**Delegate; Mike,** Purpose of why we are here "communication". How will this affect the groups? 12 step work, our primary purpose. Vote for those who seem to have the most potential. We all learn as we go. *Trustee at Large:* Election in April 2017 Suggested 10 years of sobriety, Serves the conference, 3 quality meetings, world service meeting every two years and international travel. *Finance:* Contributions are better than budgeted, at about \$3.4 million for the first six months of 2016, which is about \$250,000 better than budgeted and about \$233,000 better than the same period last year. The Big Book is currently available in 70 languages, including the original English, and there are 15 translations pending, including Navajo, Haitian Creole, Lao, and Thai. General Service Office will be making a price reduction on the 75<sup>th</sup> Anniversary Commemorative edition Big Book in order to move the current inventory. Net literature sales for the first six months of 2016 were about \$6.8 million, which is about \$345,000 better than budgeted and about \$341,000 better than the same period last year. Overall revenues (literature profit plus contributions) for the first six months of 2016 were almost \$8 million. That's about \$594,000 (8 %) better than budget and about \$544,000 (7.3%) better than the same period last year. Net profits are up about \$360K for first six months. This does not include the 714 campaign *Grapevine:* Subscriptions are up! Total Grapevine circulation for the first six months of 2016 averaged about 78,000, which is about 2500 over budget and about 300 over the same period last year. The total includes print subscriptions, Grapevine online, and the Grapevine subscription app, and it's the online and app sales that have put us ahead over last year. Total La Viña circulation for the period averaged about 10,400, which is about 250 better than budgeted and about 100 better than the same period last year.

NAGSC CPC; Cheryl, Here are the activities that CPC (NAGSC CPC and NNIG PI/CPC) have been involved with since Area 42 Assembly report in April 2016.

**University of Nevada Medical School, Reno:** Joyce Y. (NNIG PI chair) and Cheryl, along with other CPC committee members meet with Dr. D. and 4-5 third year medical students. We provide the students with some appropriate pamphlets and central office meeting schedules and a short presentation on CPC. The students get an assignment from Dr. D. to attend a 12 step meeting and then they report back on their experience in about 6 weeks. We also attend the report backs. We meet with a new rotation of students every 6 weeks. This continues throughout the year. Since the last assembly report, we met on April 11<sup>th</sup>, April 25<sup>th</sup>, May 24<sup>th</sup>, June 6<sup>th</sup>, July 8th, July 29<sup>th</sup>, August 17<sup>th</sup>, and Sept. 9<sup>th</sup>.

Washoe County School District (WCSD), Reno: We are working with some counselors at the Washoe County School District to create a presentation on alcoholism and AA geared for high school students during a health class. Joyce, Tom, and Cheryl met on April 24<sup>th</sup>, May 30<sup>th</sup>, June 10<sup>th</sup>, June 27<sup>th</sup> (mock presentation), July 1<sup>st</sup>, July 25<sup>th</sup>, and August 28<sup>th</sup> (mock presentation). We plan to meet again and modify per last mock feedback, and then meet with counselors at the school to do a mock presentation with them.

**Victim Impact Program:** In Douglas County, folks that get a DUI must attend a Victim Impact Panel as part of their requirements. There are four folks on the panel, one of them in recovery from our committee. Joyce, Cheryl, Sue, and Joanne met with Linda, the Victim Impact Panel Coordinator on May 17<sup>th</sup>. Victim Impact Panels were held on April 21<sup>st</sup> (Minden), June 14<sup>th</sup> (Stateline), and August 18<sup>th</sup> (Minden).

Orientation to AA Presentation: Joyce and several other members have been working on a presentation called Orientation to AA for the past couple years. The purpose of this presentation is to help folks new to AA and court ordered folks to understand AA meetings and the language of AA and how and why we do what we do. There will be 6 standalone presentations. These are NOT AA meetings. These presentations are a service to help folks learn about AA. There will be facilitators of these presentations. They will need to be "trained" to facilitate to provide consistency. The project committee meets weekly on Wednesdays from 2:30 to 4:30 at the Biggest Little Fellowship. Mock presentations were done at the Spring Festival in April and at SWACYPAA in June. Joyce, Merl, and Sue will be meeting with Bristlecone Treatment Center on Sept. 7<sup>th</sup>. At this meeting, it will be determined what day and time presentations will begin in October.

Volunteers Of America Restart Mental Health Division: Joyce and Cheryl met with Sheree' and Jacquelyn, Case Managers at Restart on July 26<sup>th</sup>. We went to gather information about what their needs were so we could determine if AA would and could fill their needs and if so, what committee would do this. Restart is an 8am to 5pm facility for clients that are chronically homeless and have mental health issues and need assistance. The facility is locked to the public. One must be a client to get in. They would like to have AA info for their rack in the sitting area and for case managers to give out. The pamphlets they would like are: AA schedules; Info on AA; Is AA For Me?; A Newcomer Asks...; AA and Medications; Serving Alcoholics with Special Needs; Problems Other Than Alcohol, Sponsorship; and old AA Grapevines. We agreed to provide 12 of each of these to start. Joyce picked up the literature Aug. 2<sup>nd</sup> and delivered it to Restart. Joyce and Cheryl attended the NNIG H&I committee on Aug. 25th to see if this service falls under their responsibility rather than PI/CPC. The NNIG H&I committee will be talking with the NNIG steering committee regarding this and will get back with us. In the meantime, NNIG PI/CPC committee will continue to provide them with literature as needed.

**District Meetings:** Attended the District 12 (Fallon) business meeting on August 13<sup>th</sup>, and gave an overview of CPC committee work. Great reception. Thank you, District 12!

**CPC Committee Meetings:** We held committee meetings on April 24<sup>th</sup>, June 12<sup>th</sup>, July 10<sup>th</sup>, and Aug. 28<sup>th</sup>.

NNIG CPC: Cheryl stood for the chair position of NNIG CPC at the June election business meeting. Cheryl was elected by acclamation. Cheryl wanted to stay with CPC to see some of the current projects in development through to implementation and into maintenance. This will also add continuity as new NAGSC CPC and PI chairs are appointed in Dec. Cheryl also wanted to understand NNIG better and to continue the teamwork between NAGSC and NNIG. Joyce and Cheryl met with the NNIG Steering Committee on August 30<sup>th</sup>. They explained the CPC/PI committee teamwork and submitted a budget for the next 12 months. NAGSC P.I.; Lyle, Thank you for the opportunity to serve as your Public Information chair for the North. It has been my pleasure to be allowed to participate and be a part of the area. In the north the PI committee informed the districts within California that often the first webpage which pops up is a private web site and is run by a man from Staten Island who has decided to manage a listing of meetings for many states due to personal reasons. Local PI chairs for districts and groups should be made aware of updated him with meetings changes. Making sure that correct meeting information is available on the web is a full time job. After the last assembly there were multiple meetings in both the north and south to address what has been perceived as an exclusion of the standing committee chairs from the area committee. Our feelings ranged from confusion, frustration, anger to hurt. I am grateful to have been involved, and for the unity that the process brought. NAGSC Accessibilities; Roberta, This is the last Assembly of the rotation and I want to summarize what has happened during my time as chairman of this committee. In the first year it took a few months to get up to speed as this committee covers many areas from service animals to wheelchair bound individuals. Since there was no outgoing chair of the committee, I had to reinvent the wheel. Seven people agreed to be on the committee, but only one replied when I sent info or inquiry. I started by sending a survey questionnaire to every DCM in the Northern Area to see what their needs were. There are over 450 groups and I received 7 replies. In speaking with the Accessibilities desk at GSO, this is about average for surveys. GSO has sent surveys to the entire US community and received less than 15 replies. I decided the focus of my term would be service animals and access to meeting rooms. Two things I am particularly interested in and two things I know to be issues in the Northern Area. I learned that in addition to trained dogs, trained miniature horses can be service animals, but no other animal trained or untrained. So you can lawfully ask that the monkey or goat be removed from your meeting. I also learned that those who do not have accessibility issues have no idea about those of us who do. I have been told on numerous occasions buildings that no longer meeting ADA requirements for access were "grandfathered in", so it's ok to have meetings there, even when it is not accessible to everyone in AA. I ask you to think about how welcome to AA you would feel if you were unable to attend a meeting because the building in which it was held in was not inaccessible to you because of your physical condition. I have visited all but three of the districts in the Northern Area. I hope to visit the remaining districts before the end of December. Of the remaining 3 districts, one has been scheduled for October. I also made a presentation to one home group that requested it. I had a request from Cornerstone in Reno for information on wheelchair access and I am pleased to report they got to work and made the bathroom wheelchair accessible. At the request of the SWACYPAA convention committee, I researched interpreters for hearing impaired and the cost of same and made a report to them at a committee meeting in December. I also gave them information regarding room arrangements for wheelchair access. It has been a rewarding two years. I have met lots of fellow AA members and been welcomed at every business meeting. I will make myself available to share any information I have with the next Chairman of the Accessibilities Committee. Thank you for this opportunity to serve. Ad-Hoc Communications Committee Report: Justin Opens: At the Spring Assembly an issue came up in the Area Committee meeting concerning anonymity breaks in the minutes posted to our Area website. That body elected to form an Ad Hoc committee to look into this issue. Phil appointed me to chair this group which was made up of Paul, Area secretary; Libby, Webmaster; Jonelle, SAGSC Chair; Ann, Newsletter Editor; Glenn, SAGSC Secretary and Laura, NAGSC Secretary. I looked up the definition of "Ad hoc" which in Latin means "For this, a very specific purpose". In the case of our anonymity breaks this mainly refers to last names, personal phone numbers and addresses on our Area 42 website. This does not comply with our Area's website guidelines, GSO's website guidelines and more importantly it does not adhere to AA's tradition of Anonymity which is "Our spiritual foundation". Mainly, the anonymity breaks were in our Area, Sagsc, and Nagsc minutes. However we looked at everything on the website. The first thing we did was to move all of the minutes off the open page and put them in the password protected page. We then used a system of "2 sets of eyes" to read each document on the entire website, identifying and correcting the Anonymity breaks then returned the documents to the open page of the website. We used GSO website guidelines and Area guidelines as a resource, we contacted other areas to ask them about their procedures. We used a free online translation method and translated to Spanish every document we could, however there is a lot of work that needs to be done on that topic, not covered in our committee to great extent. Our committee met 6 times by conference call, and used some email correspondence. After lengthy and productive discussion we came to an informed group conscientious and developed 6 recommendations for the Area which you will hear in just a bit. Now, If they would like to each member of the committee can come forward to share their personal experience of serving with this committee. Paul: As part of the Ad-Hoc communications committee, we were tasked with anonymity breaks on the Area 42 web site. Justin chaired this committee and we divided up the three different sets of minutes (Area, NAGSC, & SAGSC) and the Area newsletter with two members looking at each. My set was the NAGSC minutes and these go from 2008 to 2015 with four sets each year. That is 32 sets of minutes and out of the 32 there were 24 that had at least one anonymity break. This was very surprising to me as I thought when we started this that there may be one or two here and there. The breaks included last names, personal phone numbers, and personal email addresses. This was not an easy task as I was the first set of eyes to look at the NAGSC minutes and I thought I was being very through but I missed breaks in about half of what I had checked and found some but didn't find them all. Thanks to Libby she was my second set of eyes, this is why moving forward we need at least two sets of eyes to look at everything. Thank you for allowing me to serve. Jonelle: Hello all my name is Jonelle and I am an alcoholic. I currently serve as your SAGSC Chair. My experience on this committee has been personal. Last year, after doing a Google search on myself for my professional career, I found a set of SAGSC minutes posted with a DCM report I had written in 2013 as the first entry under the search. That's not good, I thought. I had used my full name. I did not fear an anonymity break when I wrote that report... However, that's what happened. Thank God for God, amazing sponsorship, and members of our fellowship who are proactive! Laura and I scrubbed the Area Minutes. I did the first reading documenting a list of my changes, she did the second reading, adding to that list and translating the minutes to Spanish. Once the minutes were complete, I was asked to reach out to my PRAASA Area Chair Roundtable's email list to see what they do re: Area Communication. The response was so helpful. Most had a Communications Committee... Some have a Translation and Interpretation Committee as well... They shared info surrounding their Area Websites, offering any assistance needed. We refined our recommendations and discussed how to best present this information to the Area. I believe we all dug deep on this, which is to say none of us took this appointment lightly. Everyone was passionate and considerate. Everyone brought questions and experience, concerns and solutions. I didn't realize how little I knew or understood... (especially surrounding the website guidelines!) I thank this amazing group for all its hard work and allowing me to use my voice and participate. Laura: This was a fantastic and dedicated group of people to work with. Though we only met by phone conference 6 times for about an hour each time, the real work was done on each person's personal time. We each spent countless hours reading over 15 years of posted material. For my part, I worked with Jonelle as the 2<sup>nd</sup> set of eyes to scrub the Area minutes of anonymity breaks. Sounds boring, right? Well, to my surprise I found the opposite to be true. In fact, it took me much longer than it should have because I would start reading the Area minutes, focused only on looking for names, email address, and phone numbers, but soon found myself engrossed in what was being discussed at that particular Assembly. Then I would realize I hadn't even been looking for any anonymity breaks at all and I would have to start over. I'm sharing this with you to remind you that the posted minutes on our website are an important resource of information that is often overlooked. It is a fascinating look at the history of our Area. Not just of the motions made and voted on but of all the people who have come through this room and through our General Service structure. It came to mind to me of how important the people really are. The issues come and go, in fact, they seem to cycle through, so that mostly the things we "lovingly discuss" today are the same things that were "lovingly discussed" 15 years ago. But there is a long list of dedicated members who have come to this building over the years who are lovingly remembered and noted in the minutes. They, like you here today are the backbone of General Service. Some of those people are still here today, some

are names of people that I never knew but have often heard spoken of, and some have passed. But their legacy and the legacy of Area 42 is preserved in those posted minutes! So please, become familiar with your Area's website, use this as a recovery tool, share this resource with your groups and help the newcomer to become familiar with the site. Read the website guidelines and help the Area to keep our tradition of anonymity. As Justin said, "It's up to all of us!" Glenn: My name is Glenn and I currently serve as our alt. Area Secretary and the recording secretary for the SAGSC body. At this year's Spring Assembly, I asked our Area Committee in the blue room to discuss a resolution regarding the anonymity breaks on our website and for clarity on the proper protocol for posting items on the site. Through that discussion this Ad-hoc committee was formed. My primary job on this committee was to be the first set of eye's to review and revise if necessary the current postings of the SAGSC minutes and scrub out any personal information that may be attached to any member or trusted servant of Alcoholics Anonymous. The SAGSC files were then sent to Justin as the second set of eyes who corrected anything I had missed. I was then asked to translate the files into Spanish for our Spanish speaking members before resubmitting them to Libby for reposting. Secondly, we all discussed why and how this happened and looked at ways to prevent it from happening in the future. I want to thank the Area Committee for listening to my presentation last spring and suggesting an ad-hoc committee be formed as the resolution to fixing the anonymity breaks on the website, our Area Chair for appointing such bright, and dedicated people to this committee and our Area 42 fellowship for your patience and understanding while this work was going on. Thank you for letting me be of service. Anne: Thank you for allowing me to serve on this ad hoc committee. I am honored to have served with such a patient and tolerant group of people. This was a maiden voyage for me and I learned a great deal through the experience. As most of the other members of my committee have reported, we spent a lot of time looking at each and every document on the Area 42 website - including the posted newsletters. (Thank you, Irene P. for your help with the task of looking over and re-working these files. You were a great help as always.) While the newsletters as a whole didn't contain a slew of anonymity breaks, like the rest of the documents, they did contain a few telephone numbers, first and last names and personal email addresses that make a person identifiable by the nature of the name in the email address. In fact, this process was a great catalyst for me - a person who those who takes great pride in adhering to anonymity - to change the email address I use for A.A. purposes to something that did not include my last name. As someone who believes wholeheartedly in the spirit of anonymity and how it keeps us and A.A. safe and protected, I realized that my last name in my email was entirely inconsistent. My intentions and actions did not match up. I had known that my email address broke my anonymity since shortly after I joined the fellowship in November of 2011. Laziness and fear kept me from taking action. Yes, as you can imagine, it's been difficult and takes quite a bit more effort on my part to navigate through all my personal email on two different accounts. However, like most things. It is absolutely necessary for me because I believe that anonymity is the spiritual foundation of our whole society. You have taught me that my actions and my belief system must be in sync - even if it's a huge inconvenience. When we finished the tasks of scrubbing the site so that all the anonymity breaks were gone, we began to talk about what we can do as a committee to insure that the Area does not repeat the same mistakes twice. You all have taught me that a real mistake is not learning from the first mistake. With that, I feel confident and hopeful that the committee's recommendations - if adopted - will help protect us all as we continue our digital journeys through this life as A.A.s and citizens of humanity. Libby: It has been an honor to work with these devoted servants of Alcoholics Anonymous in Area 42. It was obvious from the beginning of this ad hoc committee that everyone was on board to do whatever needed to be done to protect people's anonymity and thereby the principles of AA. The very first action I had was to move all the minutes and newsletters from the public areas of the website to the password protected area. Then the work of the committee began. At each meeting everyone was able to present their understanding of the project and we were able to iron out what we wanted to achieve. Once there was agreement, the group dug in and started to go through all the archives on the website. Everyone was good about keeping everyone one else informed of progress. I worked with Paul and reviewed the Minutes from the NAGSC meetings. It was an interesting read. As each pair of reviewers completed their mission I was given the revised files and uploaded the new ones on the website in the public folders. Everything has now been replaced. The final activity was to come up with suggestions for the Area to help mitigate this type of situation in the future. Thanks to everyone for letting me be of service.

# **Laura Reads Recommendations:**

- 1. Any item to be posted to the area website be reviewed by 2 "sets of eyes" to insure the document adheres to Area 42 website guidelines. ie Area secretary might have alternate secretary check area minutes, Nagsc & Sagsc minutes could be scrubbed by area or alternate area secretary.
- 2, Members should refer to and be familiar with the Area 42 website guidelines and aa.org guidelines for any document being posted to the website, that full last names be removed (last initial is okay), that personal email addresses be removed (AA addresses are okay, such as delegate@nevadaarea42.org), that non AA affiliated website links such as youtube.com should not appear in posted material, personal phone numbers be removed (AA numbers such as those for Central Offices are okay), that personal physical addresses be removed (AA addresses such as Central Offices are okay). This would only apply to the material as it will appear on the website not to oral reports.
- 3. We recommend that the online registration link to Eventbrite be removed from the website to comply with the Area 42 Website Guidelines but that the link can be communicated to the body through our various email lists.
- 4. We recommend that all material on the website be translated into Spanish and that the area look into improving and funding our current method of translation. We further recommend that all material sent out to the Area body or presented at Area Assembly be translated into Spanish.
- 5. Members should refer to and be familiar with AA's traditions concerning anonymity at the public level, stressing the importance of protecting all member's anonymity, including deceased members, that it is better to leave out all last names rather than risk breaking one member's anonymity, that adherence and education on this tradition at the area level will reduce the likelihood of further anonymity breaks and assist newcomers unfamiliar with AA's tradition of anonymity at the public level.
- 6. Ad hoc committee recommends that a permanent Area Communications Committee be established.
- a. Committee to be made up of the following members: Area Alternate Chairperson, Area Secretary, current Web Servant, immediate past Web Servant, three members at large, at least one to be from a linguistics district.
- b. The scope of the duties of the committee not be restricted to website anonymity but may include any issues concerning communication such as translation, ASL. PI issues, bulk email concerns or any issue of communication brought forward by an area member.
- 7. We recommend that the Area keep an Ad Hoc Communications committee in place until a permanent committee is established.

<u>Justin:</u> This committee met to fix the current anonymity breaks and to help this not happen in the future. It's up to the incoming panels of officers and members to make sure our anonymity is protected. It's up to ALL of us! We will now open the floor for questions and comments. Thank You

NAGSC DCM Coordinator; Chris, First of all I would like to start by saying thank you to all of the DCM's and Committee Chairs for making this a rewarding experience. This was only the second rotation of this position so I guess I could say that we were still trying to figure it out. A.A. History reports: The Temperance Society was formed in Massachusetts in 1813 – another formed in Connecticut a few years later and in 1826 the American Temperance Union was established. By the end of 1828 there were approximately 225 temperance societies, with more than 100,000 members who had signed a pledge of abstinence. The movement urged temperance (abstinence) for everyone, not just those who were already problem drinkers, and at first opposed only the use of distilled spirits, not fermented spirits. Many of the poor objected because they could only afford cider and beer, not wine. In response, a new pledge was initiated, prohibiting the use of all spirits. This was called the Teetotal Pledge. The temperance movement also aimed to wipe out the sale of alcohol. Not only did its members agree to abstain, but they campaigned to close down distilleries and merchants who dealt in liquor and they lobbied for temperance legislation. Since alcohol was the "cause" of alcoholism, the temperance movement was aimed solely at keeping the non alcoholic from becoming alcoholic; in effect, preventing alcoholism, not dealing with it once it had occurred. This clergy led temperance movement believed that there was no hope for the alcoholic. The temperance movement took a pivotal turn on April 5, 1840. Six men sat in a barroom of a tavern in Baltimore. There names were William M, David H, Charles A, George S, Bill McC, and Tom C. They usually met there to mingle and drink. They all confessedly stuffered severely from the frequent and intemperate use of intoxicating drinks – they suffered in health, estates, families, their habits, their feelings and their reputation. They were in business and 5 of them had families. They all started life with dreams and ambitions. Then they found themselves in the grips of alcoholism and they knew it was wrong. So, on April 5, 1840 they deliberately weighed the movement about to be made, and them rising in the energy of there still surviving manhood, they resolved that they would never drink any more of the poisonous drink forever; and to carry out their resolutions, they would form a society with a pledge to that effect, and bind themselves under it to each other for life. They named the group the Washingtonian Temperance Society of Baltimore, in honor of the nations first President. The idea was that by relying on each other, sharing their alcoholic experiences and creating an atmosphere of conviviality, they could keep each other sober. Total abstinence was their goal. They all signed Total Abstinence Pledges. They were given a pledge card which read. "The undersigned do pledge my work and honor to abstain from ALL intoxicating liquors as a beverage and that I will by all honorable means encourage others to abstain." Here for the first time were drunkards bonding together to solve their own problem, rather than to attack the ills of society as a whole. The movement caught on quickly - especially after the "President" suggested that each member should rise in his place and give his experience; and by the way of commencement, he arose and told what he had passed through in the last15 years and the advantages he had derived from signing the Total Abstinence Pledge. The similarities with the best practices and principles of A.A. are striking: Above all, alcoholics helping each other in practical ways and through the sharing of "experience, strength, and hope". The Washingtonians developed this tripartite temperance story – which in A.A. is called "qualification": how one's life had been destroyed by drinking, what happened, and what one's life is like in sobriety. The movement spread to other cities and began to hold large public meetings. Several powerful speakers rose to prominence in its ranks and within 2-3 years the Washingtonians could be found in every part of the country and claimed thousands of members (close to 400,000-600,000 at the peak of popularity). In February of 1842, Abraham L gave a speech at one of the Washingtonian's great revivals. He said, "But when one who has long been known as the victim of intemperance bursts the fetters that have bound him and appears before his neighbors clothed in his right mind, a redeemed specimen of long lost humanity, and stand up with tears of joy trembling in his eyes to tell the miseries once endured, now to be endured no more... In my judgment it is to the battles of this new class of champions our late success is greatly, perhaps chiefly, owing." Abraham criticizes the traditional temperance advocates for speaking to drunks in the thundering tones of anathema (hatred) and denunciation (public condemnation), and says it is not wonderful that they were slow, very slow, to acknowledge the truth of such denunciation... To have expected them to do otherwise... was to expect a reversal of human nature... On this point the Washingtonians greatly excel the temperance advocates of former times. Those whom they desire to convince and persuade are their old friends and companions. They know they are not

demons, nor even the worst of men: they know that generally they are kind, generous, and charitable, even beyond the example of the more respectable and sober neighbors... and when such is the temper of the advocate... no good cause can be unsuccessful. In 1843, Abraham stated, "I believe, if we take drunkards as a class, their heads, and their hearts will bear an advantageous (powerful or beneficial) comparison with those of any other class." But its success, though spectacular, lasted only a short time. As early as 1843, interest was beginning to fade, and by 1848 the Washingtonians had virtually disappeared, except for some lingering activity in Boston. But the impact of this movement went far beyond its success rate, for it introduced two elements that changed alcoholism treatment significantly; the concept that the alcoholic was not simply a moral degenerate but a human being who could and should be helped... and the role play by "reformed" drunkards themselves in their own rehabilitation. At several points in his writings, Bill W reflected on the Washingtonians as an object lesson for Alcoholics Anonymous. The two were similar in many respects: alcoholics helped each other, held weekly meetings, and shared personal experiences. Each featured the fellowship of a group and the availability of its members, and of course, total abstinence. Numerous factors have been suggested as leading to the demise of the Washingtonians. Two main causes were... the failure to restrict membership to alcoholics and the failure to maintain a single purpose – rescuing drunkards. Membership – Unlike A.A., whose membership is open only to alcoholics, the Washingtonian societies were open to everyone. As the Washingtonian cause became explosively popular, it seemed that everyone wanted to get into the act. At one of the meetings in March of 1842 there were many in attendance. Not only were there alcoholic speakers, but there was musical entertainment, a choir composed mainly of ladies, and a glee club composed of "fine looking young firemen". The vast presence of nonalcoholics tended to dilute the movement and to draw it away from its original goal; in addition it allowedthe clergy and others to co-opt and subert the movement for their own purposes. Single Purpose - Ths survival of A.A. owes much to having a single purpose - to carry the message of sobriety to the alcoholic who still suffers. The Washingtonians also started out with a clear mandate - To "snatch the poor inebriate from his destructive habits", but their original purpose got lost as non-alcoholic members promoted their own causes: for example, prohibition, sectarian religion, politics and abolition of slavery. These extraneous causes introduced dissension (disagreement or dispute) and destroyed the unity that was necessary for the movements survival. Conclusions: Religiosity is detrimental to the task of sobering up alcoholics. The Washingtonians took off like a rocket when they approached drunkards with human kindness and understanding - without the condemnation and moralistic preaching of the old, clergy - led temperance movement. Some Washingtonians were hostile to the clergy, and with good reason. In narrative of Charles T. W, a reformed inebriate in 1843, Charles bitterly recalls that "in my hour of degradation, no friendly hand in the old temperance times ever gave me encouragement to rise and live; but many were not only indifferent to my situation, but actually, in more ways than one, were my oppressors." When Charles took the Pledge of Abstinence, and began a new life in sobriety, one clergyman, who ought to have offered him support and hope, instead went around the community, telling people that Charles would soon be back drinking, Charles confronted him: "I told him plainly that it was such religious bigots as he that had kept the drunkard confined to his cups for yeas, and that I considered him more in the way of the cause than ten open opposers; and in fact such men are complete icebergs around any reform, chilling the atmosphere wherever they approach." Some of the clergy were hostile to the Washingtonians, who seemed to be trespassing on their turf. Good causes were supposed to be led by themselves, the men of the cloth, not by mere laymen. The Washingtonian approach totally ignored sin; it embraced the heretical notion that drunkards could be reformed without religious conversion; it undercut the prohibitionist narrative, that alcohol leads inevitable to death; and it bypassed the sacred cause of Prohibition. The hostility of some clergy is undoubtedly among the multiple causes that led to the demise of Washingtonianism as a movement. By the end of the 1840's, Washingtonianism had died out as a movement, although some groups lasted for many more decades. However, it was hardly a failure. One may hope and assume that most of the many tens of thousands of reformed drunkards, with the support of friends and family, maintained their sobriety. One may reasonably imagine that on the local level, reformed drunkards continued to carry the message of sobriety to other drunkards. And the Washingtonian ideas lived on, even if underground. As the Washingtonian movement was starting to disappear, a loose network of facilities both public and private offered treatment to drunkards. Referred to as inebriate asylums and reformatory homes, they included the N.Y. State Asylum, The Inebriate Home of Long Island N.Y., the Home for Incurables in San Francisco, the Franklin Reformatory Home in Philadelphia and the Washingtonian Homes which opened in Boston and Chicago in 1857. And now Lisa is going to continue the timeline and talk about some "cures" for alcoholism and The Oxford Group. Thank you for letting me be of service.

Lisa, Warning!! The prehistory of AA included lots of religious verbiage so please don't be scared off by any talk of Christ or Sin if that is not your thing. I promise there is a happy ending, and that is that we have AA free and clear of any affiliation. What was it like for alcoholics in the time between the Washingtonians and the Oxford Group? 1) Mandatory sterilization - During the late 1800s science believed that the hereditary transmission of the disease could be eradicated by sterilizing those suffering from what we now call alcoholism. Literature was common to say the something like the following: "Often the higher moral faculties of the person are underdeveloped, and children of alcoholized people are born criminals without consciousness of right and wrong, and with a feeble sense of duty and obligation" T.D.C., 1902. 2) The idea was that natural selection would weed out the drunkards, but the process could be speeded up through marriage bans, sexual segregation, and mandatory, state funded sterilization of degenerates. 3) Involuntary sterilization laws came in two waves: 1907-1913 and 1923 - 1929. Fifteen states passed sterilization laws before 1922, and 2/3 of all states went on to pass some type of involuntary sterilization law. as a result more then 60,000 Americans were subjected to involuntary sterilization. In 1905 Indiana passed a law prohibiting marriages of any people who were mentally deficient or habitual drunkards. 1911 Iowa passed a law that made inmates of public institutions who were involved in crime or drug addiction eligible for sterilization. In many other institutions sterilization was considered voluntary but the only way to be released from a psychiatric hospital was to volunteer for sterilization. 4) The Nazi's have been quoted as saying "alcoholism harms too many but kills too few" They also employed forced sterilization to nearly 30,000 people.

What was it like for alcoholics in the years between the Washingtonians and the Oxford Group? Other therapies were not as invasive. Natural therapies include: 1) Specialized diet: patients were told that red meat and spicy food would excite their cravings for alcohol. vegetarian diets were suggested, along with a milk diet and fasting regimen. 2) Exercise: One text notes 22 exercises the patients found useful in speeding up their recovery. 3) Water treatments of all kind: electric light baths, hot enemas, electric stimulation, massage, and more! 4) Curative gymnastics. 5) air and sun baths. 6) Drug therapies included replacing alcohol with cocaine or morphine.

Oxford Group Practices: 1) Oxford Groups attempted to recreate First Century Christianity and discipleship. 2) They developed a way of life based on changing one's life and helping others have deep and effective spiritual experiences that would in turn change their lives. Frank called it 'soul surgery'.

3) Each member bore witness throughout their daily affairs to the transformation Christ made in their lives. It is an approach not on eventual rewards in heaven but in finding a more fulfilling and exciting life in service to God here and now. 4) Oxford Group was the basis for all Twelve-Step Groups, and much of the early AA literature is based directly on the Oxford teachings. All of the AA authors were or had been members of the Oxford Group.

Frank B: 1) Born in a small town in Pennsylvania, population of 1200, where the only permissible vice was overeating. 2) went to seminary school and was called to a new parish, where he built up the vigor and the life of the church, and established a hospice for young men. Frank had disagreements about the budget and funding was shut which led Frank to resign from his position. 3) Frank spent several months in Europe, still stewing over the disagreement. In 1908 he attended an annual gathering of evangelical Christians, and it was here where he was deeply moved by the preaching of Jessie P-L. 4) "I thought of those six men back in Philadelphia who I felt had wronged me. They probably had, but I got so mixed in the wrong that I was the seventh wrong man...I can only tell you I sat there and realized how my sin, my pride, my selfishness and my ill will had eclipsed me from God to Christ. I was the center my own life. That big "I" had to be crossed out. I saw my resentments against those men standing out like tombstones in my

heart. I asked God to change me, and He told me to put things right with them. It produced in me a vibrant feeling, as though a strong current of life had suddenly been poured into me, and afterwards a dazed sense of spiritual shaking up." 5) He wrote letters to these former "bosses" where he took ownership of his own prideful behavior in holding onto the resentments.

YMCA: 1) When Frank B returned to the US he was hired as the secretary of the Penn State College YMCA. He had grave reservations about the drunkenness at what he called "the most godless University in the country." 2) It was here where he discovered the power in working one-on-one. He converted a crowd of notables which impacted the other people watching. 3) in April 1915, Frank left for India and then China. His hope was to convert a few key players to help convert these huge nations to Christianity. These ideas were seen as naive by his critics. Asian trips were ultimately failed efforts, but "he remarked one day that it had only been in China that (he had learned) the confession of one's own shortcomings, privately or publicly, was an important way to help others." Lean, PG 63 Sam S meanwhile would work with Frank for 20 years, as the American head of the Oxford Group movement. When Bill W got out of Towns hospital after his last drink, "still shaky, he visited Dr. S at Calvary Mission and made a decision to become very active in the Missions work and to try to bring other alcoholics from Towns to the Oxford Group". (The Evolution of Alcoholics Anonymous, Jim B) 4) Bill would later acknowledge that, "The early AA got its ideas of self examination, acknowledgment of character defects, restitution for harm done, and working with others directly from Oxford Group and Sam, their former leader, and nowhere else." (AA Comes of Age p 39)

Oxford Group and Frank's departure from the Christian Church: 1) 1921, history of friction between Frank and the Church culminated in his decision to quit the church proper and create his own organization, which he vowed would be a protest against the organized, committeeised, and lifeless christian work of doctrinal and institution-based religion". (Language of the Heart: A Cultural History of the Recovery movement from Alcoholics to Oprah W, Trysh T, 2009, p. 71) These efforts were financed by wealthy sponsors. 2) His primary focus was on 'soul sickness'. he saw the glorification of the physical and material as what he called materialism, which encompassed sexual acting out, profligacy (lacking legal and moral restraint / wildly extravagant), vanity, envy, gluttony, and excessive drinking. This theme of antimaterialism agrees with Bill W's later ideas of "self propulsion in the quest to become a self made 'Number One Man'." 3) The vision and principles were passed person to person throughout Britain and later in the US. Members would gather together for informal house parties in addition to their duties at there own congregations. At the house parties, they studied the bible with an eye for modern application. sought God's direct guidance for individual and world concerns, and shared openly their sins with one another for confession and witness. 4) A regular meeting that had been held at Corpus Christi College grew so popular that by 1928 the group moved to the ballroom of the Randolf Hotel, and then to the library of the Oxford University Church, St. Mary's. The movement got its name this same year when six Oxford students on a mission to South Africa were branded the Oxford Group by the press.

They reached America in 1931. A few years later, Oxford Groupers assisted Russell "Bud" F in conquering a severe drinking problem by turning to God. Bud's father, Harvey, had four things the Oxford Group liked, wealth, fame, generosity, and gratitude. The magnate in his appreciation hosted a ten day gala, in January, 1933, that brought the religious group to the forefront of Akron society. This set the table for Oxford Group members to arrange the famous Mother's Day meeting, two and a half years later, of Bill W and Dr. Bob S. (It was not until Dr. Bob had met with Bill W and was relating, one drunk to another, that he eventually surrendered. Dr. Bob met Bill on mothers day of 1935, and later drank while at a medical convention in Atlantic City in June of 1935. Bill Gave Bob his last drink of beer just prior to performing surgery on June 10th, 1935. This was to be Dr. Bob's last slip.) It is worth noting that at about this time, Frank had an even more notable candidate in mind for religious conversion, Adolph H. At least two approaches were made, in 1932 and 1933, to get a Frank audience with the German leader. The extraordinarily optimistic thinking was that if the Fuhrer could be led to a "decision for Christ", millions would follow, and the world would be changed. Some Frank critics, former colleagues among them have leveled the charge of megalomania. Not without grounds. Reinhold N – author of the Serenity Prayer – was a critic of Frank and the Oxford Group. "We can see how unbelievably naïve this movement is in its efforts to save the world. If it would content itself with preaching repentance to drunkards and adulterers one might be willing to respect it as a religious revival method which knows how to confront the sinner with God," Reinhold wrote. "But when it runs to... Adolph, or to any seat of power, always with the idea that it is on the verge of saving the world by bringing the people who control the world under God-control, it is difficult to restrain the contempt which one feels for this dangerous childishness." Even with this controversy and critisicm, Russell F's conversion still brought a lot of attention to those in Akron and this is where it came to the attention of Anne S, Dr Bob's wife. Initially in merely an attempt to appease his spouse, Dr. Bob began to attend the Christian gatherings, no doubt remembering the mandatory, unpleasant forced Church attendance of his childhood. Despite his original antipathy, Dr. Bob was somewhat drawn to the Oxford folks, "...because of their seeming poise, health, and happiness. They spoke with great freedom from embarrassment, which I could never do, and they seemed more at ease on all occasions... I was selfconscious and ill at ease most of the time, my health was at the breaking point, and I was thoroughly miserable... I gave the matter much time and study for the next two and one half years, but I still got tight every night nevertheless". (Nightmare, p. 178) "My wife became deeply interested and it was her interest that had sustained mine, though I at no time thought it might be the answer to my liquor problem." (Nightmare, p. 178) Groups principles: 1) 3 Assumptions from which everything else is based 2) 4 Absolutes and their opposite, 4 Standards are the means by which one

Groups principles: 1) 3 Assumptions from which everything else is based 2) 4 Absolutes and their opposite, 4 Standards are the means by which one could tell one's self will from God's will. 3) 4 Steps are the design for personal living that gets and keeps one free from whatever separates one from God. 4) 5 C's of Life Changing are the framework one uses to help others achieve the life change he to she has received. 5) From the Groups simple program, one receives a different conception of one's relationship with God, a standard by which to live and practical suggestions in how to do so. 6) the author of the Oxford Group states: The aims of the Oxford groups are to bring into the world the realization of the power of the Holy Spirit as a force for spiritual and material stability and betterment of the world; to awaken in us as individuals the knowledge that we are dissipating our spiritual inheritance and that Sin is the frustration of God's plan for us all. (What Is The Oxford Group) 7) The Oxford group has a very definite idea as to the nature of sin. It is anything that keeps us from God or from one another. 8) They believe that all people are caught in the internal struggle between flesh and spirit. We are constantly torn between the voices within of God and of self. The voice of Self separates us from God and keeps us in total darkness. The voice of God seeks to guide us towards the ultimate good both for ourselves and for those around us. This is the voice that leads us to life change. The ultimate goal of the Oxford Group is to learn to listen to and follow the direction of this voice. This is how we come in line with God's will for us and fulfill our purpose in God's plan. 9) Oxford group believes that to live in God's will is life's ultimate joy.

Three Assumptions: 1) God Speaks - If we listen then we can ask What is God saying to each of us Today? The Oxford Group believes that God reveals himself directly to each believer by the voice within. When debated if it is God or one's conscience, James H says, "Your conscience can tally the difference between right and wrong, but only God can show you the difference between two rights... When we listen to God and test our thoughts, we find that God directs us toward the path that is of maximum benefit to everyone." 2) God has a plan for us - Not only is God speaking, but what he has to say is relevant to each of us. Each of us can make decisions to move toward or away from God's will. 3) God will reveal Himself to us if we listen. We cannot follow God's will on our own action, we must depend on the Group to teach us how to listen and depend on God to give us the direction. We need to remove the impediments between us and God so that we can learn what His will is for us. Finding that plan is the rest of the program.

Four Absolutes: This is the heart of the Oxford program. The life change begins when one devotes oneself to striving to these ideals. "Jesus kept to these four points in their fullness...the nearer we live to the Absolute in these four points the nearer we are to Christ." WITOG. 1) Perfect Honesty - The relentless pursuit of the truth. When we are not actively seeking truth, we are in danger of letting falsehood control our thoughts. "Brutal Honesty is no more acceptable than nominal honesty (cash register honesty). This truthfulness is tempered with common sense and kindness. We aim for perfect candor with ourselves and others, but not at the expense of others" 2) Absolute Purity - Honesty in Action 3) Absolute Unselfishness - We must first learn to put God's will ahead of our self will. then we can discover that we are putting others interests ahead of our own. 4) Absolute Love - This is the essence of all the other absolutes. This is the very substance of the program. The motive power for Honesty, purity and unselfishness. We can have none of these qualities without Love. If we ever hope to live by these Absolutes we need to clear away the rubbish that keeps us from God.

Four Steps: Individual self interest is the causation of our separation from God and each other. With the Four Steps we can be freed of them. Their purpose is to produce a "life-changing alteration in perception" that will allow us to live a God directed life of purpose and meaning beyond our wildest dreams. 1) Surrender - Surrender to God's will. This is necessary to have strength to share honestly. Surrender is not a single event but an ongoing process. God waits to see if we will Surrender today with as much sincerity as we did yesterday. We must acknowledge that we have lived lives of selfsufficiency and that life has proven unsatisfying. We have bowed down to the false idols of alcohol, drugs, fame, food and fortune. We could add to that list fun, sex, work, exercise, academia, and countless other worldly distractions. "I have learned, in whatsoever state I am, therein to be content." Paul (steps one two and three) 2) Sharing - Now that we have surrendered, how do i get free of sin? In this process we see how sin manifests itself specifically in our lives. We examine our lives for those things that separate us from God. By working with someone else who has already acknowledged their faults, we learn to see our lives through a different lens. (Sound familiar:) We start to see all the ways we are driven by self-will. "To put our sins into words before Christ and another Christian, as a witness, is the only healthy way of making sure that the spiritual system is virtually cleansed." WITOG We scour our lives for the four Standards of dishonesty, impurity of thought and deed, selfishness, and fear. These are the opposites of the Four Absolutes by which we strive to get closer to God's will. Fear may look like hatred, resentment or anger. Selfishness can look like ambition, laziness, or jealousy. We share all our faults with another person. "Confessions shared become the property of God, not man." (This makes me think of overtime I have done a 5th step with a girl that I sponsor how I don't retain all of the details for some reason) This person helps us see where we missed our sins. We need someone else to help us clearly see ourselves. This is the moment where it is truly darkest before the dawn. The Oxford Group believed that when thoroughly investigated all of our faults could be attributed to one or more of the Four standards. By applying the Standards or the Absolutes we can tell if we are listening to the voice of self or the voice of God. We can see after sharing how desperately we truly need the help of God. 3) **Restitution** - The guilt and shame of the lives we have led burden us. In order for us to be free of this pain we must make efforts to right our wrongs. Through this step we begin to lay aside our selfishness and begin to be of service. It is only through restitution that we can be free of our past in order to move into the future God has prepared for us. In this process we make a list of all who we have harmed and ask God to show us how to make it right. We learn to forgive ourselves so that we can accept God's forgiveness. We learn also to forgive others (like in step 8). Step 9 4) Guidance - Final step is seeking God's will throughout our lives. Oxford members held daily Quiet Times with the Holy Spirit, both individually and communally. "These early morning Quiet Times in which God impresses on our minds His counsel become living spots in the routine of ordinary life." WITOG 60 The pamphlet "How to Listen to God" was a blueprint that members used for quiet time. The conditions to receive guidance were: to be quiet and still, to listen, to be honest about every thought that comes, to test thoughts to be sure they come from God, and to obey. Basically the process was to become quiet, pray for guidance, write whatever came to mind and test what was written with the Four Absolutes. If it conformed with the Four Absolutes it was from God. Once these steps have been done, a person became changed. It is imperative for a Changed person to help others to have the same kind of life change. Once the Change has occurred one wants to share what has so freely been given. No process is done in isolation and s witness (which is what we in AA call a sponsor) is necessary, and each of these steps brings one closer in community with God's people.

**Five C's of Life-Changing:** served as the original framework for sharing the curriculum of the Oxford Group. Later they fell in disuse in favor of the Step and Absolutes as outlined in WITOG. 1) Confidence 2) Confession 3) Conviction 4) Conversion 5) Continuance

Positives and Negatives: 1) AA broke away, New York in 1937, Cleveland in May of 1939, and Akron last and most reluctantly at the end of 1939. (this timeline is debatable and challenged by other literature) 2) Some of the most pressing reasons for the separation were that AA steadfastly and consistently: 1. Avoided absolutes, 2. avoided aggressive evangelism (preaching or pushing the Christian Bible), 3. embraced anonymity, 4. strove to avoid offending anyone who might need the program. 3) Of these and others, the most clear and convincing reason for the split was likely Bill W's vision of the future. The earliest years convinced him that for AA to have a religious attachment would be a mistake. Bill's unexpected ally in separating AA from the Christian Protestant Oxfords was Clarence S of Cleveland, who was concerned that many of Cleveland's Catholics would be prevented from seeking sobriety through a group with a Protestant affiliation. Today, it is hard to imagine the power held over cities by organized religion in the 1930's, and the impassible chasm that divided these two Christian groups. 4) it is abundantly clear that we owe a great debt to these Oxford folks. Selfexamination, acknowledgment of character defects, restitution for harms done, working with others, quiet time (meditation), and the quest for change are all practices alive and well in AA. 5) At its peak, the group had a membership of over 50,000, but Frank made a major misstep in endorsing Adolph's anti-communism, making some statements to the press that were seen as pro-Nazi. That AA distanced itself from Oxford roots may have had to do with the negative publicity that came. Hence Tradition 10. 6) In 1938, the Oxford Group was renamed "Moral Rearmament" and continues today as "Initiatives of Change", but its heyday has long past.7) In 1978, a 100th birthday memorial was organized for founder Frank B, who had died in August 7, 1961. 8) This memorial drew cooperation from a number of prominent individuals who had benefitted from Frank's work, but an invitation to Alcoholics Anonymous was politely declined. There were two problems: 1. the anonymity principle ruled out anyone speaking for AA, and 2. Bob P. (then the GM of AA World Services) put it, 'I think some of our members would say that we got out of bed with those people, why should we now get back in?"

Bryce, Alcoholism has been a problem for some people ever since man first crushed grapes. Take Noah for example. The first thing he did after the flood was plant a vineyard. It was noted that he got drunk and passed out naked. And Lot's 2 daughters took turns getting Lot drunk and while he was in his blackout, proceeded to lay with him until they both got pregnant. And we're all familiar with the story of how Jesus turned water into wine and they said "you've saved the best for last!" There has been problem drinkers ever since man first crushed grapes. In the 1600's there were lots of plagues in Europe because of bad water. So they drank a whole lot more than they do today. Back then, they drank around 34 gallons of beer, 5 gallons of hard spirits and 5 gallons of wine. Today here in the states we only drink about 2.3 gallons of spirits period. Back in the day drunkenness was to be expected but if you couldn't handle your booze, you were humiliated by various punishments. Dr. Benjamin R; considered the father of American psychiatry and a signer of the Declaration of Independence was the first doctor to realize that some of us drunks were different. Dr. R pioneered the therapeutic approach to addiction. Prior to his work, drunkenness was viewed as being sinful and a matter of choice. Dr. R believed that the alcoholic loses control over himself and identified the properties of alcohol, rather than the alcoholic's choice, as the causal agent. He developed the conception of alcoholism as a form of medical disease and proposed that alcoholics should be weaned from their addiction via less potent substances. (from Wikipedia; Benjamin R) We've talked about the Washingtonian Society; but between them and the Oxford Group there were the Emanuel and the Jacoby societies. Founded by Dr. Elwood W, Dr Samuel McC and Ernest J these two societies cooperated together in Boston helping drunks and addicts to recover. In 1907 the

Emanuel movement was founded and in 1910 the Jacoby Society came about. Dr W administered psychiatric and psychological treatment; the Jacoby's offered meetings and fellowship. The Jacoby's met in the church basement of the Emanuel Church and eventually got so big that they had to move to a new location on Newberry St. In 1913 a fellow named Dr. Courtney B joined the Emanuel team. Like Dr W he had been educated at Princeton University and had psychiatric degrees. I mention Dr. B because there is some evidence that Roland H may have spent as much as a year in the mid 20's under his care before going to Switzerland to spend a year with Dr. Carl J. He specialized in the treatment of neuroses such as PTSD, anxiety and stress. Dr. B did not see alcoholics different from all people who suffered with the various ailments. Dr. B's theory was that if you drank at all, you might have a mental problem. Dr. B's goal with a patient was "to help him to help himself so that his reconstruction would be permanent". He felt that stress over occurrences led to drinking and the drinking led to more stress. He saw alcoholism as a circle of cause and effect, a circle which he coined, "neurasthenia". His solution was to promote physical and mental relaxation. And to try to redirect a patients attention away from his stress, Dr. W, Dr. McC and Dr. B worked as a team to not only help drunks, but all people with various mental disorders. See page 47, 12&12: "We thought conditions drove us to drink...." Besides Roland H, there was a fellow named Richard P who came to the Emanuel Clinic in the early 20's and sobered up. He later went on to open his own clinic in NYC on the same street as Sam S's Episcopal Church. He wrote a book entitled "The Common Sense of Drinking" which was read by Bill W. Richard P coined the phrase "Once an alcoholic, always an alcoholic". Richard P dismissed the spiritual solution of the Oxford group and died drunk in 1934. Some of their methods used in the 19th and early 20th centuries were: shock treatments, morphine shots, arsenic and deadly nightshade (a plant used in the Belladona treatment), adrenal gland injections, "hot air boxes" that simulated equatorial conditions, and finally, lobotomies. My own sponsor has had 23 shock treatments and another old timer, Fred M; from the Tie Club had a frontal lobotomy for his alcoholism. An important off- shoot of the Emmanuel movement was a church sponsored club for alcoholics. Founded in 1910 by a non-alcoholic parishioner named Ernest J, the club held meetings in the church basement on Saturdays and its place was used for socializing most other nights. The purpose of the club was to help reinforce the newly sober persons' sobriety by providing a place to meet. Its motto was; "A club for men to help themselves by helping others". There were no dues or fees. The only requirement was to lead a decent life and help others do the same. And don't show up in church drunk. They also had a form of sponsorship which they called "special brothers". Many faiths were represented; the club was open to both alcoholic and non-alcoholic persons. By 1914 the Jacoby's had moved from the Emmanuel Church and into their own clubhouse because of increased membership. In 1940 a fellow named Paddy K started AA at the Jacoby Club, 115 Newbury st, Boston Mass. It wasn't until 1942 that the group Paddy started moved to its own place and thus separated itself from the Jacoby's. Records end for the Jacoby's in 1989. As a side note, a drunk named Richmond W came to his first AA meeting at Boston's Newbury group. In 1942. 6 years later he wrote the book "Twenty-Four Hours a Day". Early on that little black book became as popular as the Big Book. It is still very popular today. Since none of these Dr.'s and psychiatrists were alcoholic, it is easy to understand why they became frustrated with a certain type of alcoholic which today we know as the hopeless variety. Dr. S noted in his opinion that "some form of moral psychology was of urgent importance to alcoholics but its application presented difficulties beyond our conception." Later on he noted "Though the aggregate of recoveries resulting from psychiatric effort is considerable, we physicians must admit we have made little impression upon the problem as a whole. Many types do not respond to the ordinary psychological approach." So in conclusion; beginning with the thoughts of Dr. Benjamin R. it's apparent that through out the years that the disease of alcoholism has been a type of "rubics cube". Many people and movements have found bits and pieces of the problem with us and the solution. Bill got the description of the disease from Dr. S and the spiritual solution from Dr Carl J. and the Oxford Group. But it wasn't until Lois's innocent statement to Bill that the puzzle was solved. "Yes Bill, but you're staying sober"; that seemed to be our turning point when the medical, psychological and spiritual pieces came together with a plan of action that has shaped AA into what it is today. Again, thank you for this opportunity to share. Bryce B.

Rhonda, Here is a bit of a recap. In 1813 Temperance Society was created. In 1826 The American Temperance Union was started. The Washingtonians, a group of 6 men that wanted to focus on changing the alcoholic created a way for the drunkards to take part in their own recovery. The Washingtonians destroyed themselves by getting involved in religion and politics and had a non-restricted membership. By 1848 the Washingtonians were gone, they almost had it they were so close. Between 1848 and 1921 there were many attempts both colorful and devastating to stop the alcoholic from drinking. In 1931 the Oxford groups came on the scene in America. Sam S, set up house at the Calvary Chapel in New York. In 1932 Rowland H an Alcoholic visited Carl J and he was told he was hopeless and should consult a religious group role and joined the Oxford Group in New York City. In 1933 Jim N who was associated with the F's, had helped bring Akron the Oxford groups Frank B leading a team of thirty men and women descended on Akron for the first time to give testimonials at the Mayflower Hotel and in Akron churches and initiate the townspeople in the experiences of the Oxford Group. Jim N knew the F's and had been to T church group, some of the people that attended these first Oxford group's meetings were Clarice W, T Henry W, Henrietta S and Ann S. 1934 Rowland saves Ebby T from a jail sentence, Rowland introduced Ebby to the Oxford Groups and Ebby introduced Bill to the Oxford Groups. Bill first attended the Oxford Groups Drunk, he was intrigued by the program and went to see Dr. S to detox one last time. Bill shows up at Towns Hospital with a beer in his hand telling Dr. S he has found a solution!. Ebby was always a little resentful that Bill didn't consider him a cofounder of AA. For the next 6 months Bill and Louis both worked endlessly trying to practice the Oxford group program and help others. 1935 Back in New York Bill had been attending the Oxford Group meetings and trying to help the drunks that have come through the doors Bill was not having any success he would sometimes take them to Stewart's cafeteria but no one was staying sober except for Bill because Bill's reputation had been ruined on Wall Street he couldn't find much work but one friend Howard Thompson T of beer and Company was impressed by bills recovery, through his connection with Howard Bill learned about a proxy fight for control of a small Machine Tool Company in Akron Ohio according to Bill he insinuated himself into this proxy fight and actually had fantasies of becoming president of the company when his group gained control, he made a quick study of the Akron company then in April he went to Ohio to persuade disgruntled shareholders to support his group's bid for control. Bill could not have insinuated himself had he not had the support confidence and cooperation of his business associates although he did have no money he did have assets of considerable value. Bill found himself at the end of this Venture frustrated and Afraid that leads us to the Mayflower Hotel that fateful night when Bill looked at the bar and decided to go to the pay phone instead. it was Reverend T that Bill phoned and Reverend T got in touch with Henrietta S and She called Anne S and the rest is history. The Oxford groups was a non-denominational Christian Society based on Christ that was trying to change the world. AA broke away from the Oxford groups by the time the big book was written and depending on what literature you read the story varies Bill's story says that the first group started in Akron followed by New York and then a third in Cleveland. Clarence S and Oxford group member in Cleveland stated that it started in Cleveland. Cleveland was the first group to make a clean split from the Oxford groups and called the group a Alcoholics Anonymous after the title of the book so even though alcoholics were meeting separately from the Oxford groups they were still a part of the Oxford groups in "pass it on" Bill's story, Bill tells how he broke away from the Oxford Group, he also talks about the resentments and the Oxford Group now named the moral reenactment because of Adolph's public controversy we're getting tired of the drunks and discouraged by our lack of ability to stay sober. This is what Bill had to say about the Oxford Group split, "I'm always glad to say privately that some of the Oxford Group presentation and emphasis upon the Christian message saved my life, yet it is equally true that other attitudes of the Oxford Group nearly got me drunk again, and we long since discovered that if we were to approach alcoholic successfully these attitudes would have to be abandoned. recovery being a life-or-death matter for most alcoholics it became a question of adopting that which worked and rejecting that which would not" They were basically eight reasons why we separated from the Oxford Group 1) the principle of aggressive evangelism had to be dropped.2) excessive personal publicity had to be

abandoned drunks were likely to get inflated and drink again.3) the word absolute we found didn't work for us absolute honesty absolute Purity absolute unselfishness and love are our goals but certainly not rules.4) it was discovered that all forms of coercion both direct and indirect had to be dropped we found that checking in the hands of amateurs too often resulted in criticism and that resulted in resentment.5) While most of us believe profoundly in the principle of guidance it was soon apparent that to receive it accurately, considerable spiritual preparation was necessary. 6) We found that the principles of Tolerance and love had to be much more emphasized in their actual practice than they were in the Oxford groups especially tolerance. The Atheist May stand up in an AA meeting tonight in God yet reporting he has been helped in other ways experience tells us he will presently changes mind but nobody tells him he must do so. 7) To reinforce tolerance we would make no religious requirements on anyone. 8) We were not to make any religious demands upon people. Many Catholics felt they could not be interested in a day because of confession to anyone other than a priest. While bill was very grateful to the Oxford Group for all they had given us he gave all the credit to Samuel S he never Associated us with Frank B. Bill never would say that he owed all of AA's success to the Oxford Groups, he did state that he had overwhelming gratitude for the group, but giving them credit would have been like give his primary school teacher credit. So much more was involved in creating AA. Im going to wrap this all up by talking about traditions 5 and 10. After researching and reading all of the presentations, though all of the traditions can be found in all of these groups. These are the two that stood out the most to me. Tradition 5 "Each group has but one primary purpose to carry its message to the alcoholic who still suffers" The Oxford groups were trying to save the whole world, had we stayed as part of a "Sub Group" within the Now called Moral Rearmament movement we would have had to deal with more issues than just alcoholism. Today one of our greatest asset and certainly our name helps the alcoholic find a home, a place to go when all hell breaks loose and a program designed for living that really works. If you are an alcoholic you belong here, no matter what you race, creed, age or religious views. Tradition 10 "Alcoholics Anonymous has no opinion on outside issues hence the AA name ought never be drawn into public controversy. The Washingtonians really had the right idea, they were helping Alcoholics recover at an alarming rate, then enter politics and reform. The Washingtonians entered into public controversy, even the President of the United States got in on the controversy. The Oxford groups got caught up in trying to get influential men to support the cause, the controversy surrounding the Adolph Ordeal shed a dark light on the group and they never fully recovered. Today there is a lot of talk about AA being to anonymous and creating a stigma for the man who is still sick. I would hope that we have learned from these past experiences that although we are proud to be sober, we will not jump on the band wagon of public controversy. AA will hopefully remain that silent anonymous gift that so few receive, yet is available to the entire world. Thank You Rhonda W

B. The outgoing DCM and DCMC shall notify in writing the **Delegate**, **Alternate Delegate**, **Area Chairperson**, **Alternate Chairperson**, Area Secretary, and Area Registrar of the name, address, and phone number of their replacements. **and the alternates**.

C. The DCM shall notify, in writing, forward to the Delegate, Alternate Delegate, Area Chairperson, Alternate Chairperson, Area Secretary, and Area Registrar of the name, address, phone number, and group of each GSR at least once a year and as changes occur. Group Change Forms as they are turned in.

### 1. (Addendum to guidelines)

# AREA 42 FINANCE COMMITTEE – APPROVED 2012

Item 2. Is the Statement of Purpose.

2. The purpose of the FC is to define fiscal responsibility and standardize procedures in Area 42. (amended no change was made)

This third item is a change I am suggesting because I feel that the Alternate Treasurer, as an active financial participant for the area, should be partaking in the committee business activities. In my opinion, the Chair is the facilitator/moderator, and should be the non-voter in the case of an even

number.

### 3. 1.0 AREA 42 FINANCE COMMITTEE

### 1.1 Membership

The current Area Treasurer, and alternate, NAGSC and SAGSC Treasurers, and immediate past treasurer shall automatically be members of the committee. In addition, two at-large members will be elected, one residing in the North and one residing in the South. In the event there is an even number of members on the committee, the Alternate

**Treasurer** Chairperson shall be a non-voting member.

#### 4. 1.4 Replacement

If a member of the Finance Committee is unable to complete the rotation, the Treasurer and Finance Committee Will select a replacement to be confirmed, by the Finance Committee or replaced at the next regularly Area 42 Finance Guideline (Addendum) Changing Proposal scheduled Area Assembly. The replacement assumes duties immediately.

# 5. 2.1 RESPONSIBILITIES OF THE FINANCE COMMITTEE

B. Drafts **and submits proposals to** financial guidelines policy/amendments for consideration by the Area Committee and the Assembly. *Because there has not been a prudent reserve equivalent to 1/3 of previous annual expenses, this probably should be reworded. This is up to you (not the Finance Committee) to leave it as is or change it.* 

#### 6. 4.0 PRUDENT RESERVE

The Prudent Reserve is to ensure that, after all obligations are paid, enough funds are held to conduct area business. **We shall strive to attain a savings account** Experience has shown that, for any given year a reserve equal to 1/3 of the previous year's expenses, will to ensure that the Assembly will be able to meet its financial obligations. A 3/4 majority vote of area officers is necessary to draw upon our prudent reserve.

# 7. 6.0 REIMBURSEMENT OF EXPENSES

This requested addition to 6.2 is the definition of "funds permitting", directly from, and as stated in the Area 42 Guidelines before the 2014 revision. **6.2 Area Officers Funding** 

H. Some travel expenditures are authorized on a "funds permitting" basis. A "funds permitting" condition exists when \$1,000.00 or more, will remain in the operating account after the expenditure. This is in addition to the prudent reserve, savings account.
