Special Needs working with H & I Committee is still taking a meeting into the Fremont Assistant Living Facility on Tuesday mornings at 9:30am this meeting could use some support. Accessibilities is still taking a in-home meeting to a member needing a liver transplant, but his doctor has stated that since he has been sober (2yrs on the 15th of Nov.) his liver has shown improvement and he may not need the transplant after all. Special Needs is helping WACY PAA Accessibilities to find a ASL person for their upcoming W ACYP AA Conference in 2012, I plan to address the Las Vegas Intergroup tomorrow on donating funds to help WACY PAA pay for a ASL person if we can't find someone to do it for free. According to the WACY PAA Special Needs Chair they have a number of Deaf people registered for the conference.
