## **AAWS – AA World Services**

Responsible for oversight of the GSO Office, Group Services, printing and distributing of literature. Met seven times since the last (64<sup>th</sup>) Conference. GSO has 81 employees. 1,387 new groups listed were listed in 2014. Web site gets 30,000 hits per day and reach 40,000 a few times. Web site gets revamped every three years – new one launched June 3, 2015. Website a great way for members to learn about the fellowship, literature and finding a meeting near you. 54% of literature sales are on online. GSO received 2,213 visitors in 2014 and archives received 1,480 request for information.

Doug R. retired in December 2014 – he joined the General Service office since 1995. Doug visited Area 42 in spring 2014 as our speaker and guest. Phyllis is retiring in October 2015 – this was her last conference.

## **Grapevine**

Approximately 74,000 monthly print subscriptions. 5,262 online subscriptions.

La Vina has 10,379 bi-monthly subscriptions and that's an increase of 234 from 2013.

Nevada Grapevines (April 2015 – 654) (April 2014 - 673) Decrease 19

California Grapevines (April 2015 – 6,542) (April 2014 – 6,542) Decrease 71

Had 43,598 unique visitors in 2014 to the website. Visitors visit an average of 2.19 pages on [aagrapevine.org](http://aagrapevine.org) each month.

#### **75<sup>th</sup> Anniversary Big Book**

Sold 177,888 in 2014, around 3,500 in 2015. Gross profit of \$1,888,880 - \$904,032 for shipping.

Reorder error of 125K books – Total net profit at of 4/17/15 \$161,696.

#### **Finance – Increase \$3-5K:**

*Members talked about putting emphasis on group's participation in 7<sup>th</sup> tradition and services available to them. Around \$400K per year is coming from individual contributions – around 27 people have met the max \$3K per year and no one sent more than \$3K in 2014. – Failed.*

#### **Grapevine – discuss ways to increase subscriptions:**

*The committee encouraged the support and purchase of Subscription Gift Certificates by local service committees, groups and members as a way to carry the A.A. message. These subscriptions would be used to provide magazines to people in correctional facilities, treatment centers, nursing homes, and other facilities or locations. This work would be accomplished at the local area level. Not brought on the floor.*

#### **Literature – Mental Health:**

*This is the 3<sup>rd</sup> Conference that this has been discussed. Lot of discussion about who this is for and why. Talk about depression but this isn't who this is aimed for. Class A came to the microphone and mentioned this is not to teach AA's about mental illness, it's to teach those with mental illness about AA. Passed*

#### **Literature - AA for the Woman:**

*This has been talked about for a couple of Conferences. Committee suggested adding stories about women in the military and single mothers. Passed.*

#### **Agenda E: Discuss report on the conference Agenda process for the Trustees committee on the General Service conference:**

*The Committee supported the concept under consideration by the Trustees committee on the General Service Board to make Trustees Committee background available to the Delegate Chairperson of their corresponding Conference Committee and the Quarterly Board Weekend prior to the General Service Conference. The Committee noted that this would increase the effectiveness of the delegate Chairpersons participation in the Trustees Committee meeting. Didn't make the Conference Floor*

#### **Report & Charter: Consider request to add testing reactivating district or groups to the section**

#### **“Simulation interest in General Service on page S23:**

*Frequently, there is a need within as Area to attempt to reactivate District or Groups that have become inactive or are unrepresented. Areas encourage participation in General Service in many ways, especially by direct outreach to Groups by District. Area Officers to provide info about service events and opportunities to carry the message beyond the Group level. Sometimes there is District to District sponsorship in which an*

active District shares its experience and suggestions to “Jump Start” activity among Groups within the inactive neighboring Districts.

**Literature C: Consider updating the pamphlet “AA & the Gay/Lesbian Alcoholic”:**

*Fair amount of discussion about this topic, particularly about including stories from “Transgendered and non-gender conforming” members, especially regarding being a newcomer and sponsorship. Passed.*

**Grapevine B: Review Business Plan.**

The Committee discussed ways to increase organization-wide support for Grapevine and La Viña and suggested that:

1. Areas champion and embrace Grapevine/La Viña as the International Journals of A.A. through consistent narrative support in all relevant presentations, reports, announcements, newsletters and letters.
2. All A.A. entities be offered the opportunity to include a GV/LV link (with or without images) on local/Area websites.
3. All Areas participate in AAGV Inc.’s 2015 Subscription Challenge.

Did not reach the floor

**Corrections A: Discuss the corrections Correspondence Service (CCS) :**

*The Committee discussed the Corrections Correspondence Service (C.C.S.) and requested that the trustees’ Committee on Corrections consider reviewing the effectiveness of the criteria used for linking alcoholics behind the walls with outside volunteers. One specific concern is the distance requirement for correspondents participating in the Corrections Correspondence Service (C.C.S.). Did not reach the floor.*

**Literature – Item E: Consider producing a book combining Twelve Steps and Twelve Traditions for the Twelve Concepts for World Service.**

*Didn’t reach the conference floor – Committee decided to take to action. Cost to set up \$10-50K.*

*Failed.*

Minutes:

- First Delegate report I ever heard was from Joan M., leading to a long discussion of that first Delegate report from Joan.
- I arrived at the General Service Conference on Friday and immediately bought postcards to send out. I was up early on Saturday and we took an AA tour though New York, planned by our Pacific Regional Trustee. The chaperone was George D., a former Trustee from the Pacific Region and former General Manager and long-time New Yorker.
- While visiting the Grapevine and La Vina offices, we talked about learning about how to order La Vina subscriptions, which can be through mail, internet and phone, in English and Spanish.
- While visiting archives, I found myself in the “Vault”. It was shelves with boxes on it. It is where all the historical correspondence for AA is. They pulled out the very first letter from Nevada, and the response from AA to that person. I was able to get copies of those letters through much negotiation and begging.
- As a result of the Jack A. article in 1941, the writer, Ella H., wrote to AA:
  - July 18, 1943 (on 5<sup>th</sup> Street, Las Vegas downtown). “I wrote you once before when your article came out of the Saturday Evening Post. At that time, you told me that your organization was non-profit and you did not have anyone in this area. I saw your article last week in the LA Examiner, and thought at the time when I read it, but I did at there is no help for anyone living in this area. My husband like many other is exceptional in his line of work and understands both plumbing and steam-fitting. And the present his son is in the same line of work. I know the boy’s dream, also mine, to see his dad restored to normal useful life. Everything you have stated in your article is absolutely true, they do try for a period but lack the guts to carry through. If you know

of anyone there is in Las Vegas that I can talk to to get this started, I would be more than willing to my part. I honestly pray that this letter may bring results that my last and sincere hope for your organization has broadened out enough to include Las Vegas. I will be 51 years old and my husband 60, but I feel we have several years ahead for happiness if we can control the desire for liquor. Please let me hear from you soon. -- Ella H."

- Response: July 29, 1943. "I am indeed sorry to tell you that as yet there is no group in Nevada. However, if your husband really wants to stop drinking, there is a precedent to show that he can simply by practicing the 12 Steps and perhaps carrying on some correspondence with this office. I know of scores of people who have recovered just this way [something] association with a group was impossible. The only requirement is that the man himself wants to stop drinking. I am enclosing a brief but comprehensive booklet, which I suggest your husband read. If there is an interest, that he writes me. Any time we can be of assistance, please do not hesitate to call us.

Questions:

- Pamela: What was the agenda item after Gay and Lesbian and before Corrections?
  - Mike: Grapevine business plan. It did not reach the floor.
  - Mike: Re-read the 10 agenda items
- Tom: Were there other agenda items you found interesting that were not a part of the 10 discussed?
  - Mike: Yes, there was a Public Service Announcement (PSA) that was played. It was put in by the PI committee. It was stick figures and they would open into something else, and it was narrated by AA members over the phone of what their life was like as they got sober. The whole segment was 20 or 30 seconds long, but there was a 5 hour discussion about it. It was agreed that they would re-record what was already there. I was so happy to see it and can't wait until it comes out.
- Darryl: What was the title of the PSA?
  - Mike: Doors, I think.
- Darryl: And it was accepted?
  - Mike: Yes, with an amendment and more clear language and in English, French and Spanish.
- Steve M.: You said the total groups of US/Canada. Were there numbers for *members* worldwide? Was there a discussion for membership in US, Canada and worldwide?
  - Mike: There are 115,353 groups worldwide. Members worldwide? I don't know. I can get you that information.
- Cherie: Is there an estimate of when the new or revised pamphlets will be available? Like the mental health and LGBT pamphlets?
  - Mike: Hopefully, we'll get a copy to review and approve before they are available.
- Cherie: Is it the same thing with PSA?
  - Mike: They are hoping to have that available by maybe Atlanta, but probably by

next Spring.

- Rhonda: Service Manual discussion of dark groups—will they be updating the Service Manual with the new language?
    - Mike: Yes.
  - Ruth: How many actual Advisory Actions came out of this conference?
    - Mike: I don't know. [Mike subsequently researched, and the answer is 38.]
  - Ruth: It just tells you how well the group is getting along.
    - Mike: There was so much less background info. More than 500 pages of background material this year, but more than 800 pages last year.
  - Unknown: Could you repeat the transgender item, please?
    - Mike: It passed. Consider updating the pamphlet for AA and the Gay & Lesbian. The discussion was adding transgender and non-conforming issues to the LGBT pamphlet. Passed.
  - Unknown: I have written down that the paragraph in the Service Manual didn't hit the floor. As well as the updates to the Gay and Lesbian pamphlet? Do I have that wrong?
    - Gay and Lesbian pamphlet update hit the floor and passed. The dark Districts in the Service Manual did not reach the floor, but I share with you the decisions that we made.
  - Unknown: So it [the editorial change] is going to be put in?
    - Mike: Yes.
  - Ronny: Annual contribution from \$3k to \$5k was voted no. What was the gist? Why did they make that decision?
    - Mike: I was so certain it was going to pass. In our Report and Charter discussion, that in the French Service Manual, it incorrectly stated that the maximum contribution was \$5k. I told the Committee that we shouldn't make the change because I was so certain that the annual maximum contribution would change to \$5k. We did make the change, but dog-eared it in case we had to go back to it. So few people made the contributions. It would set a precedent that only the wealthy could make those large contributions.
  - Joan: Were there any floor actions?
    - Mike. Yes. I have them and I can email them to you. There is no background for this.
  - Jerry: Would you forward your report via email?
    - Mike: I'll give you the report and finances via Jonelle. You paid for it, so it's yours.
- I hope all of you have the interest to take this position. It is amazing. Thank you all.

**Letter, July 18, 1943. Author: Ella H. Addressed to A.A. Headquarters**

**Source: GSO Archives, manuscript collection, Las Vegas, Nevada.**

Excerpt as follows:

"I wrote you once before when your article came out in the *Saturday Evening Post*.... At that time you told me your organization was nonprofit and you did not have anyone in this area. I saw your article last week in the *Los Angeles Examiner* and thought at the time why read it, but I did, as there is no help for anyone living in this area.

My husband like many another is exceptional in his line of work understands both plumbing and steam filling, at the present his son is in the same line of work...I know it is the boy's dream also mine to see his dad restored to a normal useful life.

Everything you state in your articles are absolutely true, they do try for a period of time but lack the guts to carry through.

If you know of anyone here in Las Vegas that I can talk with to get this started I will be more than willing to do my part.

I honestly pray this letter will bring better results than my last and sincerely hope your organization has broadened out enough to include Las Vegas.

I will be 51 years old and my husband 60 but I feel we have several years ahead for happiness if we can control his desire for liquor...please let me hear from you real soon."
