My sobriety date is Dec. 25, 1994; the High Sierra Group in Bishop, CA. is my home group. It is an honor and a privilege to serve you as your Area 42, Panel 63 Delegate to the General Service Conference.

At this point in every rotation I have been excited and scared. I have never really known exactly what I was supposed to do or how I was supposed to do it. That drove me nuts... until I realized that EVERYbody was clueless, excited, and scared. If you are feeling this way no worries. That's the spirit of rotation. We're not **supposed** to know exactly how to do what we have never done before! And we are all in this together.

What **I do** know about my position is that I, like you GSR's, am a conduit for communication. Concept 1 states that "The final responsibility and ultimate authority for A.A. world services should always reside in the collective conscious of our whole Fellowship." Our groups exercise this authority and assume this responsibility by connecting ourselves to the General Service Conference through our GSRs and our delegates. It's all about our Primary Purpose. Through the General Service Structure, we as a fellowship, constantly ask ourselves how can we be better carry our message of recovery throughout North America and, by example, through the world.

My committee assignment for Panel 63 is to the General Service Conference Committee on Policy and admissions. This committee concerns itself with matters of policy pertaining to the Conference itself as well as reviewing all requests for admissions to the annual meeting. For example, this committee would formulate and recommend guidelines for electronic device users at the conference, or whether or not alternate delegate X can attend in the place of delegate Y who was unable to attend. Additionally, The General Service Board of India might want to send an observer to our annual meeting. This is also a matter of admissions.

I have a secondary assignment to the Conference Committee on International Conventions and Regional Forums.

Soon enough, you will be informed about agenda items coming from many different conference committees. As a delegate, I prepare myself for the business of my assigned committee only; I will have input on business of other committees (i.e. Corrections or Public Information) only if that committee brings a recommendation to the conference floor. At that time I will have an opportunity to share Area 42's thoughts and, keeping Area 42's voice in my mind, vote my conscience. At all levels we trust our trusted servants to do the jobs we request of them – GSRs and Delegates.

Regarding agenda items; this is the last call for items to be considered for the 2013 conference. All agenda items must be submitted to the conference coordinator by Tuesday, Jan.15. Please contact me right away via the Delegate's link on the area website if your group wishes to submit an item.

It will be an honor to come to your group, district or event to give my conference report, or to participate in any General Service panel or workshop that you request. Please email or call me to schedule a visit. A Delegate's calendar can fill quickly, so the sooner you contact me the better.

For that matter, feel free to contact me at any time, for any reason. I am here to serve you. Thank you for our patience with me and my wordy report. I look forward to meeting you and serving A.A. together for the next two years and beyond.
