### **Finance Committee Chair: Paul E**

Paul presented the Nagsc finance Committees proposed 2016 budget for review and approval of the Nagsc body.

## 2015 ESTIMATED ACTUALS:

1 All receipts and expenses through the end of October 2015 and anticipated expenses through December 2015.

## 2016 ORIGINAL BUDGET REQUESTS

1 Most of the Officers and Chairs submitted budgets for their respective positions. For those who did not submit a budget, a budget was created by the finance committee. 2 The amount for the workshops, committee expenses, office supplies and other expense requested were used. 3 For NAGSC meetings mileage was estimated based upon where the officer/chair live - assumed shared ride. 4 For Assemblies, average hotel, registration, food and mileage was calculated. Again, based on where the officer/chair lives - assumed shared rooms and rides. 5 An average cost was used for PRAASA - assumed shared expenses. All officers and chairs were budgeted to attend PRAASA, unless they specifically told the finance committee they are unable to attend. Funding was budgeted to assist DCMs and GSRs attend PRAASA up to \$50 each.

## 2016 CHANGES TO THE ORIGINAL REQUESTS FROM THE NAGSC FINANCE COMMITTEE

1 The budget reflects all possible expenses, providing each officer and chair with a budget to reach out to the districts and groups within Northern Area. Historically, all budgeted expenses have not been spent. In other words, this is the worst (or best) case scenario. 2 The budget was developed assuming all officers and chairs will attend all assemblies and PRAASA, unless specifically they informed the finance committee they are not available. Historically, that has never happened. 3 Officers are fully funded and chairs are funded at \$450 to PRAASA. 4 Anyone needing additional funds may request from the 2016/2017 Finance Committee prior to the February Roundtables. The Finance Committee will recommend based upon available funds. It will be voted on at the Roundtables. See Attached Request Form.

## **Registrar, Julie C**

As many of you may be aware dealing with the group information database has been challenging. Some examples are the limited access to only one person per area and the difficulty providing reports. At the Fall Assembly our area chair, Phil, invited Brouck H to speak on AA technology. Brouck is the Chair of the National AA Technology Workshop. The purpose of NAATW is to address technology and our service work. After the assembly Brouck and I discussed some of the issues Area 42 has experienced with the group information database. I followed up with a letter summarizing some of Area 42's challenges and concerns. Brouck replied the he would make certain this reached someone capable of getting us a sensible answer, and that it would take time. There hasn't been many group change forms submitted to me since the last assembly. However, I had the opportunity to communicate with one meeting that wanted a group number but didn't want to be listed as a group. The meeting/group had some questions that since no one considered the meeting her home group, they couldn't be a group. Ultimately, through a group conscience they are now listed as a new group with a contact, but no GSR. In the future, if someone decides to make this group her home group she could be their GSR. ### **Area 42 Treasurer, Tinna O**

After the Spring Assembly in Tonopah, I had some complaints about the Area's checks for Reimbursement. Those check had the name Alcoholics Anonymous on them. When people went to deposit them, the bank teller clearly saw the name Alcoholics Anonymous. After discussion with the FC and an inquiry to GSO, I ordered checks with the name Nevada Area 42 Assembly and shredded the old checks. The cost was about \$95 from Vista Print for 250

carbon copy checks and a stamp with the Area bank account # for deposit only so I don't have to write the bank account number on the back of hundreds of checks. The Area Treasury has begun reimbursing officers for their pre-payment for airline tickets and registration to PRAASA 2016 in Spokane. We should be saving some money by purchasing ahead of time, sometimes that just depends on the changes in oil prices. After the Fall 2015 Assembly I mailed out all the old Group Contribution Receipts that were in the Treasurer's file. At the Spring 2016 Assembly I will have all the Group Contribution Receipts received since then available for you to pick up for your group. After the Spring assembly I will be mailing out any that haven't been picked up yet, and that can be costly, so please check to see if I have one for your group. What I actually would prefer is if you would contact me with an email for your group. ## **DCM Reports**

### **District 2, Mary D**

Greetings all! This is an exciting time to be a sober service member of Alcoholics Anonymous! District 2 welcomed a new group, Back to Basics and their GSR, Todd to our membership. Groups are reporting higher attendance numbers following the summer. The guideline committee has been meeting before each district meeting and is making steady progress, reporting at each month's meeting. In October we invited Dan, NNIG chairman and Steve, SWACYPAA chairman. They discussed the June 3-4-5, 2016 convention of the Southwest Conference Young People in Alcoholics Anonymous at the Nugget. The local group won the bid to bring the conference to Reno and now they are looking for support as they fund this undertaking. There will be monthly events, generally on the third Saturday of the month. Steve is the general service liaison for SWACYPAA and we look forward to supporting the young people's efforts. Home groups are gearing up for festive events. Several members enjoyed the Gratitude dinner last month. One home group has had successful pot luck celebrations and on December 12<sup>th</sup>, the Eye Opener is adding a Sponsorship workshop to the event. We look forward to supporting District 16 and the 29<sup>th</sup> annual Christmas party, and the NNIG New Year's Day Masquerade event. In January, we will be joining districts 4 and 16 on the 10<sup>th</sup>, presenting a Grapevine writer's workshop. ### **District 4, Wayne H**

We had the Gratitude dinner November 14<sup>th</sup> at the Eldorado in Reno. We also had various Thanksgiving activities around the district, including a turkey dinner at the Reno triangle club to help get people through the holiday. We have a couple of events coming up that I wanted to mention. January 1 we will be having a masquerade themed new years day event at the Atlantis casino in Reno. Doors open at 2:00, tickets are available through NNIG central office. I wanted to congratulate the Reno Nevada's Young Peoples AA for winning the bid for the Southwest Area Conference of Young people's AA (SWACYPAA). The planning committee is meeting 2<sup>nd</sup> and 4<sup>th</sup> Sundays of the month. The Reno Triangle Club has always had rent set at one half of the 7<sup>th</sup> tradition. Which works out great for new groups. If you have a new/small group, and only get \$4 for 7<sup>th</sup> tradition, you rent is only

\$2. However, The club has recently put out a memo stating they expect one half of all monies collected, not just the basket (i.e. The pink cans for hospitals and institutions.). This has been discussed at the group and district level. Most of the groups felt they could no longer pass the pink cans because the money collected is supposed to go to hospitals and institutions, NOT to support the Reno Triangle Club. We are still trying to schedule a meeting with the clubs board to discuss the situation.

## **District 6, John F**

District 6 approved the updates to its guidelines. One change we made is: *Whenever prudent, assist GSRs with expenses to Area Assemblies, and PRAASA.* District 6 had a General Service assembly table at the Carson Valley Gratitude Dinner. I am estimating close to 500 were in attendance at this event. Our own Area 42 Chair, Mike M. was the speaker. The District is planning a 3 panel workshop in January that include Grapevine, Archives and PI CPC presentations. We continue to reach out to new meetings who may be interested in General service. Last month our District Corrections treatment chair and I visited a group in Dayton to share information about General Service and the Pink Can. Visiting groups that I have not been to before in my district is always an enlightening experience for me and reminds me of how much service opportunity is available in AA.

## **District 8, Scott B**

It is good to see you all again in Reno for this NAGSC meeting. The last NAGSC meeting was held at sunny June Lake in the beginning of August when our district, District 8 hosted. It was a pleasure for the district, thanks for that opportunity. I would like to start my report with a little background information about District 8 for those who aren't familiar with us. North to south the district runs along US Highway 395 from Bridgeport to Lone Pine. This is a distance of about 150 miles. From east to west the district extends from the sierra crest to the Nevada state border. The population in our district is mostly rural, Mammoth Lakes and Bishop are the main population centers. There are ten registered groups in the District. The newest is the Benton Group that celebrated its sixth anniversary August 1. Since the last Area Assembly in September, our district organized and held a Meeting Secretary's Workshop in Mammoth Lakes. This workshop featured a panel of three local members who shared on the topics of AA's primary purpose, the meeting secretary's duties and responsibilities and finally about how a meeting secretary can handle situations that might be baffling. The panelist's presentations were followed by question and discussion sessions. At one point, a panelist read a copy of the report on 'Safety in AA' that was delivered by Rhonda W. at the fall assembly and this was well received by the audience. The workshop was relatively well attended with 25 participating which is a very healthy turnout in my experience. In early November many of the groups in the district co-hosted their third annual gratitude dinner which was also well attended, this was not a general service event. In the meantime, the district committee has been working diligently to update the district guidelines. This has been an ongoing project throughout this rotation and a few minutes of our bi-monthly business meetings are typically dedicated to this task. At this time there are no special district activities planned as we head into the holiday season. In closing I would like to thank District 4 for hosting this event.

In keeping with tradition, proceeds from the dinner was given to GSO to express our gratitude for their services. We are so very grateful to Phil for traveling across the state to carry the message of hope and his outstanding example of service and commitment. Now that winter is officially underway, we will wait until Spring to invite members to Elko to share the message. Anyone willing to travel to Elko is encouraged to see me after the meeting. I am looking forward to seeing everyone again at our next NAGS meeting in Reno, provided the weather allows for safe travel.

### **District 10b, Samantha G**

District 10B meetings are hosted by a different Group each time and meet the 4<sup>th</sup> Sunday of odd months at 10 a.m. We have no GSR(s) in attendance today. The November District meeting had 2 GSRs and 1 alternate GSR in attendance. We have only received 7<sup>th</sup> Tradition contributions from 2 groups in the last 2 quarters and cannot afford to fully support the DCM to NAGSC or Assembly meetings. At our September district meeting during the GSR sharing portion, there was much discussion concerning unity or lack of between the groups in Winnemucca. One GSR said how important it is for him to visit other groups to see how they do things. The question of, "Are we working the Steps in our personal lives?" was asked since there's so much dissension between the groups. District 10B participated in Unity Days in Reno. Three of us Winnemuccans drove down and had a blast. The comments on the way home were about how fun and informative the event was. Thank you to the committee for inviting us to participate and be a part of. At our November meeting the GSRs were asked to go to their groups and discuss what to do about finding a new DCM since I've been serving for 2 years now. We still need a treasurer and a secretary too. One member shared he is finishing his paperwork to be able to carry meetings into the jail and we voted to give a GV subscription to the jail. A visitor from one of the groups said her group is working organizing the Unity Days event they used to hold here in Winnemucca. We discussed ways to protect anonymity when talking to the public about renting venues. There was concern around needing \$1 million insurance policy and it was suggested to speak with other districts and GSO for guidance. It was recommended that we consult with other groups, districts, NAGSC, and Area before choosing a date so we don't conflict with other AA events. Our Special Needs chair, Roberta, gave a presentation on handicapped accessibility and service animals in AA meetings. And she brought our GV chair, Debbie, with her. We had lots of conversation about AA not being above the law and legalities regarding service animals as well as various types of handicaps and how AA groups can accommodate members. Thank you Roberta and Debbie for coming all that way to be of service!

### **District 12, Ed L**

Hi everybody my name is Ed and I am an Alcoholic Merry Christmas, District 12 has been thriving even without me. I took a 7 week trip across the country and when I came back everything was running smoothly. Big shout out and thank you to John A. for stepping up while I was gone. We have been scheduling presentations at every business meeting and inviting anyone in the district to attend. ## **Chair, Liaison Reports**

### **Cooperation with Professional Community, Cheryl E**

Aloha All! Here are the activities that CPC (NAGSC CPC and NNIG CPC) has been involved with since the Fall Area Assembly in September 2015.

**University of Nevada Medical School, Reno:** Joyce Y (NNIG CPC chair and NAGSC CPC co-chair) and I, along with other CPC committee members meet with Dr. D and 4-5 third year medical students. We provide the students with some appropriate pamphlets and central office meeting schedules and a short presentation on CPC. The students get an assignment from Dr. D to attend a 12 step meeting and then they report back on their experience in about 6 weeks. We also attend the report backs. We meet with a new rotation of students every 6 weeks. This continues throughout the year. Since the last report in September, we met on Oct. 5<sup>th</sup>, Oct. 19<sup>th</sup>, Nov. 16<sup>th</sup>, and Nov. 30<sup>th</sup>.

**Washoe County School District (WCSD), Reno:** Joyce, Tom B., and I met on Oct. 28<sup>th</sup> to discuss and fill out a project review submission form for the Washoe County School District. Our request is to make presentations to health classes. Tom submitted the form. We received a reply from the school district asking us to meet with the project review team on Dec. 10<sup>th</sup>. Joyce, Tom, and I met on Dec. 4<sup>th</sup> to discuss what we will present at this meeting.

**UNR National Judicial College:** Joyce had been in contact with Crystal N from UNR Judicial College. Judges attending the judicial school for a week from all over the country would be attending the Almost Heaven meeting at 5pm on Oct. 27<sup>th</sup> at the Triangle Club. Joyce and I attended Almost Heaven business meeting on Tuesday, Oct. 13<sup>th</sup>, to let them know there would be ~26 judges at their meeting on the 27<sup>th</sup>. Several CPC committee members and other AA members attended the Almost Heaven meeting that night to support the group. Joyce will be contacting the Program Attorney, Irene H at the Judicial College in to see if CPC can get on their curriculum on a regular basis.

**Right At Home, Reno:** Right At Home provides in home care and assistance. Their care givers are seeing some clients with alcohol problems. CPC gave a presentation to about 8 care givers on June 24<sup>th</sup>. Right At Home has about 140 care givers. We are still in contact with Tricia S, Right At Home Client Care Coordinator, to schedule another presentation.

**District Meetings:** We are attending Northern Area district meetings to give a 10 minute overview on CPC. We attended District 16 business meeting on Nov. 17<sup>th</sup>. We may have a new committee member from this visit! We will be participating in a workshop with Archives, Grapevine, and PI at District 6 (Carson City) sometime in Jan. 2016.
