The practice of presenting the slate of director nominees for AAWS Inc. and Grapevine Inc. began in 1982, it is not clear why this practice was started, however it is firmly established as part of the Compensation, Scope and Procedure of the Conference Committee on Trustees. There has never been a slate disapproved, although there have been instances where concerns over the suitability of individual nominees were expressed by delegates prior to the vote.
What does the Delegate need to know?	The original placement of the operating board slates on the Conference agenda appears to have been a courtesy to the Conference. It now appears that this practice has the potential for causing misunderstanding and controversy, suggesting that consideration be given to discontinuing it.
