Area 42 Treasurers Report: Hi, my name is Claudia and I am an alcoholic. I am your Panel 69 area Treasurer and am here to tell you that your treasury is in great shape. You can see that from August 1, 2019 through July 31, 2020 in the Statement of Financial Position and the Statement of Financial Income and Expense in your packets. For your information, we report these as a fiscal year starting August 1, even though the tax year for Area 42 is the regular Calendar year. With this comes good news and bad news. The good news is that we have a flush treasury. The bad news is that due to COVID-19, we have not been able to have any live conferences or assemblies which are typically our biggest expenses. During this period our income was \$36,957.48 and our expenses we're \$31,623.91, leaving a net income of \$5,336.42. Groups, both live and on Zoom, have been quite generous. Next, I have two requests for those of you who are sending contributions for your groups. First, please make sure that you include the name of your group and, if possible, the GSO-assigned number. I have to look up contributions sometimes by last name and even street name of the signer of the check. If you have not received your group's contribution receipts by email, please email me (or your new treasurer) at treasurer@nevadaarea42.org and I will forward them to you. Next, please, please, please, have your Group treasurer send a note with an email address for me to send your receipt. Quite a few groups are doing this, however I still have to send many of the receipts to the DCMs. If your treasurer does not have email access, then someone in your group probably does and there are plenty of places where you can create a free email account for your group, which is a really good idea anyways. That way it would also be easy for your group to get information like minutes from your DCM, NAGSC/SAGSC, Area 42 and GSO. These are password protected so that only members of your group will be able to see the information and you just give the password to your homegroup members and can pass the email account forward when you rotate positions. Finally, I would like to thank you all for entrusting me with your finances. It has been an honor to be your treasurer and I look forward to continued service to Area 42. And, as I am Jewish and our blessing for Passover is "Next year in Israel", all I have to say is that my blessing is "Next year in Tonopah." Claudia B.

Alt. Chair My name is Jake- I am alcoholic. I am extremely grateful to be sober and to be here with you. Even though we are not in beautiful downtown Tonopah Nevada, my favorite place on earth. I'm still very grateful that we live in a time in history where we can still all be together for this meeting. It has been my absolute honor and privilege to serve as your alternate area 42 chair for the last 2 years. As alternate Area Chair I became your southern area 42 general service committee or SAGSC chair and that is where most of my work has been done for the last 2 years. I want to welcome anyone who is new and if you are new you just heard SAGSC and get ready for about 200 other acronyms this weekend and welcome to general service. So, we started this rotation with a huge change in the way our standing committees are funded for the year. At the May 2019 SAGSC meeting we were informed the Las Vegas intergroup would not be participating in the funding of the standing committees after 2019. This was a big change for our committee which brought up a lot of questions and a lot of fear and confusion. One of the biggest fears was what this change would do to unity of our committees and the southern area. This change was also going to bring changes to our SAGSC guidelines and how our committee would function. As of April 1st 2020, the funds for the SAGSC standing committees were all transferred to the SAGSC treasury and we found ourselves in the middle of a global pandemic of COVID-19. As if we didn't have enough to try and figure out already thanks for that one. At the May 2020 SAGSC meeting we had our first ever virtual SAGSC meeting. As a part of our pandemic panel 69 I was privileged to be a part of 3 of our area conference committees. I was a part of the policy and admissions committee even though Anne doesn't want to see my face and schedules every single meeting while I have to work (that is a stupid joke I hope translates through Zoom) as well as the treatment and accessibilities committee and the Archives committee. Though I wasn't able to be at the policy and admissions meetings I was still kept informed about everything that was going on through email. And the archives and treatment and accessibilities conference committees, going through the reports, talking about the group conscious of area 42, talking about what actually happened at the general service conference as a committee, that was a great experience for me. Having area conference committees is a new thing in our area and I personally hope that we keep doing it. I believe the more it becomes an integrated part of our area the more participation we will have and we will get a well-informed area. This was one of the most difficult general service reports I have ever written. Just like a lot of people in our fellowship the last few months has been a difficult time for me and for my program of recovery. I was told when I was new that everyone has their turn in the barrel. Also, I feel I could have made this report 16 hours long talking about all the things that have happened and the things I have learned about general service and Alcoholics Anonymous as a whole in the last 2 years. So, I would just like to share that the longer I stay sober the more I realize what a miracle it is that I ever got sober and became a member of this fellowship, and the more I realize the most important thing we have in AA and what keeps our fellowship spiritually fit is our unity. I believe what keeps us unified is our 12 traditions. So, I just want to finish off with some quotes from Bill W. on AA and unity. When an alcoholic applies the 12 steps of our recovery program to their personal life, their disintegration stops, and their unification begins. Exactly the same principle applies to Alcoholics Anonymous as a whole. So long as the ties which bind us together prove far stronger than those forces which would divide us, if they could, all will be well. We shall be secure as a movement, our essential unity will remain a certainty. If as AA members we can each refuse public prestige and renounce any desire for personal power, if as a movement we insist on remaining poor so avoiding disputes about extensive property and its management, if we steadfastly decline all political sectarian or other alliances, we shall avoid internal division and public notoriety. If as a movement we remain a spiritual entity concerned only with caring our message to fellow sufferers without charge or obligation then only, can we most effectively complete our mission. Unity is so vital to us AAs that we cannot risk those attitudes and practices which have sometimes demoralized other forms of human society. Thus far we have succeeded because we have been different. May we continue to be so! But AA unity cannot automatically preserve itself. Like personal recovery, we shall always have to work to maintain it. Here too we surely need honesty, humility, open mindedness, unselfishness and above all vigilance. Since personal calamity holds us in bondage no more, our most challenging concern has become the future of Alcoholics Anonymous, how to preserve among us such a powerful unity that neither weakness of persons nor the strain and strife of these troubled times can harm our common cause. We know that Alcoholics Anonymous must continue to live else save a few exceptions we and our brother alcoholics throughout the world will surely resume the hopeless journey to oblivion. May we never forget that without permanent unity we can offer little lasting relief to those scores of thousands yet to join us in their quest for freedom. Thank you Bill. My last quotes of the day are from Dr. Bob. Let's not louse this thing up. Let's keep this simple. Let's remember it boils down to love and service. We all know what love is we all know what service is. Thank you all so much for being here this weekend thank you all for holding my hand and giving me a new life, a life worth living. Alcoholics Anonymous has saved my life and General Service has become a huge part of my program of recovery. I love you all!

NAGSC CHAIR I would like to open with how much I miss the hugs and handshakes from my family, which is all of you. I never thought that in my recovery we would have been in a situation like we are now. But I know now that the energy I put into my drinking has become the will to survive in recovery. I

always had problems asking for help in my service experience. The zoom meetings have completely changed that. I have a wonderful family and network of people who I turn to and they are always there. When I stood for the NAGSC Chair position I thought to myself, I probably won't get this, but I need to get used to standing for something and letting your higher power chose. Arizona didn't have all thirteen committees mirrored, more of Committee Chairs. Maybe we want to have less, more of something we would be more familiar with.

Feedback:

- We didn't model Committees from other Areas, we model them out of the Service Manual. Agenda items come from all thirteen Committees. This past year, Trustees Committee had a ton. This is a valuable tool to learn about the Committees.
- It will take time to perfect what we are doing. Let's try one more rotation. I feel it is beneficial.
- I found it to be informative. I found a few deficiencies in the committee workbooks. Some of the helpful literature was not listed in the workbook. I learned more from being on the committee than in the workbook.
- Participating was worthwhile, yet challenging.
- Give it more time to see if we can connect with it. Interaction between committee members from the North and South and learning the language of General Service is good.
- The way it is set-up, people can slide into learning why we are here. I feel more people may be willing to participate.
- We should continue and keep working on. I suggest the committee chairs could get together on how to answer questions on how to proceed.
- Until the Conference Comes Alive DVD comes out, this is a great tool.
- The reason we are discussing this is to get a sense, do we want to move forward with this. It will be brought up Sunday.
- The interaction between North and South as we bring the new people in is beneficial. We need a solution on how we can bring the Spanish community into this. It is beneficial to me, I would like to see it benefit all.

- I propose that we bring this up Sunday. The hiccup was taking it to NAGSC & SAGSC first. Is this to be decided every panel? Let's make it known to the Standing Committee Chairs that this is part of their position.
- Can I have a sense of the room? As we move forward, there will be more information and instruction.
- When the committees break the Conference Agenda items down, it helps the Delegate at the Conference.
- There is value in what we have been building towards. DCM's should be assigned to committees.
- It is a great idea. It is important to distinguish between the Area Standing Committees and the Area Conference Committees.
- It is important to have an Alternate Chair, as opposed to Co-Chair.

Year one put me at ease I was so excited for year two. Year 2 was supposed to be "My" year. An International Convention (As Delegate), a trip to steppingstones, a regional Forum in my hometown (as Delegate) My ego was on fire!!! Then came the Covid. My plans to dominate as delegate were squashed. In reality, the world of AA got busy, zoom meetings were created, zoom workshops and conferences were scheduled, the Pacific Region Delegates started a monthly meeting and shared their homegroup information with each other. GSO created a Virtual 70th Annual Zoom Conference, a special finance meeting, a special strategic planning meeting and in November a special Western Forum. The Delegates mailed buttons, bookmarks and words of encouragement to each other. Our separate committees met via zoom 4 or 5 times. Our Area upped its game with Virtual committee meetings, district meetings, workshops and 2 assemblies via zoom. What I didn't expect was getting to know everyone on such a deeper level virtually. Seeing everyone's faces and hearing them share has brought my little world of AA to new heights. It truly was a gift among all the chaos. Now here we are. Our fall election assembly and I am sad, sad that I will now be known as a past, but as Phil would say "You will always be the Panel 69 Delegate" sad that I missed that second year, but grateful that I got to represent Area 42 virtually. I'm so excited to bring in Panel 71 I know that they will represent us with the same love and gratitude that all our pasts have. I want to thank everyone for all the e-mails, phone calls and zoom invites! It has been an honor to serve as your panel 69 area 42 Delegate.

Pacific Regional Trustee Report Kathi, alcoholic. I'm honored to be here to help with your elections. The past couple of years serving with Rhonda has been amazing. These are times of change.

- AAWS has appointed its first non-alcoholic Trustee to serve on the Board in 50 years. Sister Judith Curran is a wealth of knowledge and background.
- We have retranslated the Big Book and 12&12 to sign language.
- Since COVID, book and Literature sales took a dive. 70% from AAWS and 30% from Grapevine.Org
- Contributions went down. Members contributions have grown. \$1,030,000. In contributions, with a mid \$800,000 being in the last month.
- There has been a \$3,000,000 drawdown on our reserves. Based on our expenses, there's 7-8 months of prudent reserve. If things open back up, it could be less than that. Most non-profits keep a 6-month prudent reserve.
- Staff has been working from home. They have been showing up and getting the work done. Send them an e-mail.
- Nineteen employees took retirement. Some were of age. That has made more work for those remaining.
- Corrections answer 500 requests a month.
- Staff are not looking to return to the office until at least after January. They are looking at how the changes of COVID are spiking.
- Loners International information, Grapevine magazines, reading material and an address to an inmate for correspondence was sent to a Ca. Dept. of Forestry worker.
- I currently serve on the Grapevine Board. We are moving quickly, there are so many stories going into the magazine on current issues.
- Subscriptions have stayed or increased during 2020. La Vina has gone down 20%. We are working on bringing it up.
- La Vina has been put in full color. The subscription cost has not changed after changing from black and white to color.
- The Conference Committee asked to have Instagram looked at.
- There is so much stuff on the Grapevine Utube.
- AA is about carrying the message, not sales. Sales could be about buying subscriptions for the still suffering alcoholic.
- As of July 2,584, Grapevine gift certificates were purchased
- New books coming out in the Spring of next year will be on 'Prison' and 'Spanish Speaking Women'
- Through July, Grapevine has sold \$217,000 and a cost of \$171,000. E-subscriptions are \$1.99 monthly.
- Every two years, there is a World Service meeting. Every other time it is in the U.S., this year was to be our turn. It has been cancelled, with offer of World Service meeting virtually, at the end of the year.
- There are no Regional Forums this year. The General Service Office decided on holding two virtual. There will be a one-day event on Dec. 19th. They are interactive and fun.
- The Women's Spanish Pamphlet got all the stories together, so by next conference, there should be a draft of the pamphlet.
- The Trustees nominating Committee are looking to replace Michele. They will be voting on candidates for Service Board Chairs. There are 2-3 Class A, two General Service Board, and two U.S. Trustees at large; for a total of eight of twenty-one rotating out.

- The Big Book is in 70 other languages plus English. 26 are pending; 21 of the 26 are new; five revisions are in progress. AA stretches across 150 Countries.
- Keep coming back and good work.

NAGSC Corrections Committee volunteers serve the Fellowship in primarily three ways; by participating in meetings at correctional facilities, by serving as Pre-Release Contacts for inmate A.A. members scheduled for release and taking them to their first A.A. meeting once paroled, and by serving as Corrections Correspondents where we share our recovery experience through the mail with an inmate who has requested this service. Committee Volunteers for all three primary service functions are always needed. Throughout the NAGSC geography the committee has a presence in Federal, State, and county or local jail facilities. We have responsibility for eight State of Nevada facilities, seven Nevada County facilities, five State of California facilities, three California County facilities, and one Federal facility. The Committee includes volunteers who secure the appropriate security clearance and take A.A. meetings into correctional facilities and with larger institutions, Facility Coordinators who manage our activity within those facilities. We also have a number of District level Corrections, H&I, or C&T, (Corrections & Treatment), committees throughout NAGSC. Corrections facilities in the greater Reno area, including Washoe County Jail, fall under the umbrella of Northern Nevada Intergroup Corrections Committee. The chair position for this committee is currently vacant. Depending upon where the corrections facility is located, volunteers complete the required background checks, training seminars, and adhere to the policy of either the Nevada Department of Corrections, the California Department of Corrections, or the local county or city Department of Corrections. Within the states of Nevada and California, corrections facilities include both prisons and lower security conservation camps. Because some NAGSC facilities are in California, part of this Chair's responsibility is to coordinate corrections activity with the Northern California H&I Committee. In most cases, volunteers are required to maintain a TB clearance test on an annual basis to remain eligible for service. It is important to note that ultimately, it is a government agency that decides who our approved volunteers are. The NAGSC Corrections Committee has been successful in establishing new A.A. meeting within two facilities during this panel; Lovelock State Prison and Northern Nevada Transitional Housing. We have a current opportunity to establish a new meeting at the Federal Correctional Institution at Herlong. We are in communication with officials with appropriate governments regarding potential start-up timing for our meetings which were halted in all facilities as a result of the virus. As previously noted, one of this Chair's responsibilities is to arrange "Pre-Release Contacts" for inmate A.A. members who are scheduled for release and have reached out to A.A. for help in getting established in the A.A. Fellowship in their new city of residence upon release. This often involves contacting A.A. Areas throughout the country in an effort to find a Pre-Release Contact volunteer who will correspond with the inmate while still in custody and arrange to meet that inmate upon parole in order to take the inmate to his or her first A.A. meetings and in general, help the inmate start the process of "becoming comfortable " in their new A.A. Fellowship. The "Pre-Release Contact" function in corrections is also sometimes referred to as "Bridging The Gap". In the current environment the Pre-Release contacts can advise new members as to "Zoom Meeting" connections, advise as to any in-person meetings available, and serve as a helpful resource to our new members. The NAGSC Corrections Committee continues to focus on facilities where A.A. does not currently have a presence. Areas of opportunity are Susanville and the Winnemucca / Wells areas. There is an ever-

present need for volunteers for the Corrections Correspondence Service. While at present time the GSO reports an adequate number of volunteers, the number of volunteers needed is a "moving target" based on the number of inmates requesting the service. We often have increases in inmate requests and an inadequate number of volunteers, thus the ever-present need for additional volunteers. Because outside A.A. member correspondents are separated by at least two geographical regions from those inmates requesting our service, volunteers are needed in all Areas. Spanish speaking and writing outside members are urged to enroll as Corrections Correspondents. As continually noted in this Chair's reports and announcements, "having experience being incarcerated is Not a requirement for A.A. Corrections Service". SAGSC CPC & PI Hello Area 42! My name is Laura and I am a grateful Alcoholic and the SAGSC CPC Committee Chair. I will be giving the CPC and PI Committees report to the Assembly. At the time of our last Assembly March 27-28 the state of Nevada had just been shut down by the COVID-19 Pandemic. No one could imagine what we have come to know as the new reality for Alcoholics working in general service. We managed during what we thought would be a very short shut down, and slowly began to realize that everything we did was going to change for the long term, and perhaps some changes may be permanent. While Nevada is now mostly open, we continue with significant restrictions for groups, meetings, and public events. Most of our community service partners in the southern area (Homeless Alliance, The Giving Project PACT Coalition, APG, and several Veteran Groups) immediately cancelled events and to date only a few have hosted some virtual events or reduced live events for select communities. Our professional partners have gone completely virtual and continue so at this time. So, our committees attempted to adjust and respond to the new normal. We have members participating via zoom monthly meetings of active community partners. Business wise our committees did vote to stop our self-funding status, are now solely under SAGSCs for financial support. Since our last assembly our committees have met via zoom monthly and continued to work on getting the word out about Alcoholics Anonymous. In April the PI Committee did a press release and were interviewed for one television news report titled: As alcohol sales spike nationwide how are recovering alcoholics doing. In July we again reached out to many news and radio channels with request for AA public service announcements be aired. In August the PI committee began a campaign to get literature into Urgent Care Centers in the Vegas community. In addition, there is an active plan for outreach to high school counselors, once the public schools begin live sessions. We have active plans to restore literature racks in public venues. In addition, CPC committee members began to participate in a North America CPC group which meets quarterly and shares information across the country. We have attended multiple workshops to gather ideas for coordinating efforts in the professional communities. We were honored to do a presentation via Zoom for a group of Family Medical Residents at Sunrise Hospital in July. The feedback was very good. Participation in our committee business meetings since the pandemic has dwindled, and we currently have leadership positions up for rotation changes in January. As this will be

my last few months, and my last Assembly Report we are looking for someone willing to serve as CPC chair beginning in January. We are also seeking a person to assume secretary duties for our combined committees. Leadership roles are 2-year commitments and must have sound sobriety. In addition, we need service commitments for anyone with data base skills, web skills, Public Information, and Professional outreach experience. However, experience is not required. We work with the premise that AA in its basic form is simply one alcoholic talking to another alcoholic. Ad-hoc Committee on Treasury (Presentation) Purpose: To investigate and make recommendations to the Area regarding the possibility of eliminating separate treasuries for SAGSC and NAGSC and having a single Area 42 treasury. If the decision is made to go forward the ad hoc committee will present a plan and execute the transition. Background: A past Area 42 Delegate and past Trustee provided some background into the history of how Area 42 moved to three treasuries from one. She explained that Area 42 was an area that had little participation and met only once a year. There were not enough people to do the work of General Service. They had lots of money, but no one ever did any service work. They just seemed to meet once a year and talk. In about 1990, she and the then-sitting Delegate suggested that the Area split the treasury into two additional parts, one for the North and one for the South. The sub-areas (NAGSC and SAGSC) then agreed to start meeting four times a year with the primary object being to do service work with the money they now had. The area as a whole would begin meeting twice a year. For many years that seemed to work well with Al-anon using half of the room in Tonopah as we were such a small body. Our membership grew to the point that Al-anon now meets at a different time so we can use the entire room. The split was to be revisited as the Area grew. Our past Delegate / Trustee opined that she felt for some time that the Area has grown enough that we should begin to function as one Area as there are now enough service workers to fill all the commitments.

 - Potential for higher risk of fraud or theft
 - Potential time delays in reimbursements
 - Learning curve during transition
 - Rewriting all 3 entity guidelines
- Unity
 - Fear that the North and South may not get what they need from the Area and lose some autonomy
 - Loss of service positions
 - Resistance to change from individuals, groups and other service entities

The Ad Hoc Committee unanimously recommends combining the Area 42 treasuries for the following reasons:

- The reason for separating the treasuries no longer exists
- It would save time and money in tax preparation
- It would align Area 42 finances to mirror AA pamphlets
- Modern banking tools would enable the Area Treasurer and Area Alternate Treasurer to easily perform duties in both the North and the South
- It would simplify Group contributions

Assuming the body decides in favor of creating a single treasury there will be a 2-step process to unify the treasuries into one.

Step 1 would entail creating the plan for the transition to a single treasury. This would include:

- Recommending Area 42 guideline changes
- Bookkeeping changes
- Close the two regional treasuries
- Tax preparation changes
- Finance committee changes
- Group communications
- Other related changes as found during the planning process

Step 2 would be the execution of the above plan.

Conclusion For the stated reasons the Treasuries Unification Ad Hoc Committee unanimously recommends moving forward with combining the SAGSC and NAGSC treasuries into the Area treasury.

Assuming the body approves the motion to go forward today, our next step is to bring a draft of the Area 42 Guidelines changes to the body at the spring assembly.

FEEDBACK:

- Outstanding! Totally agree. This is well thought out.
- This report is so clear. It is a wonderful idea. Q. Don't I have to take this to my group? A. No, you have right of decision.
- Wonderful, clear and concise presentation. This is a wonderful idea. Q. Would there be one finance committee? A. Eventually after transition.
- Amazing idea. Presentation was great. The hardest idea to explain to our groups. We don't have to be unique anymore.
- Can you send this presentation to the groups? A. This process will take a minimum of two years. We are not doing anything yet. Debbie will distribute presentation to body.
- Q. Is the Area going to fund all NAGSC and SAGSC expenses? A. We did not work the details out yet.
- One treasury, will still go through a budget process. The budget will be for all expenses needed.
- My concern is that combined treasuries may lose some services. A. Both treasurers will be able to draw from bank. North and South will be Treasurer and Alternate Treasurer. Money will just be combined, so we are not losing anything.
- Try not to get caught up in the small details. We are only trying to combine treasuries. Position funding will be autonomous. There will be a big enough budget to fund positions.
- It is a great idea. I suggest to make sure that the finance committee deep dive on how funds are going to be dispersed in a timely manner and how the committees operate.
- My concern is that the Southern is more populated and North may be constricted. He who controls the purse, controls the situation.
- My perception is that the South is grabbing money.

- I am on the committee, as Libby mentioned, there were designated members to ask district for feedback. Feedback showed up on the pro and con. We are not taking this lightly. We are looking to see what this really will look like.
- Funds will be represented equally with the Treasurer and Alternate rotating. Remote communities need their share to be active in the North and South. Committees submit their budget. There will be representation from all over Area 42.
- I'm on the committee, I just want a sense of taking it on. Do you want us to pursue? We are not spending too much time on the particulars. It will take two-three years at least. Do you want us to pursue or not is all we want to know.
- I agree with a lot of stuff said. Let's look into a draft proposal to the Area. Don't want to see NAGSC funds used for used more populous areas. I want to see a plan.
- I heard concerns, whatever happens, I will support. Q. I the current system broke?
- Q. What was the major motive? A. To simplify the account. Put all the money into one pot. The Area has matured in service functions so let's expedite service work.
- In responding to the question on motivation. If NAGSC or SAGSC has money issues, should they be borrowing from the Area?
- If it ain't broke, don't fix it.

Sense of the Assembly: Should we have the ad-hoc committee, on combining the three treasuries, move forward to work on a proposal? **Yes 72 / No 8.** Maybe have a proposal in the Fall 2021; give an updated report in Spring 2021.

Area Budget: A budget was presented, discussed, amended, and approved. (Financials are posted on Area Website.)

Motion regarding refund of Spring 2020 Registrations. Dan made a motion to have the Area reimburse, for the full amount that was paid to "Brown Paper Tickets" by the registrants, as it was an Area decision to use them. **2nd, passed.**

Discussion:

- Q. Can we do this without writing 100 checks for \$15? A. Set's clean this up for this assembly. I will help write checks.
- Q. How much are we looking at? A. \$2954. There are 109 registrations and 75 banquet tickets.
- I will need \$200 more to buy checks.
- Q. Can I just donate it to Area? A. No, it will mess up the budget. Just take the check and cash it. This is not a donation. BPT has the money. If you get your money back from BPT, you decide what to do with it.

Registrar will send email to all registrants for any updated addresses. The Finance Committee and Registrar will work out all the nitty gritty.

Ad-hoc Committee on YPAA. The Area 42 Standing committee ad-hoc has met two times, with very limited attendance. We have identified the current problems within Area 42 which have been identified as: There is no centralized point of contact within the area for other committees to fulfill service needs best provided by young people. Lack of communication at the area level for all the various YP activities occurring within the districts. Lack of presence in rural areas where young people's meetings, and committees are needed. A proposal has been created with proposed solutions, and a clear definition of what the YPAA standing committee would like, which I will read next Area assembly. I would really like some help with feedback on the proposal, and will need help with the guidelines change as this will be a guideline changing proposal. Our primary purpose has been defined as: "The Area 42 Young Peoples in AA standing committee, encourages young people to enter into the mainstream of AA Recovery, Service, and Unity through the 12 Steps, the 12 Traditions and the 12 Concepts for World Service. Young People's groups are in no way separate from Alcoholics Anonymous as a whole. Members are involved in, and committed to all levels of AA service. Age is not a requirement for a young people's group. Young people's groups and activities directed towards young people in AA are helpful tools in reaching young alcoholics who might otherwise not give AA a try for many more years, if at all." (Taken from New Mexico AA Area 46) Basic function of Young People's Committee: Assist young people in finding service opportunities, connect young people with members of AA of all ages, provide resources, references and contacts to start and/or find young people oriented meetings. (Area 46 New Mexico). We strive to: Support young alcoholics in their recovery, promote unity among alcoholics of all ages, encourage young members of A.A. to participate in A.A.'s General Service Structure. (Area 31 Western Massachusetts)

Feedback:

- Q. Is this going to be a YPAA General Service Committee, like our other Committees position? A. Not yet, it would take several YPAA proposals to make it as a General Service Standing Committee.
- Are you merging LVYPAA, RENVYAA? A. No There is more than LVYPAA and RENVYPAA, examples SPARKYPAA, TTYPAA, etc. We will just have one Gen. Service Liaison report to Area42 from the several YPAA's Committees.
- We will still have the existing committees to fulfill their local needs. The movement in Young People is growing and we see a need for it. Other Areas have YPAA Liaisons, we are doing catch-up. It would benefit the Area to be a part of. Good resource for AA.
- I heard you are asking for help. Most YPAA start with a liaison to talk to the other YPAA's, for help and support first.
- LVYPAA has been around since 2008. This isn't something we are starting. We have already had young people showing up at Area 42 Assemblies. It is time for an Area Committee. We have Districts asking GSR's to be their local YPAA liaison. It is the natural progression and now time for the next step.

Treatment For me, participating on the T/A Conference Committee is worthwhile. Good but challenging, sometime more than that. It reveals a part of A.A. that is mysterious - the interconnection between the body and the GSC and the GSO, conference committees and trustee committees taking stock from what the body of A.A. experiences in the various ways we devise to carry our message to the suffering alcoholic. There is a kind of alchemy that happens, how shared experience is collected and woven into literature that we can use to guide our collective efforts to carry the message to alcoholics who still suffer, year after year. I got a boost in confidence just a week or so ago, when a long timer in SAGSC general service jumped into Conference Committee report prep when asked at the last minute. I get an overwhelmed feeling with the added work of reporting on the Conference Committee, but have come to realize that it passes as I ask for help to keep it real, do what is in front of me, take baby steps, do one thing at a time in some sort of order that seems to come from deep down inside, don't worry about the outcome. No one is assigning grades. I was even so overwhelmed that a tsunami of inspiration propelled me to pick up the phone and call some long-time general service junkies to get their guidance through rough patches during recent months. A kind of joy wells up on occasion when I feel a part of a society of ill people getting weller by trying to live spiritual lives in unity and applying the principles of making decisions democratically. It lifts my spirits. The inconvenience of Conference Committee duty morphs into a labor of love. Unbidden moments of trust and surrender are essential experiences. There is so much alcoholic pain and suffering. To have been spared and changed into one whose experience can help others like me keeps me living, alive. I am grateful for having time and space and health in my life to participate, and for family members that love me just as I am, a recovering alcoholic with a compulsion to live the A.A. way of life. Policy and Admission Chairperson: Anne D., Co-Chairperson: Rina H. Policy & Admissions Committee: Ernesto C., Dean H., Colton S., Susan L., Deborah C., Kevin C., Felicia W., Joe V., Rich S., Bruce S., Committee Support: Sophie K., Jake S. The Area 42, Panel 70 Policy & Admissions Committee met for a Zoom conference call at 9 a.m. on Sept. 5. Those present on the call were Bruce S., Sophie K. and Anne D. The meeting included a review of the General Service Conference's Policy & Admissions Committee's 2020 report and the Area 42 Spring 2020 Policy & Admissions Committee Report submitted in April. The italicized part is the A42 P&A Committee's findings as reported in the Spring 2020 report to the area. The Area 42 Policy & Admissions Committee would like to submit the following: Consider a proposed process for approving observers in the US/Canada General Service Conference.

The Area 42 P&A Committee agreed that the GSC P&A committee ought to consider the proposed process which includes an Oct. 1 deadline for application to attend the following year's GSC. The A42 committee thought it would help both the GSO and the travelling observer with making plans to attend. It would also help make way for friends of AA who can further share the AA message. GSC Panel 70 P&A Conference Committee recommended.

Consider implementing electronic voting for trustee elections. *The A42 P&A Committee agreed that electronic voting ought to be considered for the trustee elections.* GSC Panel 70 P&A Conference Committee recommended with a NOTE that should it become a Conference Advisory Action it may warrant updating of the second sentence in Article 10 of the Conference Charter. Review GSO general manager's report regarding General Service Conference site selection. *Yes. We agreed that it would be a good thing to review the GSO general manager's report regarding GSC site selection.* GSC Panel 70 P&A Conference Committee recommended. Consider continuing the review of dates for the GSC with timing and year(s) to review as requested by GM. *Area 42's P&A Committee agreed that the P&A GSC committee continue to review dates as requested in order to secure best 'deals' with New York area convention and hospitality services.* GSC Panel 70 P&A Conference Committee forwarded to 71st GSC. Consider a proposed process for how a Conference Committee could review and discuss and act on proposed agenda items not forwarded to a Conference Committee. *Deborah H. and Sophie K. submitted this item for discussion at the round tables. The A42 P&A Committee agrees the proposed process as outlined in the background for the agenda item ought to be considered. It seems to offer a way the Delegate Committees to have input on agenda items should the Trustees not put for a proposed agenda item. The A42 Committee thought this would be a great way to find a balance with Trustees.* GSC Panel 70 P&A Conference Committee forwarded to 71st GSC. Consider a proposed process for equitable distribution of Conference Committees workload. *The background information indicates that the workload distribution is continually addressed throughout the conference history stretching back to the late 1950s. The A42 P&A Committee agreed that the proposal in the background information that would condense the 13 GSC Committees down to six ought to be considered.* GSC Panel 70 P&A Conference Committee requested the Trustees GSC clarify the specifics of the proposal and bring it back for review in 2021 with more on precisely how this process will impact what will happen regarding agenda items considered at the Fall and Winter trustees' meetings. Clarity on on how the process with impact the delegates, creation of primary committees' scope of work and process and provide examples with sample agenda items showing how the whole process will work for 2021. Review Floor Action process. *"This is kind of a funny one." The Trustees committee took no action when a proposal to review the current Floor Action process in November 2019 then agreed in February 2020 to forward to the 2020 Conference Policy and Admissions Committee a proposed agenda item to "Review the Floor Action process to guard against circumvention of the Conference process."* *The A42 P&A Committee agreed that the Item G. should be thoroughly reviewed.* GSC Panel 70 P&A Conference Committee forwarded to 71st GSC.

International Conventions/Regional Forums What do you feel about how your conference committee handled your agenda items? They met twice virtually and accepted the steps taken related to the cancellation of the 2020 International Convention. They deliberated issues related to the use of the Lord's Prayer and agreed that additional discussion was indicated. This is a very important issue and does not bear a quick decision. Careful consideration must be given to this important issue and I believe that the committee understands this. Discussed ways to encourage attendance in forums especially for first-timers and many great ideas were reviewed. Was new information revealed to you, that you hadn't thought of during your committee discussions? Not particularly. Was there anything specific that touched you? How did it touch you? The memory of the Lord's prayer being said by an entire stadium gives me goose bumps but I understand that it is problematic for some. It is critical that AA is welcoming to all though. This is a real challenge for our fellowship and will likely continue to be in discussion. Was your experience on the Area Conference Committee helpful? Yes Do you feel you learned more about the General Service Conference process? Yes. What would you like changed for next panel? Don't have any further to suggest. Best regards, John

New/Unfinished Business:

Area Conference Committees Should we continue?

Area Chair, Paul: This exercise was created 2 years ago. This not only helps with the post conference; it also helps with the pre-conference. Having people from that particular committee go over the Conference Agenda items lessens the load. Question: Do we want to keep doing this? There were some confusion and growing pains. As the panel progressed, we learned some things.

Alternate Delegate, Julie: Thank you all whom participated. We rolled it out fast, now we are pulling out slower. If we do it again, Jake will train for this. If you want to do this, we want you to. Look how much more knowledge you have to share with the GSR's. By the time you stand for Delegate, you will be much more prepared. The feedback from the Committees? We heard you. With only one chair, I suggest we communicate. The Committee Chairs will change with their positions. I suggest we assign DCM's and GSR's into a Committee; they can opt out.

Alternate Chair, Jake: Thank you everyone. This is new to our Area. There was so much information, and no one knew how to proceed. It is simple, so much work, but simple. Pre-conference, we have the committee to summarize and choose the Conference Agenda Items. Post-Conference, we have the Committee report back the results. This helps the Area Standing Committees in their positions. The feedback is not negative; it is the growing pains.

Area Chair, Paul: Maybe we should have a Chair and an Alternate Chair, as opposed to a Chair and a Co-Chair.

Feedback:

- Good stuff. Ideas on how we can make this more efficient; use the conference report for a reference, Preparing the Delegate for the General Service Conference, use the conference report as a tool.
- I had a clear picture of what the General Conference would look like by the time I got there. It is exciting to see that Area 42 is talking about this again.
- I don't agree with the view of "Not knowing what we were doing". Julie gave good instructions. I agree with the young stages view. People only feel comfortable doing what is comfortable. We need to make people feel comfortable.
- I enjoyed walking through the whole process of pre and post Conference.
- I had to opt out. I was confused. Now I have a better understanding of what we are doing.
- I would suggest/consider that some of the Standing Committee Chairs and Area Officer with a heavier work load could get someone else in the Conference Committee to chair.
- To translate I read everything. I learned a lot of the Committees. Question: How can we get the Spanish Community to participate? It is important to make them feel included. We need to be sure we are aware of being inclusive.
- GSR's need to be aware through the GSR manual that they will be assigned to a committee and made clear of the whole process of serving on that committee.
- The discussion through the weekend has made me aware of the scope of this. Maybe we can be involved on a different Area Conference Committee than our position?
- I did not participate as I had too much on my plate to add one more thing. I want to add that I was not pressured. Would it be easier done at the Area Assembly, rather than at NAGSC/SAGSC? A. If you want to be on another committee let us know. It has to be done before Area Assembly to prepare the Delegate for the Conference.
- We would appoint the Homegroup of the GSR. As member of Officers, you can pick the committee you want to serve on. This is something that has been near and dear to my heart for many years.

- This is some valuable conversation. I have learned a lot as part of SAGSC. I am puzzled about, so many groups-very little participations. It would be valuable to have the General Service and Conference committees explained to the GSR.
- Points of confusion started with the sign-up sheets. I suggest we start with the Districts to recruit the GSR's. The DCM would start earlier and would be able to communicate between Area and Groups.

Sense of the Assembly: If you are in favor of continuing with the Area Conference Committees, click yes; otherwise click no. **64 yes/2 no** it is a substantial unanimity to move forward. This will probably be talked about in the upcoming NAGSC and SAGSC meetings. Hopefully this will become part of our Area. The more information we can get, helps us to better serve AA.

Break 10:30-10:45

Hybrid Area Assembly Meetings Allow each group to participate in all future Area Assemblies in person or virtual by Zoom. Submitted 9-8-20 by Tues Grapevine Group (District 3) The group's reasons for doing this: 1. More groups will have the opportunity to participate. Many groups, including ours, do not have the funds to send a Rep. to Tonopah twice a year. 2. Funds saved by not traveling to Tonopah (including grants to groups from our Service Structure) can be used to further our Primary Purpose. 3. It is safer and more efficient for many people. 4. Groups still have the option of sending their Rep. to Tonopah. Paul, SAGS Chair Jake has convinced me we should NOT discuss any pros and cons of this during this month's Assembly. Instead, please create a committee to study all of the pros and cons. That committee should be charged with providing a full report on this motion for our Spring 21 Assembly. Also, we want to get official backing from District 3 and SAGS before the Spring Assembly. Neither of these groups meet until after this month's Assembly. Humble thanks to Paul, Jake, Jason and Tues. Grapevine Group for your input into this. It is a very good idea whose time has come to implement. Many other Areas are also looking into doing this. In Service, Bob D. Tuesday Grapevine Group GSR

Does the body want me to create an ad-hoc committee to look into this? The issues are wi-fi in Tonopah, equipment, logistics. The idea is not bad, implementing it in Tonopah could be a problem.

Feedback:

- I support this 100%. The ability to meet virtually would be efficient in time and financials. I believe we need to bring others into the process. I say yes.
- I support an ad-hoc committee. Hot spot option? My homegroup figured out how to. Allowing hybrid, the spirit and relationships would be lost. It is easier to opt out in person.
- It's a good idea to look at it.
- Isn't COVID going to go away? What about anonymity breaks, like to the fellowship? Is this a proposal? A. The details would be looked at. Do not worry about the details now. The question is, do you want me to create an ad-hoc committee to look into starting a hybrid Assembly.
- We need to look at this, the future we may be facing may become our reality. I have never seen an ad-hoc committee say no.
- Money is available for GSR's to come to the Assembly. Safety is the issue, now it is not safe.
- I do not think we need to appoint an ad-hoc committee; we should use the Communications Committee to look into this. In the Spring, less attended the zoom meeting than we had in registrations. There is less unity. If we have to, ok, if it is safe.
- We budget for GSR travel to NAGSC. If you want the voice of your group to be heard, your GSR needs to participate.
- For the logistics, we need a broadcast engineer. Who is going to be in charge of the equipment? Is it physically feasible? These need to be looked at.

- I'm not attacking Tonopah, it is good. A Communications Committee already exists. Maybe they can explore options to look into it.
- I support an ad-hoc committee. That is a lot of work to be put onto the Communications Committee.
- The concept of safety is of personal importance. We can't be prudent to know what our facts are. What are our options to have some one look into it and report back? Central Office in Las Vegas will be setting up for hybrid. Boosters are available. Technical issues can be resolved, as can financial issues. Facts need to be looked at.

Sense of the Assembly: Does the body want me to assign an ad-hoc committee to look into the logistics, etc of holding Hybrid Area Assemblies? **Unanimously Yes.** The Communications Committee is to keep a pulse on it. The ad-hoc committee is to contact the Communications Committee when assigned. Contact Paul for signing up to be on the ad-hoc committee. I am looking for technical advisors and others to serve on this committee.

Registration Badges Sometime between Panels 67-68 it was decided to stop purchasing the ribbons that stick onto the registration badges. These ribbons have the registrants service position labeled. We are now running out and people are getting upset. It would cost approximately \$168. To purchase enough to last us for a couple of years. The Officer expenses have already been added to the budget for this. **I propose that we bring back these ribbons. It was 2nd.**

Discussion:

- No, it is a frivolous expense.
- It is really important for new GSR's to identify others.
- It is very important, as it makes it easy to identify others.
- Yes, it is important to newly elected GSR's. It looks professional.
- Name badge says I'm alcoholic. It maybe ego to some, but for me, it identifies you.

Sense of the Assembly: Do you want us to bring back the Ribbons? **Yes 65/No 1** Majority to bring back the ribbons rules.

What's on your mind

Alternate Area Secretary requests an ad-hoc committee Lisa, alcoholic. I would like to see a new committee to look into separating the Area Alternate Secretary duties from the Area Assembly literature chair. I would like to see a proposal to create a Literature Standing Committee or combine the literature with Grapevine. Literature needs to be on hand, and a Standing Committee should be available to educate on Literature. I don't think the Literature gets the appropriate attention to have a Literature Chair only have literature at the Area Assemblies. With the point of an Alternate possibly needing to step into the Area Secretary position, the literature may fall through the cracks. Minority Outreach Robert, alcoholic. When you see some minority come into your group, please talk to them about service. Let them know they can be of service in the Group, District, and Area. I don't see enough representation from minority. That concerns me. When I was asked to participate it helped.

Voting Members, The Translation Committee Chair and the Finance Committee gets funded to the Area Assemblies. They are the only two people at the Area Assemblies without a vote.

Discussion:

- Under membership 2.1 of the Area 42 Guidelines it states that all Chairs are voting members.
 - The Guidelines Change ad-hoc committee responded with “we were not tasked to look at that section.
 - We can have it changed if we want to.
 - These committees were set up to support the Assembly. They are a Service Provider, see 6.1 of the Area 42 Guidelines. Should they be provided a vote?
 - This should be addressed as a Guideline change. Should have more than one person look at it.
- Area Chair, Paul suggests to get a hold of him or Claudia to hash out a Guideline change.
