With all the changes happening in the world and in Area 42, now might be a good time to head towards the best direction with regards to the Area Secretary's duties. In the meantime, please know that I enjoy being of service to all of you. You are my greatest teachers.

I'm presently serving as your Panel 71 Delegate. On a personal note, let me thank all of you who have reached out over the last few months to check on, support and listen to Lyle and me. We landed in the Reno/Sparks area twice during our 28 days of evacuation. I appreciated every opportunity to do service — it gave me a purpose and distracted me from the fire. I know many of you didn't want to bother me, but I wanted to be bothered. Most, not all, distractions have been a reprieve.

Our home is safe yet is forever changed by the Dixie fire, but we are resilient. Some of the members of my district lost everything, others were merely strangled by the thick never ceasing smoke and the constant screeching of evacuation alarms. We were all affected. Those of you in the nearby districts were also impacted by the Dixie fire and now some are directly impacted by the Caldor fire. It has been a rough summer for many of us in the Northern part of Area 42. My heart hurts for those of you who lost homes, lost communities, lost nearby beauty, were evacuated for sometimes extremely long periods, were impacted by poor air quality, had health issues, lost your sense of safety and normalcy, and suffered emotionally or spiritually or financially. I have witnessed love and unity within the fellowship of Alcoholics Anonymous. I know many of us feel raw and edgy, but we are also extraordinarily vulnerable. Within vulnerability grows love and compassion. [Visual references are to PowerPoint slides shown at the Assembly.] This is an old photo of my daily walk in the woods near our home. This is what it looked like during April when I attended the week-long Conference from home. We have taken all of our dogs here, where they chased squirrels, deer, coyotes and swam after sticks and geese. It will always be a very special place in our hearts. The Dixie Fire began July 13th and has burned 910,000 acres. It is 57% contained. We may well live under its threat until the snow flies. On August 4th, we lost much of the town of Greenville and on August 5th, we lost the community of Canyon Dam. The fire burned 115,000 acres including coming into our neighborhood and burning close to ¼ mile from our home. It makes no sense why more homes weren't burnt except for the outstanding work of the firefighters, loggers, and luck of the draw. We spent 28 days evacuated and have been home now for three weeks. The last few years have been devastating for the communities in Northeast California. My heart is broken for the communities within District 20 and District 6 who have suffered so much from the fires this

year, as well as in recent years. On behalf of those of us impacted by the fires, thank you to Area 42 for all your love and support during this trying time. Okay, now onto the delegate's report. I already presented the results of the Conference at the May SAGSC and June NAGSC meetings. I know some of you were not there and this is our first full assembly with the entire Area. In your packets is a 71st SC (General Service Conference) Quick Reference. It is also available on our webpage under the Delegate's Corner. I am going to go over the highlights of the Conference and then open it up for discussion. In the Summer Newsletter and a follow up email, I asked for you to bring your group's voice to the assembly. After I have done a short overview, Lisa will facilitate the discussion. I will answer any questions that I can and make notes of how Area 42 feels.

This is where I spent 8 days as part of the 71st General Service Conference. Even though I printed out most everything I received from the Conference Coordinator, creating 5 large binders including tabs and indexes, it was quite challenging trying to stay up.

This is a collage from all the photos that Conference members sent to be included in the final conference report. This is the virtual equivalent of the empty rooms shown when we actually meet in person. While three of my photos made the collage, none were selected for the final report.

- ACCESSIBILITIES: a new Remote Communities Service web page will be available soon
- CONFERENCE (Policy & Admissions): New Deadline for submitting proposed agenda items is Wednesday, Sept 15th.
- CPC (Cooperation with the Professional Community): Due to the pandemic GSO has not participated in live or virtual exhibits
 - CLASS A Trustee spoke at CPC Virtual Workshop
- CORRECTIONS: Implemented new Corrections Correspondence Service (CCS) Matching Application to launch in Sept 2021
- GROUP SERVICES: Working with OIAA (Online Intergroup of AA) to help implement the listing of online groups.
- INTERNATIONAL: First pan-transcontinental North/South Connections Forum was held in May.
- LITERATURE: Staff followed up on 21 proposed agenda item submissions from the actions of the 71^{st t} GSC (General Service Conference)

- NOMINATING: Work has begun to fill upcoming vacancies for Class A (nonalcoholic) trustees: Pacific and Eastern Canada regional trustees; nontrustee director and/or general service trustee. Staff are using LinkedIn for applicants for Class A Trustee positions.
- PI (Public Information): 3 press releases were distributed using Cision PR Newswire and for the first time some news outlets including the Associated Press and Yahoo Finance shared memos with the public.
- REGIONAL FORUM: staff is preparing for the virtual Special Forum in December 2021
- TREATMENT: Attended National Institute on Alcohol Abuse and Alcoholism (NIAAA) Virtual Roundtable

A.A. World Services Management News

- We have a new general manager, Bob Wilcox. Some of you may remember him as our U.S. Trustee-at-Large from 2013-2017. He was our Saturday night speaker when we hosted PRAASA in Reno in 2018.
- Linda C. is our new General Service Board Chair. She was previously on the board as a Class A (nonalcoholic) Trustee from 1997 – 2002. Trained as a lawyer, Linda spent 22 years serving as a judge, beginning as the first female Circuit Court judge in Indiana followed by a decade on the Indiana Court of Appeals.
- Voluntary return to work began in the office on a limited basis in May. The full return to the workplace, with some eligibility to work from home, is set to begin on October 1, 2021.
- Covid Protocols are causing delays in publishing.
- Chris C. is the new publisher of A.A. Grapevine and La Viña

Fun with delegate socks!

Some financial highlights from the July General Service Board meeting:

For A.A. World Services, we are using the actual figures through the first half of the year compared to a full year budget. And then against the same first half of the year in 2020. Blue is the full year budget; green are the figures through 6/30/2021; and yellow is last year through June 30th.

Contributions were in line with budget. We budgeted \$9,725,000 for the full year and have received nearly \$5 million or 51%. Gross literature sales are significantly higher than anticipated. We initially budgeted \$8,865,00 for the full year and have sold \$5,736,000 or 65%. And our surplus was budgeted at \$641,000, but

due to reduced costs and increased sales, it is at 223% of the budget for \$1,430,000. In all categories we are doing better than last year.

For AA Grapevine and La Viña, all of the numbers reflect activity through May 31st. Yellow is the budget; orange is the current year; and green is last year. All are through the first five months of the year.

Circulation is 68,645 or 102% of budget. Total Income is \$934,409 or 153% of budget. Net Income is \$268,981 of a budgeted loss of \$(99,725) or 270% better than budgeted.

For *La Viña*, circulation is also 102% of budget or 5,821. Net Income is down and reflects only 44% of budget or \$5,032. And Net Income is 114% worse than budgeted or \$(66,965). Most subscriptions are purchased at in-person events and those events are still down due to the pandemic.

All the Pacific Region delegates received a pair of "Don't Panic" socks from Thad, Area 18.

Once again, I want to thank all the groups for your contributions. Even though it looks like the contributions came in from individuals, we know that many of those contributions were made in lieu of putting money into the virtual basket. So, even if you didn't associate your group with your contribution, we all know it came from members. We know that when Alcoholics Anonymous needed you, you were there. Thank you so much for helping us keep afloat in such uncertain times.

The estimated cost for services per member for 2020 was \$7.34. If everyone contributed \$7.34 to the General Service Office, we would be completely self-supporting without.

During 2020 we used our Reserve Fund to pay our bills.

Why did we need \$4 million from the Reserve Fund?

- The simplest answer is that we had many items which required cash and there was not enough cash on hand.
- The longer answer is that literature sales were down significantly at a time when there was a need for cash to meet our obligations.
- At year end, gross profit from literature sales was \$6.6 M, 33% less than a budget of \$9.8M and 30% less than 2019 gross profit of \$9.4 M.
- In July 2021 the Board voted to deposit \$250,000 back into the Reserve

Reserve Fund stands at 8.4 months of operations.

What is really going on with the reserve? I reached out to the new Board Treasurer, Kevin Prior because I wasn't clear on why we needed so much from the reserves. The initial reserve draw was required to immediately refund the

registration fees for the International Convention after cancellation was announced.

The insurance settlement certainly helped reduce our ultimate financial exposure; however, with a last-minute cancellation some expenses had already been paid and some deposits were non-refundable. Even with the settlement, the convention netted a loss of \$210,000 versus a budgeted surplus of \$65,000. Cash that would have otherwise been available to replenish the reserve was also needed to complete the ERP (enterprise resource planning – which means an integrated system) implementation, to finish the 8th floor renovation and to fund greater-than-expected participation in the Voluntary Retirement Incentive Program.

On the revenue side, Seventh Tradition contributions were much greater than budget, AAWS literature sales decreased significantly during the pandemic, resulting in an overall AAWS revenue shortfall of \$2.1 million.

Decreased sales of Grapevine literature caused *Grapevine* (excluding general fund support for *La Viña*) to experience a loss of \$299k versus a break-even budget. In summary, there were so many headwinds that occurred throughout 2020 that funds to rebuild the reserve were not available.

During the Conference we participated in two-hour breakout workshops.

- If we were 10 times bolder... How would we inform and communicate with others about A.A.?
- If we were 10 times bolder... How would we involve and call all A.A. members to action and service?
- If we were 10 times bolder... How would we inspire and attract potential A.A. members and others in need of our life-saving message?

WHAT CAN HAPPEN IF WE ASK THESE QUESTIONS?

Our very own Marita R, from Mesquite is the new U.S. Trustee-at-Large. She will be popping in from time to time this weekend when she can. She is part of the Virtual West Central Regional Forum that is happening right now. She has a 4-year commitment. As US TAL, Marita sits on the General Service Board as one of 21 trustees. We have 14 class B (boozers) and 7 class A (amateurs). She is one of two at-large trustees; one from here and the other from Canada. I am extremely grateful that I am able to serve for 20 months with Marita. Her term began in May 2021.

This is your Pacific Region

Our workload this year was huge. We ended up with nearly 1800 pages of background. We passed 79 advisory actions and the committees recommended

89 Committee Considerations. On the next few slides, I have summarized the advisory actions that we passed at the 71st General Service Conference in April. The General Service Board met during the last weekend in July and, where possible, I will provide you with a current update of what the trustee's committees, GSO or A.A. Grapevine are working on. The Delegates meet once a year for a week, but the Conference goes on all year long.

THE DELEGATE & THE CONFERENCE

- Area delegates make up at least two-thirds of the Conference body. The other members that make up the General Service Conference are 21 trustees, both nonalcoholic (Class A) and alcoholic (Class B); directors of A.A. World Services & Grapevine; A.A. staff at G.S.O., *Grapevine* and *La Viña*, which brings the total number of Conference members to approximately 135.
- At the annual Conference, matters of importance to A.A. as a whole are considered and discussed. Items approved by a 2/3 majority of Conference members become *Conference Advisory Actions*; they are referred to the trustees of the General Service Board for disposition.
- After the Conference meeting: Each delegate reports back to their Area on Conference proceedings, the approved *Conference Advisory Actions*, and additional committee considerations. Each GSR, having had the opportunity to hear from and ask questions of their delegate, is responsible for informing their group on the Conference outcome.

CORRECTIONS

• Revisions to A.A.W.S. literature directed to members behind the walls and replace the terms "inmate" and "offender" with "person in custody".

Updated corrections materials will be on a rolling schedule, as revisions are completed.

Ongoing communications and planning with book distributor and associates; met with Corrections tablet sales reps to discuss additional intellectual property and artwork needed; met with Corrections Services of Canada to pitch tablet content, books, and Carry the Message project.

I'm not sure who pays for the tablets or if or when they may be used in Nevada and California.

Corrections Correspondence Service Database: A demo of the new Corrections Correspondence Service database was provided to the committee. Scheduled to launch in September 2021, the new, state of the art digital application will enable matching of persons in custody to members on the outside with speed and efficacy.

FINANCE

- 1. Add "SAMPLE" watermark to the 2nd and 3rd pie charts in, "Self-Support: Where Money and Spirituality Mix."
- 2. Changes to "Self-Support: Where Money and Spirituality Mix"

- Add between the pie chart examples and the question, "Where should I send contributions?"
 - Duties of the entities notated above are described on page 7 of this pamphlet. Performance of these service duties vary from area to area.
 Please be sure to inquire which services these entities provide in YOUR area and contribute accordingly.

I love that we are trying to clarify for groups that they should find out who is providing the services that they want to support with their 7th Tradition. This makes it very clear that there is not a right or wrong way to deliver the services, but rather that groups have the right and responsibility to determine where they want their contributions to go. The power of the purse. The new updated pamphlet "Self-Support: Where Money and Spirituality Mix," will be forthcoming. *GRAPEVINE* & *LA VIÑA*

- The first sentence of the A.A. Preamble to be revised with gender-neutral language by replacing the words "men and women" with the word "people". Our Instagram accounts for both *Grapevine* and *La Viña* were launched on July 7^{th,} and each edition continues to grow in engagement and content. One of the Pacific region delegates asked that Kathi pass onto *Grapevine* that we need to be posting more diverse photos. The *Grapevine* office filed for the Copyright of the new Preamble (English and Spanish). Revised A.A. Preamble items in placards, parchments, and pamphlets will be released on a rolling schedule, pending reprints.

- 1. Acceptance of the "A.A.W.S. Policy on Conversion of Written Conferenceapproved Literature and Service Material into Video Format".
- 2. That a Fifth Edition of the *Big Book, Alcoholics Anonymous* be developed.
- 3. That the Fifth Edition include a new foreword, an updated preface, and updates to Appendices III and V.
- 4. In the *Twelve Steps and Twelve Traditions*, replace the phrase "opposite sex" with the word "partner".

POLICY & ADMISSIONS

- Make use of virtual meeting technologies to develop a process for polling the General Service Conference between annual meetings.
- The Equitable Distribution of Workload Process be implemented for the 72nd General Service Conference on a three-year trial basis.
- Recognize online groups and encourage their participation, listing those groups who ask to be listed within the group's preferred district and area.
- The General Service Board form a committee to explore future possibilities for the participation of online groups in the U.S./Canada General Service structure.

We will decide this weekend if we want to submit an agenda item and will need to get it in by Sep 15th to the Conference Coordinator. This is the new deadline created so that the trustees and staff will have enough time to use the new scoring tool to attempt to create an equitable workload for all the committees. If you belong to an online group, you can list your group with Paul, our area Registrar. For now, we ask that you associate your group with a district of your choice. We may at some time create an online district within Area 42. Or possibly an online area. We are still in discussions.

PUBLIC INFORMATION

- 1. The video PSA "Party" (working title) was approved with minor revisions.
- 2. The video PSA "Wall" (working title) was approved with minor revisions.
- 3. One to two PSAs be centrally distributed to broadcast media.
- 4. A feasibility study on paid placement of PSA videos on streaming platforms including, but not limited to, Netflix, Hulu, and YouTube.
- 5. Podcasts providing sharing within the Fellowship and information about A.A. to the public be produced.

- 6. Revise the pamphlet "Speaking at Non-A.A. Meetings" to reflect a more diverse public.

Also, they are reviewing the 2021 PI committee consideration that a PowerPoint presentation be developed for PI and CPC committees for the purpose of providing shared experience on "how to" present A.A. at non-A.A. events.

- Approval of the new 2021-2023 Edition of *The A.A. Service Manual combined* with Twelve Concepts for World Service.

This edition has color and graphics, and it was determined that having this "medium" sized version would be the best fit for the Fellowship.

The delegate from San Diego, Area 8, suggested asking their newly formed but enthusiastic Armed Services Standing Committee.

"Bridging the Gap" pamphlet and service material: The trustee committee has received progress reports on both the pamphlet "Bridging the Gap" and on the service materials.

We are scheduled to meet in person in Brooklyn in April of 2022.

Thank you all for coming to the Fall assembly whether virtually or in-person. I am so very grateful to be given the opportunity to serve Alcoholics Anonymous. I can never repay what was so freely given to me, but if I can continue to help the still suffering alcoholic and continue to grow in effectiveness in carrying the message

then I feel that I am fulfilling my purpose. This Conference was an incredible experience with the underlying urgency to reach suffering alcoholics. To make sure that our doors are open to all who seek us. I was taught that A.A. is not for people who need it, but for people who want it. I wish I could give the gift of willingness, but I can't. I never want the doors of Alcoholics Anonymous to be closed for those who are asking for help. Thank you for my sobriety and for my life.

Comments from the floor on Delegate's Report

Past Delegate Pete. He has a problem with the Preamble. Was it a floor action? Julie said four people proposed. Three combined to one so there were two. We ended up with two floor actions to change the Preamble. We were asked which one would they prefer? The Board was only making one change.

Hanlon asked how this can be explained. We had a very passionate conference. Wanted to make some changes so that everyone felt welcome in Alcoholics Anonymous.

Joyce asked about the 10 percent bolder concept. Julie said the Agenda Committee developed it. If we get too bold Joyce thinks we are promoting. Joanne said she is gender nonconforming. The binary language needs to go. We need to make these changes.

Larry from ZOOM. Group conscious yesterday was pretty upset that any literature was going to have any changes. Wondered if he can keep the Preamble the same? Julie: we have a preconference assembly where this was discussed. 133 trusted servants discussed it in NY. Nevada discussed much of this. Julie went with A42 voice. If the group doesn't like it, work on an Agenda item.

Rhonda past Delegate Panel 69. Changes in printed pamphlets will be implemented as necessary.

Robert J. noticed ongoing throughout AA was a shortage in diversity at the general service level. He's not seeing any diversity. Very little diversity at PRAASA. Julie thanked Robert for bringing that up. Noted that we are not doing a good job of representing all the diverse people in AA in general service. The majority of those who serve are a pale group of people. Sexual orientation representation was there. Julie challenged the assembly with a request that we all try to figure out how we become more inclusive.

Michael amplified that what was written seems to have worked for the past 80 years. Says language does matter.

Dano B.: Every group is autonomous. The Preamble change was not done behind our backs.

Julie C said some of the thinking behind the changes was that some of our literature was being banned at institutions because of our languages.

Elise asked about floor action. Wondered how the process actually works. Julie said it goes to the board after the conference recommendation. The board decided the conference indicated it preferred the third recommendation over the second. The second was dropped.

Greg clarified that the conference is not a legal body. The board has to approve the recommendation of the body.

Brooke comment: AA wants to always be all inclusive should always strive for this. Groups can decide which Preamble will be used.

Dan wanted to know is it really that big of a deal?

Greg asked about future changes to Bill's writings. Mentioned Concept 11. Julie: The need for literature to be available to those in institutions is going to be a driving factor.

Larry via ZOOM. Primary purpose we can change three or four words. Things don't change to keep up with the times. Things will matter if we continue to change.

Debbie make no mistake that all of this dialogue is extremely important. Ralph is concerned about how far change is going to go. Brought up anonymity, old fashioned needs to change with the times. He understands that while there is talk to become more inclusive he is worried about AA's singleness of purpose. Concerned about AA remaining AA.

Area 42 extends gratitude to all groups and individuals who continue to send contributions to our community basket, "where money and spirituality mix."

Our treasury remains healthy, and we are well positioned for a return to funding travel expenses as in person General Service events resume.

I worked with the Area Finance Committee in preparation of the budget we will present this weekend. This process has taken an interesting deviation as we attempt to consider how our new hybrid meetings will affect travel and technology expenses. More will be revealed.

While the 2020 Final Report from GSO reflected a concerning financial situation, the July quarterly report gave a better outlook. With the return of in person meetings and the gradual re-opening of treatment centers, literature sales have begun to rise again. It was the drop in book sales that had the most negative impact on the 2020 GSO budget which was partially countered by generous individual and group contributions. If your home groups are meeting face to face again, encourage them to check their literature inventories and re-supply through your Central Offices or directly through GSO.

Libby made a friendly motion to accept Guidelines change with amendment adding 'Area Alternate Chair' to 6.2 then adding 'per meeting' in 6.7. It was seconded. A show of hands in the room and on ZOOM indicated the motion was approved. Two no votes.

Alternate Delegate

Jake S.

My name is Jake I am alcoholic. It is my honor and my privilege to be serving as the Area 42 panel 71 alternate delegate. If you are here this week and you are new to General Service I really want to welcome you. I remember my first area assembly, it was confusing and chaotic, and I heard about 600 acronyms that I had no idea what they meant. CPC GSO PI DCM PCP EIEIO! When I found out that as a GSR that meant I had to spend a whole weekend sitting in the Tonopah Convention center with a bunch of AA nerds I was not happy at all to say the least. I cussed out my home group the whole drive up here. But when I got here I wasn't sitting in this room for more than a couple hours before I realized the people that were sitting in this room with me were doing more to help the alcoholic who still suffers than 99% of the people I had met in Alcoholics Anonymous up to that point. The people, who when anyone anywhere reached out for help, was trying to make sure the hand of AA was always there. To this day I am so grateful to that group for putting me into service in AA and that I found my way into general service in Alcoholics Anonymous. If you have heard me give a report before you know I always end by saying Alcoholics Anonymous saved my life and that general service has become a huge part of my program of recovery. That statement is truer today than it has ever been and I cannot tell you how much I have missed being here with you. As the alternate delegate my job is to pray for the health of the delegate of course, to be aware of the General Service

Conference Agenda items, and to be able to take Julie's place if she's not available for the general service conference. In other words, it is the easiest job in the history of Alcoholics Anonymous. And I just want to take a guick moment to say how grateful I am for our area delegate Julie. She has helped me and taught me so much in the first year of this rotation. I did not own my own computer at the start of this rotation. She has also personally been through so much this year and has never missed a beat with Alcoholics Anonymous and her service to our area. The kindness, love, and passion she has for AA I pray that I am able to pass that on. I am so grateful our area has been blessed with her as delegate. At the beginning of this rotation Julie also tasked me with running the Area Conference Committees. So, I don't have time to go through everything that means here but if you're not sure what that means then please come and see me I would love to tell you all about it. Concept 1 tells us that the final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship. And concept 2 says the General Service Conference of A.A. has become, for nearly every practical purpose, the active voice, and the effective conscience of our whole society in its world affairs. So, if you want something to happen in Alcoholics Anonymous, if you want to make a new pamphlet, or if you want to change the wording in a book, those things happen and are taken care of and voted on at the General Service Conference. Obviously we could not have a meeting and have every member of Alcoholics Anonymous attend it. So how we make decisions based on the collective conscience of our whole fellowship is every area elects a delegate to represent their area at the General Service Conference. So how the delegate for Area 42 finds out the collective conscience for all of our groups is through our area round tables and area assemblies. In Alcoholics Anonymous we like to say that we are based on an upside down triangle where the groups are the most important and all the decisions that we make come from our groups conscience, but if we do not have general service representatives representing these groups, coming to the Area Assemblies and roundtables, getting informed on the General Service Conference Agenda items, and bringing this information back to their group then it is not so. This is why in my opinion GSR is the most important job in general service. Every year the delegate receives a document that is usually around 1500 or so pages long with all of the background information for all of the items that are on the General Service Conference Agenda. Just like we can't have a meeting that every member of Alcoholics Anonymous attends in the same way we can't give every member a 1500-page document and say this is what we are going to be voting on

go figure it out. In Area 42 we ask members to take this information on these agenda items read the background information and do a summary into a few sentences what they are talking about. The way this process worked in Area 42 up until last year was we would send a sheet of paper around at the nags meetings and the sags meetings asking people to volunteer to summarize an agenda item, then they would get one or two to summarize. They would summarize their items send them back to the delegate and then a document would be created using these summaries. We never really had any rhyme or reason for who summarized what topics. So starting a few years ago when Rhonda was our delegate and Julie was the alternate delegate they had the idea to create area conference committees. These committees would mirror the General Service Conference and would be made up of the sags and nags standing committee chairs for each committee and anyone else who would volunteer to participate. Starting this year we also asked these area conference committees to summarize, as well as discuss, all their agenda items as a committee. So instead of randomly asking a list of people to summarize the agenda items now we had the grapevine chairs from the north and south summarizing and discussing the Grapevine agenda items with their area conference committee, same with the CPC committee with PI, finance, literature. In Area 42 we have 13 separate committees that summarized and discussed every item that was on the general service conference agenda. This whole process is new to our area so obviously we still have a lot to learn and we make plenty of mistakes. But I cannot tell you how grateful I am to the Area conference committee chairs and every member that was willing to participate in this process. We have obviously been in an unprecedented time with COVID-19 and all of the shut downs, but I absolutely believe our area is better informed. Also another important point in my opinion is if you are new to General Service today and you become a member of one of one these area conference committees by the end of the rotation you will understand how to summarize General Service Conference Agenda items and discuss them in a committee. This year you're a GSR and you sit on the Agenda committee next rotation you're a DCM and sit on the PI committee next rotation you are the grapevine chair and sit on the Grapevine committee next rotation you're the area treasurer and sit on the finance area conference committee. If we have this process as part of our area by the time somebody has been in service for 10 years and is lucky enough to serve as the Area 42 delegate there is no question in my mind that they will be more prepared to serve in that position. I could easily go on talking about everything I have learned and how grateful I am for our area but this report is

already way too long so I will just finish by saying if you are not currently a member of an Area Conference Committee and would like to be please see me or Julie this weekend. Our conference committee chairs would love to see you and can always use the help. Thank you all very much for being here this weekend. I am so grateful to be in beautiful downtown Tonopah Nevada again and to be with my people. Thank you very much to the standing committee chairs and the area officers for all of your hard work and dedication to Alcoholics Anonymous during this difficult time. And most of all thank you thank you very much to all of our GSRs and DCMs that keep our upside-down triangle upside down. I am currently serving as the Area 42 /SAGSC Archivist in the first year of a fouryear term.

Since the beginning of this year, I have been a regular attendee of the Pacific Region Archivist Monthly Zoom meeting and have enjoyed interacting and sharing information with Archivists from Japan, Washington, Alaska, and Southern California.

In March of this year Michelle Mirza, Archivist for GSO and her committee initiated the COVID 19 project that encompasses the collection and archiving of materials related to AA and the pandemic. The collection includes outward facing communications to the fellowship; communications from the Public Information desk in response to inquiries from reporters and news agencies; staff responses to members seeking guidance about online meetings, anonymity breaks and other issues. External sources include news articles in print, audio and video and our collection of these news related pieces continues to grow. We also collected shares and activities of groups, districts, and areas. The goal of initiating the COVID-19 project is to maintain a collection of first-hand accounts and other primary sources documenting the effects of the pandemic, how groups adapted,

problems encountered, and shared experiences of the AA membership. GSO has initiated a new project of digitizing photographs and negatives and developed guidelines for scanning, file naming and cataloguing photos and negatives.

I have made inquiries into both the COVID-19 project and the guidelines for digitization for our Area 42 and have not heard back from GSO.

Archives had tables at Founders Day and District 1's workshop last month. An anonymous donor gifted Archives with two retail showcases for a permanent display in the meeting room at Las Vegas Central Office. Time permitting it is being cleaned and modified with locks to the showcase and has been used in lieu of a table.

Time permitting, the Archives committee met and focused on getting material transferred from decaying cardboard boxes to plastic bins with labels for content and dates of material. We collected over 400 cassette tapes, audio CD's and will research methods to preserve in digital format.

Archives has had a few requests for research information concerning groups, GSO suggestions for the General Service Conference, and group number original dates for groups. We tried to get answers by research and emails to GSO.

Should you wish to participate in the Archives committee please contact me. We will need help with moving and lifting boxes and creating labelled bins and the upcoming Las Vegas Round up at Thanksgiving.

Area 42 Website Guidelines change proposal: 2nd reading

The objective for this proposal: To add links to the Area website to register and pay for the registration and virtual Area 42, NAGSC & SAGSC service meeting information.

Background: Intent-Purpose: Last year 2020 for our Spring Pre-Conference Area 42 assembly many members pre-registered through an outside company. Then we had to shut down and not have our in-person meeting, which led to everyone needing a refund. This never happened through the company. As a result, the Area refunded everyone's registration with Area 42 funds. This was a loss for the Area. To prevent this from happening again, this proposal would allow Area 42

members to register and pay the Area directly. This would be similar to the way members register and pay for PRAASA and other A.A. events. Also, the proposal is to add links to virtual Area 42, NAGSC, & SAGSC service meeting information, to be kept in the password protected section of the website. This would allow easier access for our members to acquire this information. With the continued upswing in virtual service meetings this would be a great tool for the Area.

Q. How do inmates get ahold of the new proposed pamphlet?

A. The groups bring them in.

Q. Northern Central Office struggling with service positions, service work is falling through the cracks. How do we deal with this?

A. In the spirit of carrying the message be patient with them through the pandemic.

Q. What is an ad hoc committee and what isn't?

A. It is a committee set to a specific task and then it is dissolved once that is completed. Unless the area wants it to continue.

Q. How do we generate motivation for the GSRs to come to the assembly?

A. The assembly regulars need to engage them while they are here. Make the new people feel welcome, be helpful to them.

Q. What does LaVina committee stand for?

A. It's the Spanish speaking version of the *Grapevine*.

Q. How many different committee positions, should, could you have at once?

- A. As much as an individual can handle to save their life.
- Q. What are the three suggested requirements you should ask yourself about a service position before standing?
- A. Am I willing? Am I able? Am I qualified?
- Q. My district tried to follow the third legacy procedure during yesterday's vote. Besides trusting God and realizing everything is in the divine hands, how can we be better prepared to participate appropriately?
- A. The Service Manual has all the information on the voting procedure and how it works, voting members. Also remember that the third legacy procedure is spiritually significant in terms of the hat because it means that the body just can't decide on its own and that both candidates are so wonderful and perfect for the job. The hat puts it in God's hands.
- Q. What is the difference between 12 step work and 12 step work done by central office?
- A. Central office answers the phone, provides information on all the meetings in town. Intergroup PI, CPC, Corrections, Treatment they are boots on the ground. We take reports from all of them and inform our Delegate. At the GSC, the delegate brings that information there and then they discuss all that and bring it back to the groups.
- Q. I believe it's a dishonor to change Bill W.'s words, but if we can add to them why would we leave it as a group of men and women and add words to satisfy the gender neutral?
- A. Not sure it's a dishonor to change Bill's words, but we can change anything we want as long as we have a group conscious. With regards to the preamble, the delegate who answered believes we are being influenced by outside issues. Another delegate wanted to clarify that this issue came out of a young people's group in Florida. The proposition to change the preamble came from this group. They talked about it for two years.
- Q. I live in a very rural area and in the past I started a CPC PI committee outside the area committee and it worked very well. Do you have any thoughts?

 A. We become individual members of these committees, you become AA with regards to the service work. Why not include the district? Ask the others to be included.
- Q. I try to cooperate and develop a relationship with the native community near me. Does anyone have any advice?
- A. Go to the elders of the community of whatever nation you are with and they are very receptive. Help is available.
