DCM Coordinator-South John L.

I was appointed to complete the Area 42 - Panel 73 term for SAGSC DCM Coordinator prior to the fall assembly last year. For those of you who aren't aware of the duties of the DCM Coordinator, it is an appointed position, and according to the current guidelines, the duties are: *Provides a link between the Area, DCMs, and Delegate by:*

- Conducting meetings with SAGSC DCMs
- Coordinating multi-District events such as workshops, picnics, etc.
- Conducting Traditions and Concepts education
- Being available to the DCMs to answer questions, attend District meetings, etc.

As such, I am available to support SAGSC DCMs in any way necessary. I have come to believe that the areas of greatest potential impact involve multi-District events, workshops, and other activities. Some of my activities prior to the Fall Assembly are noted in my report in the minutes from that event. Since that time, the DCM's in the southern region have been regularly participating in joint meetings that provide a forum for shared experience as well as opportunities for coordination and collaboration. We traditionally have come together during SAGSC meetings and area assemblies and are now having quick virtual check-ins during off months – except for March as I was out of the country on my honeymoon. The Districts have begun participating in multi-District events that have been successful and are planning for future events together. They are also sharing experiences related to encouraging groups to elect active GSRs and are seeing some success. In addition, we have been actively partnering with District 21 to broaden Spanishspeaking participation. Maybe most importantly, District trusted servants are forming relationships beyond the DCMS that are helpful, increasing efficiency, and, in many cases, providing knowledge and resources that were needed but were lacking. This collaboration opens up access to the considerable shared experience for all which improves their ability to effectively scale their efforts. When we kicked off our initiative at the Service Festival last October, we saw a SAGSC-wide event generate significant results and a foundation was laid that has proven to provide opportunities for other multi-District events that have increased overall participation and visibility to important opportunities for service and education. We are already seeing a range of innovative activities being planned as the year progresses. This shared experience is beginning to improve the effectiveness of activities in individual Districts as we discuss topics and strategies for improving group GSR participation as well as any areas that are challenges to their groups. We are very early in this process of improving our communications. A WhatsApp group and a Google Drive have been set up for sharing documents and flyers. This is an appointed position but the more people who are involved, the more that will understand how to best support the Districts in SAGSC going forward. So, anyone interested in getting involved is welcome to reach out to help support events and outreach across the Districts. Of course, there is never one size that fits all. Some of our Districts are very remote, widespread, or small, and it is difficult for them to broadly participate in some multi-District activities and to scale their outreach efforts. There have been discussions related to their need for support in providing education and other services to their Districts notwithstanding that there is frequently a lack of resources in smaller or fragmented Districts. However, as our recovery is a reflection of years of shared experience, the DCM's shared experience is proving to be useful to all. There are so many passionate and hardworking people to thank for this progress. From the DCMs, their alternates and chairs, such as workshop and outreach, to others in the service structure including the translation and Grapevine teams, LVYPAA and NACYPAA, we are coming together to improve the unity of the Southern Area. The significant contribution you all are making is greatly appreciated. I have really enjoyed attending the District meetings and events. I am confident that collectively we are enhancing the ability to serve the South in Area 42 through building connections that last while encouraging more people to make meaningful contributions to general service and AA as a whole.

CPC South. Chris H.

Greetings everyone, from Chris H, S Area 42 C.P.C. chair.

For those who may not be familiar with C.P.C., here is a brief overview.

C.P.C. is an acronym for Cooperation With The Professional Community. C.P.C. came into being as a distinct entity in 1970 when the trustees' committee was formed as an outgrowth of the Public Information Committee. In 1971, the Conference C.P.C. Committee was established. C.P.C. is an outward-facing committee, it does not focus its service efforts inward to the fellowship, contrary to most other A.A. committees. In fact, C.P.C.'s inward efforts are focused on keeping the fellowship aware of our efforts and accomplishments outside of the fellowship. In simple terms, consider C.P.C. as the megaphone of all things A.A. to professionals outside of the fellowship who work in a vast array of fields. Nearly all professionals we meet have at least basic knowledge of A.A. They know that we conduct meetings where alcoholics who want to get sober and stay sober meet. Most know that we have a text book, our "The Big Book". Most know we "work Twelve Steps." Consequently, C.P.C. focuses on communicating to the professionals information about the resources A.A. has, resources that the professional doesn't have yet may be useful to them as they engage with alcoholics and problem drinkers in their daily work lives. In this vein, the following is a summary of the recent accomplishments of S Area 42;s C.P.C. efforts:

- 1) C.P.C.held our second annual Forum For Sober Communities on March 14, 2024. This Forum facilitates an opportunity for members of the fellowship and professionals from outside to cooperatively discuss at length the disease of alcoholism. This year's topic was Obstacles To Sobriety. I want to personally thank the many members of the fellowship who stepped up to the plate and volunteered to collectively make this event a great success!
- 2) Saturday March 9, 2024, I conducted a presentation to A.A.'s National PI & CPC Working Group. My presentation highlighted the approach we take to reach out to Professionals and the successes we've realized, most notably, the cooperative relationship we developed with the Nevada Army National Guard. SArea 42 conducted 2 presentations so far and on March 10, 2024, Terri M, the CPC chair for the north, conducted the first presentation to the Guard in the Reno area.

The Corrections Area Conference Committee was small but we were able to summarize our items with a vast amount of fun about it. Treatment Facilities/ Bridging the Gap North. Anna L.

My name is Anna, I am an alcoholic and your current NAGSC Treatment and Bridging the Gap Committee Chair. The committee has been having regular monthly meetings since December with an average of 6 attendees. The format of our meetings is to give each district and NNIG an opportunity to report on meetings and Bridging the Gap presentations that are being taken into treatment facilities and institutions in their areas. Our meetings are also intended to help and support districts without active committees and create an environment where they can learn from the other district committee chairs. Here's what's happening in the Northern Area: Reno districts 2 and 4 have AA meetings going into several treatment centers anywhere from once a week to daily, mostly through the NNIG Treatment Committee. The NNIG Bridging the Gap Committee is taking presentations into one treatment center twice amonth, and recently began taking presentations into the Lyon County Jail. They also distribute a business card and flyer with a QR code that enables people who are being released from treatment to request a temporary contact in their home town. District 6 also has regular AA meetings and Bridging the Gap presentations going into multiple treatment centers in the Carson City area. District 8 has panels that go into a DUI class once a month, and a panel that goes into an outpatient rehab monthly. District 12 has a regular Bridging the Gap presentation going into New Frontier in Fallon, and patients in New Frontier are allowed to go out of the facility to attend AA meetings. District 20 has a new H & I Committee Chair and recently began taking weekly men's meetings into Crossroads in Susanville. District 22 was contacted by an inmate in High Desert State Prison in Susanville, CA who requested information on starting a meeting in Spanish inside the prison. The districtsent the inmate literature and a package with information on how to run the meeting. The NAGSC Treatment & Bridging the Gap Committee and NNIG Bridging the Gap Committee are working together on scheduling mini workshops in Districts 10B, 14, and 20. We are also working on creating a business card (with help from the NNIG Bridging the Gap Committee Chair) with a QR code that will connect people who are being released from treatment with the meeting app and enable them to request a temporary contact in their home town. If you are interested in participating in taking AA meetings or Bridging the Gap presentations into treatment facilities or would like to be added to the temporary contact list to assist a newcomer to their first AA meeting, please see me any time this weekend! Lyle reads the ANONYMITY STATEMENT:

There may be some here who are not familiar with our Tradition of personal anonymity at the public level:

"Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and films."

Thus, we respectfully ask that AA speakers and AA members not be photographed, videotaped, or identified by full name on recordings and in published or broadcast reports of our meetings, including those reports on new media technologies such as the internet. The assurance of anonymity is essential in our efforts to help other problem drinkers who may wish to share our recovery program with us. And our Tradition of anonymity reminds us that "AA principles come before personalities."

A further note about anonymity: out of respect for others, please do not take photographs during any of the meetings at the assembly. Also, be considerate when taking photographs around the conference venue. Take care that you do not capture images of AA members, family members and friends who did not give permission and who may not wish to appear in your pictures. Please do not post recognizable photos of identifiable members on web sites accessible to the public, including unrestricted pages on social networking sites.

Reader Matt K. GSR District 1:

CONCEPT I: The final responsibility and the ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

The first paragraph of the essay on concept one is: "The A.A. Groups today hold ultimate responsibility and final authority for our world services—those special elements of over-all service activity which make it possible for our Society to function as a whole. The groups assumed that responsibility at the St. Louis International Convention of 1955. There, on behalf of Dr. Bob, the Trustees and A.A. 's old-time leaders, I made the transfer of world service responsibility to our entire Fellowship."

The last paragraph of the essay on concept one is: "Therefore we believe that we see in our Fellowship a spiritualized society characterized by enough enlightenment, enough responsibility and enough love of man and of God to ensure that our democracy of world service will work under all conditions. We are confident that we can rely upon Tradition Two, our group conscience and its trusted servants. Hence it is with a sense of great security that we old-timers have now fully vested in A.A.'s General Service Conference the authority for giving shape—through the labors of its chosen Delegates, Trustees, and service workers—to the destiny that we trust God in His wisdom is holding in store for all of us."

Delegate Jake Report

Yo yo yo. Area 42. Here we go again!! My name is Jake - I'm an alcoholic. Grateful to be sober and extremely grateful to be here, once again, with my people, in beautiful downtown Tonopah Nevada, the sobriety capital of the universe. For the past 16 years I have been at every area 42 assembly we have ever had and I have never been more excited to be a part of area 42, and our amazing general service committee, than I am right now. We have done things already in this panel, we are going to do things here today that we have never been able to do before. Thank you all so much for being here this weekend! Thank you very much for helping keep Alcoholics Anonymous, our fellowship, connected through love, unity, and service.

Speaking of gratitude, at our fall election

assembly in 2022, I was elected to be the panel 73 delegate to the general service conference. I will never be able to put into words what that meant to me and how honored I am to have the opportunity to serve OUR area as the panel 73 delegate. At one of the very first AA meetings

that I ever went to, a woman there said Alcoholics Anonymous is the most important thing in my life. So, I of course thought, what a loser you are. Seriously, AA is the most important thing in your life. I have 2 kids, I have my parents, I have my career, I have my friends, I have my motorcycle. I mean AA is not even in the top 10 of the most important things in my life. I don't even particularly like it at all! And then in the same breath she said because if I don't have AA I won't have anything else. And once again, a member of AA, chipped away at my pride, and my ego, and my contempt prior to investigation and helped to save my life. And that is what we do here. We save lives! We keep one drink out of one drunk for one more day and it is the greatest miracle of my entire life. The longer I stay sober the more I realize what an absolute miracle it is that I ever became a member of this fellowship. I will never be able to figure out how I ever got 30 days sober. If I had a crystal ball at my first meeting, while I was sitting there judging and hating everyone. My face pops in and says oh no Jake you are totally wrong, this AA deal is great. You are going to spend the next 17 years working everyday for AA, for no money. You are going to use every vacation day you have for AA. That night I would have paid you to kick my ass. The person I was that night could not imagine a spiritual life and being rid of the bondage of self. The person I was that night would have had absolutely no interest in any of that. And once again look how wrong I would have been. Every single thing that's good in my life is because I became a member of this fellowship. But I absolutely do believe that the reason this fellowship still exists, and the reason it was still here and available to save my life when I got here, is because of the traditions of Alcoholics Anonymous. The large T traditions as well as the small T traditions of AA. Doing things the AA way means everything to me today. I am so grateful for all of the amazing members who came before us and kept our fellowship connected through love, unity, and service. I am so grateful for our founders and all of the simple wisdom that they have left for us. One of my favorite things about AA is that I do not have to stand up here and try to explain what it's like to be an absolute slave to alcohol. To have no choice if we are going to drink today or not. To have to do what alcohol says to do when it says to do it. To be beyond human aid. We know what this means. When I talk about the pitiful and incomprehensible demoralization of being an active alcoholic it feels like I'm talking about some distant past lifetime or that I'm talking about someone else. When I got here and everyone was smiling and laughing and hugging and sober I thought what the hell is wrong with you people. And I especially thought whatever it is that is wrong with you people is obviously not the same thing that is wrong with me. Thank God that I fell into a group that did things the AA way and believed in service in Alcoholics Anonymous. If that was not the case I'm sure I would not be here today, I would probably be dead. And because of this group, and because of people like the people in this room today, I have recovered from a seemingly hopeless state of mind and body. Now, today, it is our turn. The people sitting in this room today are the leaders of AA. In 1955, at the second International Convention in St. Louis we celebrated the Fellowship's 20th anniversary. The General Service Conference had proven its worth. And at this convention, on behalf of AA's old-timers, Bill turned the future care and custody of AA over to the Conference, the trustees, and the fellowship of Alcoholics Anonymous. At this moment, A.A. had come of age. And make no mistake that today this means us. 1955 may seem like a really long time ago to some people here today, but I am here today to say that it was not. I'm also here to say that A.A. unity cannot automatically preserve itself. Just like personal recovery, we shall always

have to work to maintain it. And here too, we surely need honesty, humility, open-mindedness, unselfishness, and, above all, vigilance. So long as the ties which bind us together prove far stronger than those forces which would divide us if they could, all will be well. We shall be secure as a movement; our essential unity will remain a certainty. Unity is so vital to us that we cannot risk those attitudes and practices which have sometimes demoralized other forms of human society. This may be the dubious luxury of normal people, but we cannot risk it. Thus far we of AA have succeeded because we have been different. May we always continue to be so! May we never forget that without permanent unity we can offer little lasting relief to those thousands, to those millions, yet to join us in their quest for freedom. We owe this to all of those amazing people who came before us. Those that kept this fellowship connected through love, unity and service. Nobody invented Alcoholics Anonymous. It grew like a flower. Trial and error has produced our experience. Little by little we have been adopting the lessons of that experience, first as policy and then as tradition. That process still goes on today in 2024 and we hope it never stops. Should we ever harden too much, the letter might crush the spirit. We could victimize ourselves by petty rules and prohibitions, we could imagine that we had said the last word. We might even be asking alcoholics to accept our rigid ideas or stay away. May we never stifle progress like that! Yet the lessons of our experience count for a great deal. We now have had 89 years with the problem of living and working together. And if we can succeed in this adventure, and keep succeeding, then and only then, will our future be secure. Since alcohol holds us in bondage no more, and we have been saved from an alcoholic death, our most challenging concern has become the future of Alcoholics Anonymous. How do we preserve among us such a powerful unity that neither weakness of persons nor the strain and strife of these troubled times that we now live in can harm our common cause. We know that Alcoholics Anonymous must continue to live. Else, save few exceptions, we and our brother and sister alcoholics throughout the world will surely resume the hopeless journey into oblivion. Terribly relevant is the problem of our basic structure and our attitude toward ever pressing questions of leadership, money, and authority. Here today we are going to talk about a bunch of different items that will be on the agenda of the 74th general service conference. The future of Alcoholics Anonymous may well depend on how we feel and act about these things that can be controversial. Our final destiny will almost surely hang upon what we presently decide to do with danger fraught issues! We are never all going to agree about what we should do or how we should feel about these agenda items. That is not what unity means. Unity means that we all sit here and we all listen to what everyone has to say. We do not close our minds. We listen carefully, especially to the people we do not agree with. We assure that throughout our whole structure the minority opinion is always heard and considered carefully. We turn everything over to our group conscience and a loving God, and when these decisions come, we accept that group conscience. We are the General Service Representatives. We are the link in the chain of communication for our groups with the General Service Conference and the world of A.A. We realize the ultimate authority is a loving God as he may express Himself in our Group Conscience. As trusted servants, our job is to bring information to our groups in order that they can reach an informed group conscience. In passing along this group conscience, we are helping to maintain the unity and strength so vital to our fellowship. Let us, therefore, have the patience and tolerance to listen while others share, the courage to speak up when we have something to

share, and the wisdom to do what is right for our group and for A.A. as a whole. We are not all going to agree. But if we can do things the AA way. If we can always remember that every single person here today is here because they love Alcoholics Anonymous. That they are here because they want to do what is best for their group AA and as a whole. If we remember that no work we get done here, and that no decision we make here will ever be as important as how we treat and talk to each other while we are here! If we always remember that the decisions we make here are never as important as how we make those decisions. Then we can be good examples of how AA works and we can hold this fellowship together in unity for 100 more years. That the child being born today destined for Alcoholism will have a place to go. We joke around a lot here, we are not a glum lot. We have a lot of fun here. But I always want to hold in my heart that what we do here is life and death. What we do here is deadly serious. This precious life saving gift of Alcoholics Anonymous has been handed down to us by our founders and now it is our responsibility to keep this fellowship connected through love, unity and service. Alcoholics Anonymous saved my life and general service has become a huge part of my program of recovery. Thank you all very much for being here this weekend. Thank you very much for your service to Alcoholics Anonymous as a whole. I love you all.

- o **GSO Staff** For the year ending 2023, our department responded to **165,420** emails and **1,677** phone calls. To put this into perspective, there are 2,080 work hours in a year for a traditional 8-hour workday (52 weeks which does not consider vacation time; and of course, rarely do we work 8-hour days). If you divide 165,240 by 11 (the number of staff members last year), it averages **15,000** emails per staff member. Emails from the Fellowship often require responsive sharing that is nuanced and in which "standardized" templates will not suffice.
- We also welcomed 1,470 visitors and 12 large groups (20 or more members) to GSO in 2023. We have already welcomed 2 large groups in January and have ten more groups booked through June.
- Member Services Received and responded to 27,475 unique email inquiries.
 A total of 13,808 phone calls; 5,857 were routed from the Front Desk and 7,951 were direct calls to Member Services.
- The Front Desk associate received and routed 12,045 phone calls in 2023. The Member Services team executed 7,410 (or 46%) District/Area/Group updates in NetSuite. During this same time, Area Registrars performed 8,852 District/Area/Group updates via Fellowship Connection. The team reviewed and processed 31,168 literature orders in 2023.

III. Correction D. Bigg J.

Consider a request to develop a pamphlet on the transgender alcoholic in A.A.* This proposal was discussed at Queer Femmes: a group in Oakland, and then forwarded to the District, where discussion occurred for the better part of 2018 and passed the District with substantial unanimity. At the suggestion of the Area Chair, members of District 07 waited to present this motion to the Area until the revised pamphlet for the LGBTQ alcoholic (published in 2018) was available for their review. After the pamphlet was published, members of the District strongly felt that there was still a need for a separate pamphlet. The motion was then presented at our Pre-Conference Assembly in California Northern Coastal Area 06 in April 2019. The Area had fruitful discussions over the course of the next two years at four separate assemblies. Because of the pandemic, the discussion stretched over two years. The motion passed with substantial unanimity in April 2021; There was no motion to reconsider after the minority opinion. The Delegate at the time submitted a proposed agenda item, at which point the Trustee's Literature committee discussed the proposed agenda item and took no action. The committee agreed that due to the overwhelming number of pamphlets currently in development or in revision, as well as the

projects carried over from the 70th and 71st General Service Conferences, new pamphlet requests cannot be addressed at this time. The trustees' Literature Committee invited the submitter to consider resubmitting in the future for consideration. The proposal was submitted again last year, again resulting in no action. The Area Grapevine/Literature/La Vina sharing session discussed this proposal again this year and requested a sense of the room at our most recent assembly in August 2023 on whether to re-submit this proposal for a third time, emphasizing the continuing need for this pamphlet. The Area (6) voted again with substantial unanimity to submit this proposed agenda item. This will be different from the LGBTQ pamphlet.

Southern Area Roundtables Feedback. Libby G.

<u>Topic 1 – Grapevine and La Vina Item C – Heather – Discuss the cost effectiveness and sustainability of continuing to print La Vina.</u>

- Do we know the number of subscribers we need to be self-supporting? There is always talk about how we need more people to subscribe. (Heather) We were self-supporting in 2017 and then the pandemic hit, we now have a 5 year plan to be independent of GSO money, 50% of the revenue is from Grapevine books and such, the new app may help generate more money.
- Are apps and such cost effective? (Heather) The numbers are just Grapevine and La Vina so don't know.
- There were losses in 2018 & Damp; 2019 are people not subscribing? Seems loss of money was pre-pandemic as well. (Heather) Losses were for La Vina.
- If we are only discussing printing as a loss we could decide to no longer have printed copies. (Heather) No plans to stop printing at this time. Expecting app to generate for Grapevine and La Vina, (Jonelle) feedback is it is not sustainable with continual losses.
- Need to be clear to groups we're talking about La Vina printing/editing/production costs, missing Grapevine statistics, digital shows sustainability & currently digital and part of the app.
- Wants La Vina to continue, talked to Quebec about how they manage their version La Vina (La Vigne), it is a smaller scale and more grassroots, our business model isn't working, maybe we can get some ideas from Quebec.
- There are lots of things involved in publishing for periodicals, after the pandemic materials costs went up a lot i.e. ink, equipment, etc., digital is the corporate way to save expenses, there is a cultural need for La Vina i.e. people who are unable to leave their homes for meetings, Suggest solution of every home group member gets a subscription
- Districts 21 and 22 have problems using computers, it would be a dis-service to force them to digital, Have to support Las Vina convention, get a subscription & support Las Vina convention.
- Principle Power of AA money strings if we're not satisfied then they will go away, all entities should be self-supporting, Grapevine sells various things to be self-support, the fellowship supports it or they die as a natural effect
- Are we printing more than we sell? (Heather) We always have past editions for sale, during pandemic only sold to subscribers
- Agreed with Tony and recommends supporting the La Vina convention

- Wants to confirm the numbers are just for La Vina
- Comment Topic has been around a long time, concern as to lay person who is not a finance person feels she doesn't have enough information to be informed, not apples to apples (Heather) Grapevine is printed 12 times a year, La Vina is printed 6 times a year, La Vina has reps, Supporting the Carrying the Message is a good way to be supportive, Grapevine literature Working Group describes the role of the Grapevine and La Vina is to educate people, info for hospital s and institutions
- 2001 Advisory Action to publish La Vine and that it be supported by GSO as a service to the fellowship, paid for through the General Fund (Heather) 2010 proposed self-supporting by 2017, then pandemic hit, now there is the 5 year plan
- Seems the item is not looking for solution in that case the answer is no however just because it is not coast effective doesn't mean it isn't important, Are there any statistics on does it help people get sober?
- Has La Vina experience for several years, The Spanish community is working hard to support La Vina, yearly convention is growing and sending subscriptions for La Vina, (Heather) La Vina conference was closed during COVID.
- Read La Vina the first time when incarcerated, first page caught him, attended PRAASA didn't understand, having problems with La Vina director & committee, confusion between La Vina and Grapevine and where the money is going, report is specific to La Vina, Solution donations
- 2013 goal pasted, question if the 5 year plan money will offset all loses including Grapevine (Heather) Get both printed and digital subscriptions and that will help both Grapevine and La Vina
- Where is the money coming from to cover the losses? (Heather) GSO; (Paula) Can we afford it? (Heather) That's why it needs to go to conference and raise prices, (Paula) is La Vina subscription going up? (Heather) went to editor and haven't heard that the La Vina price is going up, Grapevine is going from \$28 to \$36, (Paula) It's not just about profit La Vina has been around for 28 years we can figure out solutions
- Grapevine can't accept contributions must live off sales, altogether La Vina and Grapevine losses are over \$2 million, GSO uses 7 th tradition contributions to pay for it, treat losses as service, need to look at the articles of incorporation for solutions (Heather) Recommend Carrying The Message subscriptions as way to support both

<u>Topic 2 - Literature Item K – Victor – Consider a request that the words "Donation" and "Contribution" be swapped under Warranty One in "The Twelve Concepts Illustrated" pamphlet.</u>

<u>Topic 3 – Policy/Admissions Item D – Janice – Review report of the GSB Ad-Hoc</u> <u>Committee on Participation of Online Groups in the U.S./Canada Service Structure.</u>

- PAI means Proposed Agneda Items which means it will be brought to the conference floor, Virtual AREA PAI what online groups belong to an Area? Each Area is autonomous, we don't need GSO's permission to join an Area.
- My home group is online, Do we want to still consider a pilot? (Janice) Yes. (Speaker) it's a good idea just need to consider the cost of the pilot.
- When groups register they have the option to register as online, we have online groups registered in our Area, virtual groups are very active, maybe even more than in person ones, some confusion because members are from all over, suggest a virtual area in each region, what about international people
- Virtual meetings have people from all over just like live meetings have people who up from out of town, in person meetings don't change for having visitors, (Janice) Where initiated = where registered
- She's a GSR for an online group, group went online with COVID, have 1 in person meeting and 2 virtual meetings, started with geographic region, have freedom to choose, helps elderly to attend virtual meetings, many benefits from anonymity not asked where we live in open/live meeting, regarding the survey who picked the groups? Don't think it was a good selection of groups.
- Group in Japan started an online group, the roots are not in the States, have virtual delegate, questions about costs involved
- Question if survey was only about zoom meetings and not other kinds of non-in-person meetings (Janice) Numbers are online, Janice will follow up to get answer
- Liked idea of virtual regions, suggester register in districts, maybe register in DIM districts that need support, help them, we get Int'l all the time, don't have to be in a regional area to participate
- Idea of geography and selection, maybe groups have different concerns than a specific region, members might not feel connected, pilot sounds intriguing
- Is there a place to call to get more information about virtual meetings? (Janice) The Meeting Guide, and other resources.
- Virtual participation existed before COVID, how did conference call groups do it? (Janice) So many more groups and many more looking for representation
- Has online meetings with other central offices, There is an online Intergroup

Regional forums proposal for Hospitality room: Phil W.

Hi to everyone here and thank you Lyle for allowing us this time to talk to everyone. As you all know we will be hosting the Pacific regional forum this July 12 through the 14th. One thing I want to say before I even get started with the business part the forum is a little different than PRAASA. This is where the A.A. General Service Office comes out to our region and lets us know what is going on in A.A. in general all over the world. There will be lots of presentations. There will be lots of opportunities to talk to the folks who are doing our work at our office in New York. I want to reiterate that this is not just for general service people. This is for all members of Alcoholics Anonymous to be part of so please pass the word on to your groups and tell them we are hoping that they will be able to attend this informative get together. Registration will take place on aa.org starting May 13. There is a flyer available on aa.org and also on nevadaarea42.org I have a few things I need to talk about and the first of them is about financing. I have been talking to the two ladies at the General Service Office who will be putting together the program and have put together the hotel conference rooms, and breakout rooms, and everything else that our General Service Office finances. There are a couple things that are not financed by the office but are allowed to be dealt with by the hosting area. One of these is a hospitality room, I have asked our friend Michael Miller to be Area 42s liaison with the hotel, and I want to thank him very much for doing this. The hotel has given us a cut rate deal on a couple rooms which we have not procured yet as I was waiting for this assembly to ask you for financing. The first price that was quoted was \$1000 for a 600 square-foot room. A couple days later they got that together and Michale was able to get a discounted deal \$500 for a 600 squarefoot room for reference 20'x30'. This will include 2 tables, some 30" high round tables, and high chairs to go around the round tables, and water service . 2 rooms are available We are hoping to have a Area Archive display. Having the larger area would make it less crowded. I am asking for an OK to rent both rooms with costs not to exceed \$1500. I don't want to have any surprises. Michael has said there might be a little room for negotiation on costs or other things. We will be asking to have an Ice Cream sale after Sat evening speaker meeting and the hotel

stands to make \$ on that.

Lets vote on \$1500

Now the next thing on my agenda to talk about is translation radios. I understand that we have paid a lot of money for our translation radios and we try to keep them safe as possible so as not to have to replace them, Elaine has told me that the office actually has 50 translation radios available for the Pacific regional form and I kind of think that we might need more than that number I'm going to ask you if you feel it would be all right to use our radios that are compatible with the ones that they already have. If they need more than 50 this would save them from having to rent radios and I know that we're trying to help GSO save money, in these situations, I think our radios would be marked as area 42 and we will be the ones issuing out the radio so we would be able to keep track of them. Next I want to thank Rhonda W and Jay S.for all their work. They've been doing with the lists of volunteers who have said that they are willing and able to give an hour or two of their weekend to helping with this forum. We still would love to have more volunteers. Please talk to Rhonda and Jay. We need volunteers as greeters as registers as folks who will be setting up signs and helping setting up displays. We would like to have folks from our Service Committees Help at the displays of literature that is used by the committees to carry this message of hope to other still suffering alcoholics I am really hoping that our Nevada Area Young People in Alcoholics Anonymous are going to be Hosting the hospitality room with all their enthusiasm. I know we all love the enthusiasm that they bring to AA. One last thing and this is a special announcement because I haven't really said this enough We need people who are able to speak Spanish as greeters and also at the registration area and so I'm asking that we bring this up at our meetings and ask those who do speak Spanish if they would please let Carlos in the North or Roy Colon in the South know that they are available to do some translation over that weekend.

V. Grapevine and La Viña — Item D. Explore the services provided by AA Grapevine and how they should be funded.

Question: What is the trend of Grapevine subscriptions.

Answer: Going down like all print media

Question: If there is budget shortfall, how is it made up.

Answer: Anytime there is a shortfall of the Grapevine or La Vina is made up by the

General fund. There was a drawdown of the \$500,000 for the development of the app.

Question: If not charging for digital copies to correctional facilities what the plans are to

cover that:

Answer: The answer question is part of why this agenda item is being discussed.

Question: Do we want to think of the Grapevine as a service tool or as a for profit entity?

Answer: Grapevine and La Vĩna are important 12 step tools serving as a beacon of hope carrying the message of Alcoholics Anonymous.

Comment: Are the trustees protecting integrity of the primary purpose of the grapevine? And Why? One group views the Grapevine falling short representing the singleness of purpose.

Comment: Increase group involvement

Comment: There are only 67,000 subscriptions to the grapevine. At PRAASA that the Grapevine is not conference approved but conference endorsed because it isn't practical the board to approve every issue.

II. CPC — Item E. Consider a request to develop a pamphlet on the unhoused alcoholic in A.A.

Comment: The pamphlet not necessary since we are all alcoholics and too expensive.

Comment: The pamphlet and other pamphlets are not just good for the different communities, but it educates the membership how to approach the communities.

Comment: Are we creating so pamphlets are in danger breaking AA unity?

Comment: There are different situations of unhoused alcoholics.

Comment: We need of an inventory of all the pamphlets and determine which ones aren't cost affective.

<u>VIII. Public Information</u> — <u>Item N. Review results of A.A. Membership Survey</u> convenience sample pilot.

Question: was the 10,300 that were excluded from the survey of the 32,000 that took the survey?

Answer: Yes, they were of the 32,000 many were excluded because they didn't fill out all of the questions.

Comment: some Spanish do not fill out all of the questions because they may feel there could be consequences.

V. Grapevine and La Viña — Item E. Consider a request to develop a pamphlet on the Asian and Asian-American alcoholics in A.A.

Comment: our membership ought to include "All" that suffer from alcoholism, do we already have literature that is available? When someone comes in the rooms it is our duty to treat them all equally.

Question: It was stated that the Asian Big Book that the stories were not included, when the 5 th edition of the Big Book comes out will those stories be included in the Asian Big Book?

Answer: There are many General Service Offices (GSO) around the world and our GSO helps them translate the Big Book with their own translators. The stories are not translated from our English version; they have the ability to add stories for members of their particular language. Just like the Spanish edition does not have stories from the English edition but their own stories.

Comment: We say the first 164 pages but if you look carefully you would be excluding the preface, forwards, the doctor's opinion, and the appendices.

XIII. Int'l Conventions/Regional Forums — Item C. Discuss a report concerning virtual programming for the 2025 International Convention.

Comment: I think this is a great idea, wouldn't it be wonderful for those around the world to participate.

Guidelines Change Proposal: Translation Committee Guideline 1st Reading — Tony S

Reason for this proposal: The original Translation Committee guidelines were approved in spring, 2020, and need to be revised. This update more accurately reflects how the committee operates.

Black font = previously approved guidelines (Addendum 3, Area 42 Guidelines, 9/2022) Red font = changes proposed by the Translation Committee

I. Purpose

The Area 42 Translation Committee will be responsible for keeping open communications, written and oral, between the Spanish Linguistic Districts and Area 42.

- A. The Translation Committee will coordinate and facilitate translation (written) and interpretation (oral) services. It will provide consecutive and simultaneous Spanish/English interpretation at Area Assemblies and pre-conference roundtables;
- B. Depending on the availability of volunteer translators and/or interpreters and equipment, the Area 42 Translation Committee will:
 - 1. Provide, upon request, consecutive and simultaneous Spanish/English interpretation at:
 - a. Area Committee meetings;
 - b. Area Standing Committee meetings;
 - c. NAGSC and SAGSC meetings.
 - 2. Provide written translation of Area 42 Assembly minutes, conference agenda item summaries, the newsletter, updates to the website and such other documents, reports, minutes or emails as may be requested by the Delegate, Area 42 Secretary or NAGSC or SAGSC Secretaries in consultation with the Translation Committee;
 - 3. Provide written translation of Area 42 officers', SAGSC and NAGSC DCMs', committee chairs' and liaisons' reports;

II. Membership-Members and Meetings

The Translation Committee is to be a Committee which will consist of:

1. Chairperson

2. Alternate Chairperson

3. Committee members

- A. Composition and Terms of Service The Translation Committee will consist of a minimum of four members: three officers and at least one other member. The Chairperson and Alternate Chair must be bilingual English/Spanish and capable of interpreting and translating.
 - 1. The Chairperson will be appointed by the Area Chair.¹
 - 2. The Alternate Chair and Secretary will be elected from within the committee.
 - 3. Translation Committee officers serve a four-year rotation. Rotation is strongly encouraged.
 - 4. All Translation Committee members have one vote. In the case of an even number of committee members voting, the Chairperson does not vote.
 - 5. All are welcome to serve on the Translation Committee.
- B. Meetings The Translation Committee meets monthly. Meetings of the Translation Committee are open to all.

III. OFFICERS

A. Chairperson

- 1. Facilitates carrying out the purpose of the Translation Committee;
- 2. Attends and conducts the meetings of the Translation Committee;
- 3. Interprets at Area Assemblies and pre-conference roundtables;
- 4. Prepares and submits quarterly reports to NAGSC/SAGSC meetings;
- 5. Secures translation and interpretation resources for Area Assemblies and Area Committee Meetings;
- 6. Oversees the preparation of the annual Translation Committee budget and brings forward requests for budget revisions as needed;
- 7. Gives Translation Committee reports and presents motions at Area Assemblies;
- 8. Relays all requests for written translation to the volunteer translators. Note: the Translation Committee fulfills requests received from the Delegate, the Area Secretary and the NAGSC and SAGSC secretaries only;
- 9. Facilitates repair of equipment as needed;

10. Serves on the Area Communications Committee.

B. Alternate Chairperson

- 1. Attends and participates at Translation Committee meetings;
- 2. Conducts Translation Committee meetings in the absence of the Chairperson;
- 3. Interprets at Area Assemblies and pre-conference roundtables;
- 4. Schedules equipment use requests for Area events (Assemblies, Area Committee Meetings and pre-conference roundtables);
- 5. Sets up, tests, and oversees equipment operation at all Area Assemblies and, upon request, at Area Committee Meetings;
- 6. Works with interpreters at Area Assemblies and resolves any immediate needs that may come up during work time (e.g., people talking to them while they are working, where they will be set up, equipment problems etc.);
- 7. Inventories equipment after each assembly;

C. Secretary

- 1. Attends and participates at Translation Committee meetings;
- 2. Takes minutes of all Translation Committee meetings. Sends the minutes to the Translation Committee Chair and Translation Committee members prior to the next meeting;
- 3. Prepares Translation Committee agenda by communicating with Translation Committee Chair and other Translation Committee members prior to the Translation Committee meeting;
- 4. Gives the Area Archivist all Translation Committee meeting minutes at the end of the rotation;
- D. Depending upon the availability of equipment and interpreters, the Translation Committee Chairperson and Alt. Chairperson (or other bi-lingual person) should be present at all Area Assemblies and pre-conference roundtables to interpret. There must always be at least two interpreters present.

Responsibilities of the Translation Committee

The translation committee will be responsible for:

- C. Keeping open communications with Area 42 and the Spanish Linguistic Community.
- D. The translation of documents.
- E. Providing translators during Assemblies.
- F. Providing a budget for expenses; materials, translation equipment, printing and other expenses
- G. Conducting two or more meetings annually.
- H. Presenting a semi-annual report at Area Assemblies.

IV. EQUIPMENT POLICIES

- A. The Northern and Southern Area Chairs will store their own equipment and be responsible for transporting the equipment to area assemblies.
- B. The cost of any repair or replacement of the equipment as the result of damage at an Area or NAGSC/SAGSC event will be the responsibility of the Area.

These proposed guidelines will become effective immediately upon adoption.

Report and Charter: Ed L.

This agenda item is very lengthy but the main reason for this discussion iclarification. In 1955 Bill W wrote in the section AS IT IS UNDERSTOOD" That neither the twelve traditions of Alcoholics Anonymous nor the warranties of article 12 of the conference charter shall ever be changed if and when the time comes. Except by a vote of 34,s of the registered groups world wide. There would be at least a six month time frame for the groups to respond. The main focus of this resolution was to discern between listed and registered groups. A footnote was to be added the AAWs only list groups solely for purpose of accurate communications. What all of really comes down to is that a meetings on the meeting app are just that a meeting and are not necessarily registered. So who can vote on a very important issue? Who's votes would be counted listed or registered or both? The proposal in this item is to remove the footnote and to have further discussion on the subject as to what votes would count. Bear in mind Bill wrote registered groups in the original draft in 1955. Much discussion needs to be made as to how do we allow every AA member a vote. Like many agenda items this topic will be around for quite a while. Right now

the question is to remove the footnote and discuss different wording as it somewhat confusing.

Treatment and Accessibilities: Anna L.

My name is Anna, I am an alcoholic, and the Alt. Chair for the Treatment & Accessibilities Area Conference Committee. The Chair from the South and I received an email in December from the Alt. Delegate with the roster for our committee and direction to contact them to determine if they still want to participate. The Chair sent out an email as requested. We received the background information on February 23rd with an extension to have the summaries completed by February 29th due to the late delivery of background information. There were nine agenda items for the Treatment and Accessibilities Committee to summarize, two of which were already summarized. The Chair summarized three of the remaining agenda items, and the Alt. Chair summarized four. The Alt. Chair sent an email to the committee asking if anyone was interested in presenting, should any of the topics be selected for the Area Assembly. One committee member replied stating that they are serving on another committee, and another committee member replied stating that they were interested in participating. None of the Treatment and Accessibilities agenda items were selected for the Area Assembly. Unfortunately, there was some frustration and a sense of lack of communication among our committee. Certainly, there are circumstances beyond our control, such as when we receive the background information, but we would like to make a few suggestions for future rotations:

1. Increase the support ahead of time to ensure that the ACCs are prepared for each step in the process. For example, the Alt. Delegate could send out an information package that includes documents such as the Nevada Area 42 Calendar, an ACC Panel Chairs List, Guidelines for Agenda Topic Summarizers, and Guidelines for Agenda Topic Presenters; or at least an email with links to the documents and a reminder to review them.

- 2. Hold a workshop for the ACC Chairs & Alt. Chairs in January to create a collaborative environment where Chairs and Alt. Chairs have an opportunity to ask questions and share experiences from previous rotations.
- 3. Do not rely solely on email to contact committee members. If they do not respond to an email, follow up with a phone call; or try starting with phone calls. Please feel free to reach out to me with any questions regarding the Treatment and Accessibilities ACC or any of the agenda items we summarized.
