Leadership in AA

When I had a few months of sobriety I raised my hand to volunteer to be the coffee maker at my Monday night meeting. It was a big production. I would get the coffee started and then get to work preparing the food. About an hour before the meeting started, some of the less fortunate would arrive wanting to eat the food and wait for the meeting. I controlled the kitchen with an iron hand. No one was allowed in until I said so. Here I was three months sober and in charge of the big Monday night feast for the meeting. I don't remember what my criteria

was, but at some point, I opened the kitchen and put the prepared food out.

So, let me ask you, was that strong leadership? Well, as I look back at it today, there are lots and lots of things I would change. But it was my first experience in a leadership role in Alcoholics Anonymous. I was a newcomer, doing what newcomers do best, taking my responsibilities very seriously.

At 22 years sober, I became a first time GSR. There was something exhilarating about learning new things in Alcoholics

Anonymous. Not only was I exposed to new ideas, but my AA world expanded from my little home group to the big world of General Service. I met people who were Trustees on our General Service Board. I met people who had served two years as delegates and gone to the General Service Conference in New York.

My first experience at an area meeting was during our annual roundtable discussions. This is where all the GSRs and members of the Area Committee discuss policy items that will be considered at the annual meeting. I was lost. I didn't know the history of AA. I had never read

about it. I hadn't read the Grapevine, so I hadn't read any articles about people's experience with the 12 Traditions. I didn't know A.A. had 12 Concepts or that we had 93 Areas who sent delegates to an annual meeting to decide the direction for A.A.'s future.

I don't like to make a fool of myself, so I tend to watch quietly until I feel prepared to participate. I was so overwhelmed with my lack of knowledge and the wealth of knowledge and experience of those around me that I kept quiet for a while. I saw people who were chairing


meetings allow their schedules to change so that everyone had an opportunity to voice an opinion. I heard speakers talk passionately about an idea only to change their minds after hearing a different opinion. I felt the open-mindedness.

There is a saying "listen like you want them to change your mind" or "listen like you don't have an opinion". At our area meetings, I observed people talk passionately about items and then change their mind

and vote against what they had proposed. It is the most awe-

inspiring experience. To me, it feels like a true spiritual experience to watch long-time members demonstrate loving leadership. Leadership through showing us how to allow a full group conscience.

I was able to attend the North/South Connection Special Forum in July. This is a new Special Virtual Forum between the separate General Service Structures of Chile, Argentina and US/Canada. The focus is reaching remote communities – remote through

either language, culture or geography. Topics ranged from speakers in the deaf community, indigenous people and those speaking different languages. One speaker from Canada talked about the Punjabi community and stepping up to help get literature in Punjabi from India, while he was still new.

A gentleman in Argentina spoke about taking a six hour bus (not car) ride up the mountain on a twelfth step call; not knowing if his prospect would be there. Another man from the Mapuche people spoke about feeling disconnected from his culture as did an Inuit woman from Baffin Island in Northern Canada. What all these speakers had in common was quiet leadership. They were part of a hidden community that wanted to belong. Through their experience in Alcoholics Anonymous they had healed enough to want more. They didn't wait for someone else to come along and tell them what to do, they found their own way. I was moved by their passion to help others, their compassion and their sense of purpose.

A few years ago, there was a request from the fellowship to create a pamphlet for the Hispanic Woman. As the area discussed the value and need for a new pamphlet, a group of Hispanic men came to the mic and in both Spanish and English discussed why there needs to be outreach to Hispanic women. They honestly talked about their experience with either excluding the women or observing the exclusion of Hispanic women in their home groups. There were tears and heartfelt amends made and a plea to those of us unaware of the behavior to support the creation of the pamphlet. There wasn't a dry eye in the room. And now we have a pamphlet. Those men stepped up, told their truth, and lead our area into supporting the new pamphlet.

During the pandemic when many of us temporarily lost our meeting places, I saw AA

members transform into leaders before my very eyes. People with little understanding of technology learned how to run a Zoom meeting. Other's found new places outside when the weather allowed (cold winters where I live and unbearable heat in Las Vegas). The need to make sure the still suffering alcoholic had a place to go uncovered the AA leaders among us.

Bill W. wrote in Concept IV:

"There is another good reason for 'participation,' and this one has to do with our spiritual needs. All of us deeply desire to belong. We want an A.A. relation of brotherly partnership. It is our shining ideal that the 'spiritual corporation' of A.A. should never include any members who are regarded as 'second class.' Deep down, I think this is what we have been struggling to achieve in our world service structure. Here is perhaps the principal reason why we should continue to ensure 'participation' at every important level."

So, I would like to ask all of us, what hidden community are you witnessing? When you see a need, do you act? I want to celebrate all of our quiet leadership. Leadership in A.A. isn't just those out in front, on stage or with titles. Some of the strongest leaders are those among us who see a need and take action. Those who listen with an open mind, who encourage others to try new ideas with an open heart. A good leader doesn't need accolades or to be given credit. Roberta L. Panel 47 Nevada Area 42 Delegate and Past General Service Trustee was guoted at the 2022 General Service Conference "Blessed are those who have nothing to say and the courage not to say it." As we prepare for our election assembly, please keep in mind those who have demonstrated leadership and choose wisely.



Did You Know?



A.A.'s **Third Legacy Procedure** is a special type of electoral procedure, used primarily for the election of delegates and regional and at-large trustees. It is considered to be unique to A.A., and at first glance, appears to introduce a strong element of chance into a matter that should depend solely on the judgment of the majority. In practice, however, it has proved highly successful in eliminating the influence of factions or parties that seem to thrive on most political scenes. The railroading of a candidate for election is made difficult, if not impossible, since voters have a wide selection of candidates to choose from. More importantly, a second-place candidate who may be extremely well qualified but without early popular support is encouraged to stay in the balloting rather than withdraw.



La Viña Ad Hoc Committee Proposal September 2022

History:

For several years dedicated individuals have been carrying the La Viña message to Area 42 with no support from the Area. They have put together story writing workshops. They have been bringing La Viña publications displays to our assemblies. And in general, carrying the La Viña message to the Area and beyond as they have also been active in promoting La Viña to the Pacific Region.

Proposal:

The La Viña Ad Hoc Committee proposes the creation of two (2) La Viña committees complete with Chair positions, one in the North and one in the South. The purpose of this proposal is to bring La Viña into parity with NAGSC and SAGSC Grapevine committees. The La Viña committee chairs' duties would be the same as the Grapevine chairs and will be to represent La Viña at Area, SAGSC and NAGSC events. The La Viña Chairs should be fully funded voting members of the area committee. The newly formed NAGSC and SAGSC La Viña committees should be included in the Area budget process.

As our Area grows and matures it is time to recognize the value, passion and efforts of those who have been carrying the La Viña message and give them parity with the Grapevine committees efforts. The area Ad hoc committee is tasked with recommending ways to create parity. To achieve this, we are proposing to both NAGSC and SAGSC to create La Viña committees complete with Chair positions and that the Area 42, NAGSC and SAGSC guidelines recognize the chair positions. Finally, that the new La Viña Committees and Chairs are financially supported by appropriate budgets.

- B. Duties of the Alternate Chairperson:
- 1) Assume the duties of the Chairperson in his/her absence.
- 2) Assist and support the Chairperson in carrying out the duties as needed.
- 3) Serve as the Chairperson of the General Service committee in the section of the area (Northern or Southern) in which he/she resides. If he/she has already served a two-year term as Chairperson of this body, the NAGSC/SAGSC may elect a chairperson from among its membership.
- 4) The local Special Needs Committee Chairperson shall notify the Alternate Chair and Area Treasurer as soon as assistance is requested so that any necessary arrangements can be made. (rev. 4/16)
- 5) The local Special Needs Committee Chairperson shall obtain from the interpreter(s), in writing, a quote for the hourly fee for services to be provided, or for a set fee for the Assembly or meeting. (rev. 4/16)
- 6) Appoint a Grapevine Representative from NAGSC or SAGSC as appropriate.
- 7) Appoint a La Vina Representative from NAGSC or SAGSC as appropriate. (rev 7/22)

- D. Duties of the Alternate Delegate:
- 1) Serve as the Chairperson of the General Service Committee in the section of the area (Northern or Southern) in which he/she resides. If he/she has already served a two-year term as Chairperson of this body, the NAGSC/SAGSC may elect a chairperson from among its membership.
- 2) Appoint a Grapevine Representative from NAGSC or SAGSC as appropriate.
- 3) Appoint a La Vina Representative from NAGSC or SAGSC as appropriate. (rev. 7/22)



This one is about recommending we create La Viña Committees in the North and South that would be set up like the Grapevine committees. The committee and their Chairs to be funded appropriately for Assemblies and other activities. The Ad Hoc committee's recommendation will be presented at the Fall Assembly for a first reading.
