

For anyone who doesn't know what NACYPAA is, it was created with the sole mission of promoting participation, enthusiasm, unity and excitement about the program of Alcoholics Anonymous and to support the sobriety of young people in Area 42 through an annual Area conference. Since last assembly, LVYPAA hosted the first ever NACYPAA in June at the Plaza Hotel in downtown Las Vegas. Through a bid submission process, the young people's committee RENVYPAA was selected to host the next conference in Reno NV, dates are still TBD, but we will send out information once it is finalized. Through the process of hosting our first ever conference, 2 new YPAA committees were formed, ELKYPAA (Elko Young People in AA), and CACYPAA (Carson City Young People in A A), with hopes of forming a Mesquite YPAA. It has truly been an amazing experience to watch the AA community expand through YPAA, and being a part of helping, these committees create their own service committees. NACYPAA advisory meets every 1st Sunday of the month via zoom at 9:00 am and the meetings are open to anyone who cares to join, you can reach out to me for any information regarding that.

After hosting the first conference, LVYPAA has since reformed and held elections on August 7th. 

Our website is continually being updated with meeting changes and we are beginning to do more outreach to online meetings (nnig.org).






## "Surrounded"

## Area 42 Guidelines Preamble:

Ever mindful that the reason for the General Service Structure is to be of service to the fellowship of Alcoholics Anonymous, this body shall always observe the spirit of the Twelve Steps, Twelve Traditions, and Twelve Concepts for World Service. In the absence of specific indications... the latest edition of the AA Service Manual may be relied upon.

## **Worldwide Unification-Online**

Being a computer savvy person and having had a lot of experience with online meeting platforms I adapted well to the changes that were brought about by the pandemic. For about three months after the initial shutdown I attended virtually, then continued to host a hybrid meeting, and then returned to the in person format. I predominantly go to in person meetings.

Now that you know that, let me share with you my takeaways. I believe that the Legacy of Unity can be fulfilled in an online format and that we just need to work a little harder at it. Creating an inviting atmosphere for the newcomer and visitor online can seem to be a challenge but it is possible.

At an in person meeting there can be ten individual conversations going on simultaneously, but online whoever has the "conch" controls the room. Forgive my Lord of the Flies reference but please understand that if a newcomer comes into a room five to ten minutes before the meeting and hears people talking about their pets, health problems, or weather, they may not be so attracted. This is a job for the online Home Group members to either create some shared understandings with the group or teach through demonstration. When a newcomer or visitor appears the direction can either shift to a discussion of principles, alcoholism, or towards an invitation for that individual to speak. I feel we are making great strides in the online space and will continue to do so.

When I got sober the forever infamous meetings before and after the meeting were most impactful for me, so it is my intention when in an online meeting to make sure to reach out to those that may be there for the first time and try and connect with them after the meeting. I also want to remember that it may sometimes be hard for a newcomer to walk out of an actual room (and someone can

always follow them), but online all they need to do is push a button and they are gone.

The meetings themselves online I find extremely beneficial for many reasons, if not the least of all... convenience. I believe future generations of AA's will look back on this as a truly pioneering time that brought us, by forces beyond our control, into the next phase of the Fellowship. We are able to sit at home and hear the experience, strength, and hope from people all across the world. We are able to log on to a meeting any time of day on any day of the week!

I also feel that it has opened up more acceptable ways of sponsorship. I know many people, including myself, that did not take on many sponsees due to their travel schedule. I even started sponsoring guys locally online. Even now when I travel people ask me to sponsor them and my response is much different than before when I would say, "I am not from here." It appears that the virtual world has broken it all down for us and we are all from everywhere. I hear all the time now things like, "I am speaking in England tonight." Just recently I got asked in a visiting room to speak in a prison in another state- online. The possibilities are endless.

So my final thought is this, and I say this for myself. Like everything else in recovery and in life, I will get out of it what I put into it. If I let an app, or for that matter even a mask stand between me and my purpose, between me and my higher power, then I am only hurting myself. Now the online venue may not be for everyone but lets let others decide for themselves. Tradition one states, "Our Common Welfare should come first; personal recovery depends upon AA Unity." So the question remains for me, am I being divisive or am I being unifying? I feel that the online meetings have the potential to bring us into a worldwide unification- one meeting at a time. - c. Time and duration of your meeting
- d. Is it a recurring meeting?
- e. The password you would like to use

You will receive the following information to the email that requested the meeting.

- The link for your meeting
- The password for your meeting
- A Host Key
- How to use a Host Key instructions

NOTE: A Host Key is used for the specific meeting requested and can be used for that meeting (including recurring meetings at the same time).

If a meeting is required at another date and time you must send another email as a request to have that meeting set up for that time and date.

## A Lifeline For Many Of Us

I'm alcoholic, and I live in the Eastern Sierra of California - a rather remote part of Area 42. When COVID hit, my home group voted right away to set up our 8 meetings on Zoom. We got help from a neighboring group, and we were up and running really quickly. Some members hated it but others accepted it. Some members with health issues were grateful. Then there were AAs who just disappeared, and surprise! We had a few newcomers join us. (We've had a couple of "Zoom baby" anniversaries.)

Zoom has been a lifeline for many of us. We have members who live even more remotely than I and those who have accessibility issues. One couple lives 90 miles away in Fish Lake Valley, NV and don't have internet service. They join meetings through their phone connection. Moreover, one of them is getting chemo and couldn't risk coming in person. Another member is partially disabled and without transportation. She moved 60 miles down the valley, and she can keep attending meetings with us!

I'm (mostly) fine with Zoom. Two of the six meetings I regularly attend exist only in the Zoom-i-verse. In my Tuesday women's meeting I get to know AAs I wouldn't otherwise meet - a big plus living as I do in a small town. Women from coast to coast join in weekly. My home group has hybrid-format meetings which I take advantage of sometimes. Yes, I admit to being lazy now and then, and I just log in from home.

There are some drawbacks though. It's weird when online members turn off their video. It's like having ghosts in the room. I think, "Yoo Hoo, anybody home?" What's more, it's hard to recognize the in-person people in the back of the big meeting rooms. Sometimes it's hard to hear them too, but it's great that there's always



someone who spins the laptop so that we Zoomers can see the people closer to the camera when they share.

One more thing: I serve as the group's treasurer. Comparing pre-COVID to hybrid era attendance and contribution numbers, I see that the Seventh Tradition contributions overall have declined. Not drastically, but noticeably. About 25% of a month's meeting attendees are online, and we don't have an easy way for them to participate in the 7th. We tried Venmo without much success. We rely on members to send their contributions to our PO box. Some do regularly. All the same, we've got to get better at inviting the online folks to feel more a part-of by participating in the Seventh Tradition.

Dinner to make, kids to feed, no babysitter, no transportation, illness, or for whatever reason, Zoom makes meetings accessible for many of us who wouldn't otherwise be plugging into our shared experience, strength and hope.

There are always pros and cons. Overall, our hybrid meetings are very inclusive with inperson and online members sharing equally. It's tough, though, to feel the connection when it's time to circle up and pray out. There's just nothing like holding hands.

## From The Ask-It Basket:

"What is the deal with Area 42 members wearing t-shirts with political statements on them? My sponsor said to never do that anywhere in AA?"

I'm Sophie... I served as the Panel 63 delegate for Area 42. I was handed this question during the ask-it-basket, and I gave my best shot at a reply. Since then I've continued to think about the topic and its significance today in what Bill W., in 1955, referred to as "troubled times."

Naturally my thoughts go to our Traditions: the First (Unity) and the Tenth (no controversy). It's my opinion that we've got to apply the Twelve Traditions to group life and service work as seriously as we apply the Twelve Steps to ourselves individually.

The Traditions "...repeatedly ask us to give up personal desires for the common good..." (Twelve Steps and Twelve Traditions, p.184). My stomach twitches when a member, maybe unknowingly, shares in a way that emphasizes our differences rather than staying with our similarities. Some of us feel at times that we have to make a point or express a controversial opinion, maybe without thinking that his/her/their share may be divisive. We all need to speak up to protect our unity at group, district and area levels and in AA as a whole, or there will likely be little sobriety for us and nothing for us to pass on to alcoholics looking for a solution.

Our need to steer clear of controversy, expressing our opinions about "outside issues," is a critical principle for AA's survival. The story of the Washingtonians is often used as an example of the consequences of becoming distracted from a primary purpose. That temperance movement fell into disunity over the abolition of slavery and collapsed. I believe this is the kind of trouble Bill W. called "controversy-serious controversy." The Washingtonians' mistakes

inspired the writing of our Tenth Tradition.

Many questions come to mind. Does wearing a t-shirt, jacket or cap with a political, social or religious statement or representation constitute "serious controversy"? Does it distract us from fulfilling our primary purpose whether we're doing the business of AA as a whole or sharing in the rooms of AA? Is wearing or sharing our opinions on outside issues giving newer members an accurate picture of the principles of Alcoholics Anonymous? Could it drive anyone away? Is it negatively impacting unity among the not-so-new among us? How do I feel when another member comes to a meeting wearing their hot-button opinion- one that I disagree with?

Today we have no shortage of time bomb political, social and religious controversies- "serious" controversies. Bill W. wrote in AA Comes of Age (p.124) that our hesitation to clash with each other or anyone else doesn't mean "...that the members of Alcoholics Anonymous, now restored as citizens of the world, are going to back away from their individual responsibilities to act as they see the right upon issues of our time. But when it comes to A.A. as a whole, that is a different matter. As A.A.'s we do not enter into public controversy, because we know that our fellowship will perish if we do...". I think he might have smiled when he said, "Of course, we did reserve that sometimes enjoyable right of quarreling among ourselves about lesser matters."

What about wearing or sharing my opinions or beliefs when I'm representing Alcoholics Anonymous in public such as in Public Information or Cooperation with the Professional Community service work? Implying an affiliation or position on a controversial matter harms our reputation in the public eye. We cannot give the impression that we have opinions on matters other than our primary purpose. It eats away

at our unity and will certainly affect the still-suffering alcoholic's chances of finding recovery through the local community.

When controversy would affect the AA group, area, AA as a whole or the reputation of Alcoholics Anonymous before the public, the Traditions ask us to surrender our desires for the sake of our unity. In a September, 1948 Grapevine article, Bill W. asked what is our best defense? "This surely lies in the formation of a Tradition respecting serious controversy so powerful that neither the weakness of persons nor the strain and strife of our troubled times can harm Alcoholics Anonymous. We know that AA must continue to live, or else many of us and many of our fellow alcoholics throughout the world will surely resume the hopeless journey to oblivion. This must never be."

"Compliance or noncompliance with any principle of AA is a matter for the conscience of the individual; he is the judge of his own conduct." (Language of the Heart, p. 76) The Traditions are suggestions; there are no AA police.




