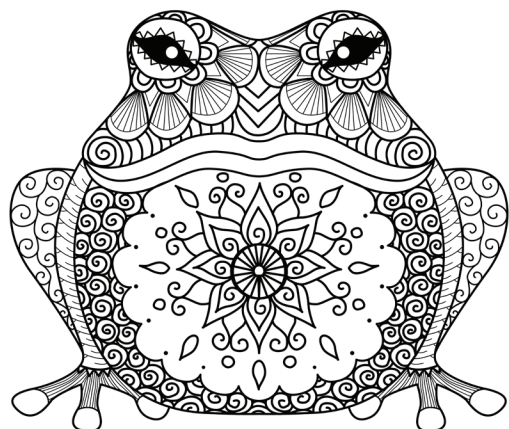

Why Do We Need a Conference?

The late Bernard B. Smith, nonalcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting: "We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.*

"We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing overintegration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

"We need it to ensure that changes within A.A. come only as a response to the needs and wants of all A.A., and not of any few. We need it to ensure that the doors and halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks anyone who needs what his or her race is, what his or her creed is, what his or her social position is."

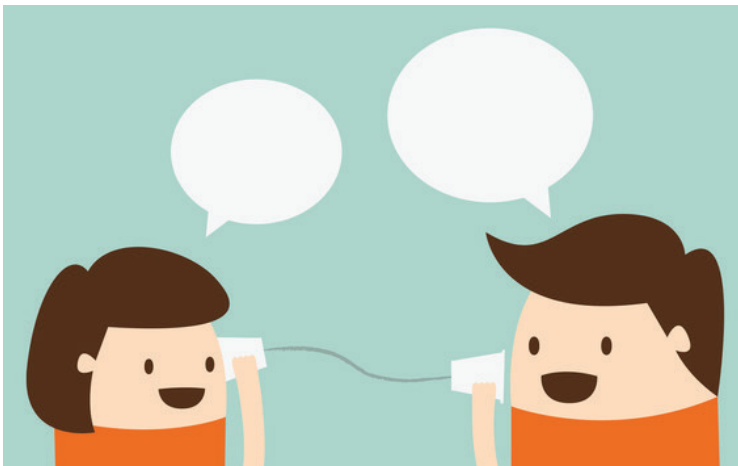

For the month ending May 2017 there were 432 information calls and 130 twelve step calls. The website had an average of 182 hits per day for an average of 5,800 web visits. The Intergroup Treasurer reported a total bank balance for the month ending May 2017 of \$19,005.57.

"What is an A.A. Group?"

As the long form of Tradition Three clearly states, 'Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.'

Shared experience suggests that a special interest meeting's function is not to keep the alcoholic seeking help with a drinking problem out, but, rather, to create a space where the alcoholic can in fact find help.

The function is inclusiveness not exclusiveness. In A.A. we are much more concerned with results not methods and shared experience shows that these groups work. If these groups can be a tool that can help one A.A. member then the miracle of A.A. will be alive.

"What about the group that seems to impose extra requirements, beyond "a desire to stop drinking"? This might be a 'special interest' group or collection of groups in which, for example, each member must be a physician-or a young person, a man, a woman, a priest, or a law enforcement officer. By their own account, those attending special interest groups consider themselves A.A. members first. They attend general-membership meetings as well as those that fill their other individual needs, and they remain devoted to A.A.'s primary purpose.

"These 'special interest' groups offer only one instance of the diverse and inclusive membership within our Fellowship. Our Traditions allow unparalleled freedom, not only to every A.A. member, but to every A.A. group

We know of special interest groups which have been met with disfavor by certain members of A.A., including Spanish-speaking women's meetings. While any disfavor to an A.A. group can definitely present challenges to the group's efforts to carrying A.A.'s message, collective experience suggests most members and groups favor and support

each other's efforts. Keep in mind, by reflecting on shared experience and expressing guiding principles, A.A.'s Twelve Steps and Twelve Traditions offer spiritual guideposts rather than legalistic brick walls. The ideal is for sharing and the emergence of an informed group conscience to arrive at what is the most effective decision at any given time for A.A.'s to carry the message to still suffering alcoholics.

SAFETY CARD FOR A.A. GROUPS

Suggested Statement on Safety

Our group endeavors to provide a safe meeting place for all attendees and encourages each person here to contribute to fostering a secure and welcoming environment in which our meetings can take place. As our Traditions remind us, the formation and operation of an A.A. group resides with the group conscience. Therefore, we ask that group members and others refrain from any behavior which might compromise another person's safety.

Also, please take the precautions you feel are necessary to ensure your own personal safety, for example, walking to your car in a group after a meeting. If a situation should arise where someone feels their safety is in jeopardy, or the situation breaches the law, the individuals involved should take appropriate action. Calling the proper authorities does not go against any A.A. Traditions and is recommended when someone may have broken the law or endangered the safety of another person.

Our Common Welfare

Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.

— Tradition One (Long Form)

It is hoped that our common suffering as alcoholics and our common solution in A.A. will transcend most issues and curtail negative behaviors that could jeopardize the safety of anyone attending an A.A. meeting. Nevertheless, Alcoholics Anonymous is a microcosm of the larger society we exist in. As such, problems found in the outside world can also make their way into the rooms of A.A. For this reason, groups and members discuss the topic of safety — to raise awareness in the Fellowship and to seek through sponsorship, workshops and meetings, to create as safe an environment as possible to carry A.A.'s message of hope and recovery to the still-suffering alcoholic.

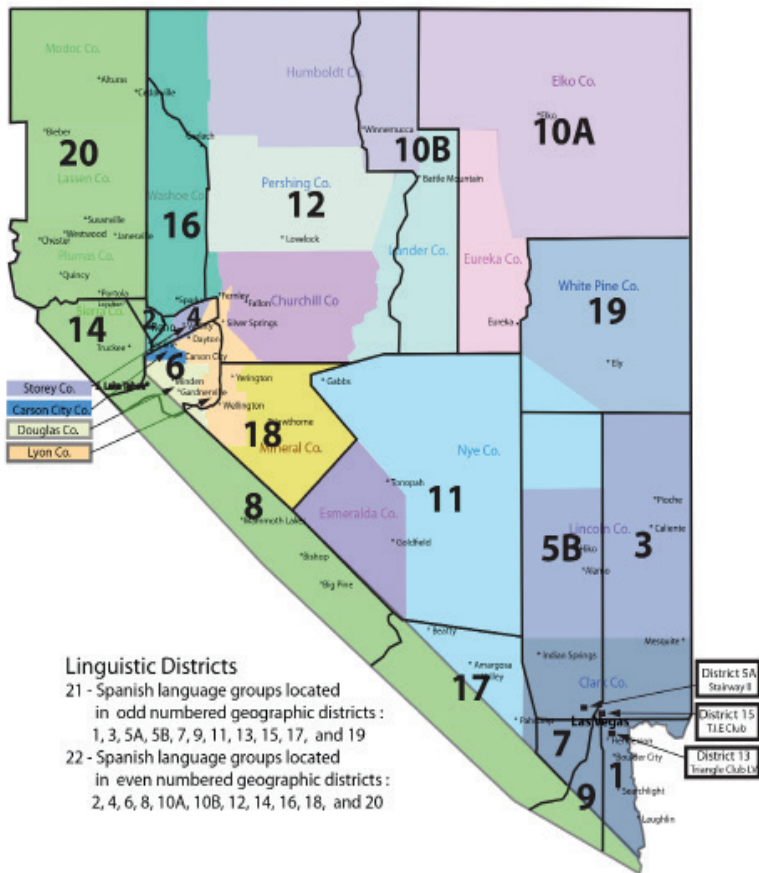
