GRAPEVINE OUR MEETING IN PRINT

Our 'Meeting in Print'

The "A.A. Grapevine," our "meeting in print," was created by four women and two men with their first issue published in June 1944. They've not missed a monthly

printing since that date.

As it was 73 years ago, the heart of the magazine remains personal stories of recovery. The format has changed somewhat — it's now in color, and to qualify it to be distributed in prisons and jails the magazine now has no metal staples. But the underlying message remains unchanged: there's hope for the suffering alcoholic.

I remember reading a copy on an airplane a couple of years ago, when another passenger spotted it and asked me if I, too, was a "Friend of Bill." A new friendship began. I've heard stories of members who were at rope's end and about to drink, unable to make personal contact with a fellow AA, but they picked up a copy of the "Grapevine,"

found inspiration, and are still sober today.

It's our publication, which means you and I can submit personal stories of recovery, items of humor, and photographs. Personally, I've had one story and two photos (in the "If Walls Could Talk" section) published. Many other Area 42 A.A. members have been published in the "Grapevine," our Spanish-language publication "La Viña," and even in "Best of Grapevine."

What? You don't subscribe? Not to worry ... we'll be happy to sign you up. An idea for you: "Grapevine" makes

a wonderful gift for sponsees.

Your Area 42 "Grapevine" Reps (Justin P. in the south and me, Pat S., in the north) would love to take your subscription, or make presentations you your group, district or special event. Finance

According to the 67th Annual Meeting Final Report 2017, United States and Canadian Groups, Individuals, Specials and Special Meetings contributed \$7,934,869.47 in 2016. Of the 66,336 reported groups, 27,542 contributed or 41.5 percent. Nevada Area 42 had 649 groups with 14,030 individual members reported. Those 209 Nevada groups contributed \$45,887.66 in 2016. (67th Annual Meeting Final Report 2017, P. 94-95)

Literature

In 2016, \$13,502,905 worth of books were sold by AA World Services, Inc. It 845,202 copies of Alchoholic Anonymous in print form plus 16,726 e-books. (67th Annual Meeting Final Report 2017, P. 67)

Grapevine and LaVina:

While the overall AA Grapevine Circulation continues to decline year after year, it did show a projected net income of \$2,012,507 in 2017 which is \$91,702 less than the 2016 actual income. Projected income from books, casette tapes and misc items is estimated at \$689,321. For 2017 La Vina was expecting a \$46,645 gross profit. (67th Annual Meeting Final Report 2017, P. 96)

AA.org:

Oversight of the G..S.O A.A.W.S. is the responsibility of the A.A.W.S. Board of Directors acting through its Technology/Communications/Services and Pubishing Committees and in accordance with the Twelve Traditions of Alchoholics Anonymous. In 2016, it received a total of 13,327,469 million visits, an increase of 4 percent from 2015. New features include updated search capabilities and a new service piece called "Safety and A.A.: Our Common Welfare" and audio clips of Bill W. (67th Annual Meeting Final Report 2017, P. 29)

New Grapevine Book Available

"Voices of Women in A.A.: Stories of experience, strength and hope from Grapevine" is now available. It is collection of 61 stories by or about women in Alcoholics Anonymous. It costs \$11.50 for an individual copy. It is available now. (Box 459, Fall 2017, P. 6)

\$7.27 Contribtions:

G.S.O. has noticed a groundswell of contributions in the amount of \$7.27 which is the 2017 estimated cost per member for G.S.O. to provide service to the A.A. fellowship. The surge of individual contributions for \$7.27 around July 27 was started in the Pacific Northwest and has swept across eight regions and the 93 Areas of the U.S. and Canada. G.S.O sends thanks. (Box 459, Fall 2017, P. 8)

SAFETY CARD FOR A.A. GROUPS

Suggested Statement on Safety

Our group endeavors to provide a safe meeting place for all attendees and encourages each person here to contribute to fostering a secure and welcoming environment in which our meetings can take place. As our Traditions remind us, the formation and operation of an A.A. group resides with the group conscience. Therefore, we ask that group members and others refrain from any behavior which might compromise another person's safety.

Also, please take the precautions you feel are necessary to ensure your own personal safety, for example, walking to your car in a group after a meeting. If a situation should arise where someone feels their safety is in jeopardy, or the situation breaches the law, the individuals involved should take appropriate action. Calling the proper authorities does not go against any A.A. Traditions and is recommended when someone may have broken the law or endangered the safety of another person.

Our Common Welfare

Each member of Alcoholics Anonymous is but a small part of a great whole.

A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.

- Tradition One (Long Form)

It is hoped that our common suffering as alcoholics and our common solution in A.A. will transcend most issues and curtail negative behaviors that could jeopardize the safety of anyone attending an A.A. meeting. Nevertheless, Alcoholics Anonymous is a microcosm of the larger society we exist in. As such, problems found in the outside world can also make their way into the rooms of A.A. For this reason, groups and members discuss the topic of safety — to raise awareness in the Fellowship and to seek through sponsorship, workshops and meetings, to create as safe an environment as possible to carry A.A.'s message of hope and recovery to the still-suffering alcoholic.


