Chair, Liaison Reports

Cooperation with Professional Community, Cheryl E

Aloha All! Here are the activities that CPC (NAGSC CPC and NNIG CPC) has been involved with since the last report in June 2015. University of Nevada Medical School, Reno: Joyce Y (NNIG CPC chair and NAGSC CPC co-chair) and I, along with other CPC committee members meet with Dr. D. and 4-5 third year medical students. We provide the students with some appropriate pamphlets and central office meeting schedules and a short presentation on CPC. The students get an assignment from Dr. D. to attend a 12 step meeting and then they report back on their experience in about 6 weeks. We also attend the report backs. We meet with a new rotation of students every 6 weeks. This continues throughout the year. Since the last report, we met on June 15th, July 14th, and July 30th. Right At Home, Reno: Joyce and I had met with Tricia S., Client Care Coordinator. Right At Home provides in home care and assistance. Their care givers are seeing some clients with alcohol problems. Joyce and I, along with the NNIG Sunshine Committee chair person, gave a presentation to about 8 care givers on June 24th. We were well received. We provided AA meeting schedules and literature, along with Al-Anon meeting schedules. Right At Home has about 140 care givers. They plan to have us come back in the fall to give another presentation. University of Nevada, Sanford Center for Aging, Reno: We will resume

attending the Senior Outreach Services educational talks at the Laxalt Auditorium, Nelson Building of UNR, in the fall. We bring an AA literature rack an hour before the talk and make ourselves available to answer questions and provide information on AA before and after the talk. This event allows us to network with other providers as well, and learn how we may reach the suffering alcoholic through their services. We continue to stay in contact with Dr. Sina W., who organizes these talks, to make ourselves available to other organizations that we could cooperate with to reach the suffering alcoholic. Washoe County School District (WCSD), Reno: The school district changed how it schedules folks to talk with employees and/or students. There is a more rigorous process now. The CPC committee has a member that is retired from the school district and will initiate the process in this fall. District Meetings: We would like to attend Northern Area district meetings and give a 10 minute overview on CPC. We are scheduled to go to District 4 business meeting on August 6th and District 2 business meeting on August 11th. CPC Presentation: We continue to work on a basic presentation that can be used as a starting point for any CPC presentation. We are modifying the CPC presentation that GSO provided to accomplish this. CPC Committee Meeting: We held a NAGSC/NNIG CPC committee meeting on July 19th. There were 5 in attendance. We have a new NNIG CPC liaison and two new committee members. We reviewed the recent CPC activities. We also reviewed the May edition of the Grapevine, which had a special section on CPC and activities that other areas/districts are involved in. We will be meeting again on October 11th to determine other activities we want to pursue as a committee and budget for these for 2016.

Public Information, Lyle C (Read by Rick B, committee member)

A quote the PI Workbook: "What is Public Information Work and Why Should A.A.s Do It? Public Information (P.I.) in Alcoholics Anonymous means carrying the message of recovery to the still-suffering alcoholic by informing the general public about the A.A. program." I was able to attend the International Convention in Atlanta and was asked to participate at the Public Information Booth. This was the first time that GSO provided booths for each of the standing committees. I was on the registration floor for four hours at the PI Booth. The new PSA video Shadows was there for viewing in English, Spanish and French. I was able to discuss with members at large about PI, mainly the concept that we are informational not promotional. I met some staff from our General Service Office and other Area and local PI Chairs. One of the PI Chairs from Florida talked at length to the District 20 PI Chair and me regarding an upcoming CPC/PI open forum. For the first time in recent memory District 20 is planning an open forum for the professional community in Lassen County with PI participation. I had the opportunity to discuss the value of running PSAs (public service announcements) on the local radio stations to a concerned Area 42 member. I explained that letting the public know about Alcoholics Anonymous is informational not promotional. We are anonymous individually, but AA is not anonymous.

Grapevine, Debbie S

In early June, Jake, our Southern Area GV Chair, contacted me with a letter of request from the GV Office. There were 8 inmates in the North and 8 in the South asking for GV magazine subscriptions. This was a powerful experience to watch unfold and be a part of. In sending a letter of announcement to Laura, our Northern Area Secretary, to send out to you all by way of email; groups, districts, members, and NNIG/Central office's Pink Can Treasurer, were flowing in to meet the needs of our incarcerated members! Thank you all for your willingness and help. In July, I was invited to the "Serenity in the Rubies" 19th

annual campout to set up a GV display. Their committee paid for my registration, lodging, and dinner. I am feeling the need to say thank you again for this opportunity! I so enjoyed the meetings, speakers, and fellowship, highlighted by the beautiful scenery. I had most of the GV books and supplies packed in cardboard boxes in the bed of my pick up. In running into a major storm, I was both surprised and relieved that all stayed dry! I froze Friday night as I only took a couple of blankets to 7000 feet. The pamphlet includes stories from AA members that have been incarcerated and brief explanation about AA including what AA does and does not do, sponsorship, Corrections Correspondence Service along with prerelease and re-entry suggestions. This pamphlet is a great tool for the Northern Area corrections service committees to bring 12 twelve step work to correctional facilities. I am very excited about this pamphlet and I will be doing my part to get this pamphlet distributed. This pamphlet and accompanying DVD are available from AA world services. Reported on the DCM meeting prior to this nagsc meeting. 5 DCMs, 7 chairs attended, he asked how many DCMs had had presentations from committees, answer – 3 and one workshop. Presentations inspired a few more members to become committee members.

NAGSC Old Business

Carol asked for a sense of the body concerning changing the format of our Round Table discussions from break out, smaller group discussions to one room where all discuss together and one scribe. This may simplify the note taking process.

Discussion:

Phil – Opposes the change because one room will create less feedback from the GSRs. The notes can be written in a different manner but note taking is secondary to getting the information out to the groups and making sure all have a chance to speak.

Paul – Prefers the intimacy of round tables, suggest giving each presenter one scribe that travels with presenters.

Joyce – Prefers the intimacy of separate rooms but agrees the Nagsc notes were not accurately when read at the Assembly.

Roberta – Perhaps give each scribe a recording device.

Wayne – Prefers intimate rooms, the notes are turned in too quickly and not organized properly.

Karie – The one room means she can hear every speaker, not just the members of her smaller group

Minority Opinion. Nancy prefers to hear all opinions but not just the opinions of a small group

Nagsc will keep as we have in the past, Carol will assign a scribe to each presenter and compiled notes will go to GSRs prior to assembly to take to their groups discussions.

NAGSC New Business

Sue read the following for a sense of the body: Does the Nagsc body support forwarding this proposal as a possible agenda item.

Concept meeting participants: Joyce Y., Merl C., Nancy W. Cheryl E. & Sober Sue

- Our Concept group meet in Spring in 2014.
- Attendees were: Merl, Joyce, Nancy, Cheryl and Sober Sue.
- We can not know what Bill "Apparently Inadvertently" meant.
- We are addressing only the Endnote #4 on page 73 of Service Manual 2013-2014; not any of the other wording in Warranty 6.
- We read the email from Sophie (Delegate) and the history regarding the research on the Concept 12, Warranty 6, Endnote #4.

1. Written request:

A Concept study group which met in Reno, Nevada in the spring of 2014 had some concerns about endnote #4 of Concept 12, Warranty 6.

Actual Endnote:

(4 Bill here, apparently inadvertently, used the phrase "in action and spirit", instead of "in thought and action" that appears elsewhere in both the Conference Charter and the statement of Concept XII.)

Specifically our group felt that the endnote is a guess as to what Bill meant. There is no evidence to indicate that he meant anything different from what he actually wrote. We request that endnote #4 be removed.

2. Background material

<u>2013</u>, Panel 63, General Service Conference Delegate, George J. previously addressed this same concern about Endnote #4. He unfortunately died before he could complete the process.

<u>2014</u>, Area 42 revealed that someone in the publishing department made notes to the 1972 Service Manual to make changes to the Warranty by crossing through certain words and adding new words. The endnote was then added to reflect the change in wording. The person made an assumption that Bill W. "apparently inadvertently," made errors in his wording and created endnote #4.

<u>2014</u>, Our research and communication with Tracy O., General Service Coordinator, indicated that there is no clear knowledge of how or when endnote #4 was originally place in the Service Manual.

<u>2015</u>, Next we will be going thru District, Area North and South and then our Delegate and to Conference.

Some discussion held to clarify the purpose of the proposal and what specifically is being asked in the proposal.

Marianne – Agrees because AA should never be drawing conclusions about what Bill W "meant".

Samantha – can you just remove the words: "apparently inadvertently"?

Nate – Why not add additional footnote that explains why the footnote is there?

Carol – Concerned about the notes around 2014 about crossing out and changing. Joyce suggested removing this section.

Samantha – would like to see some of the background material not presented here today.

Paul – Once submitted to GSO, all of the background info will be available to all.

Jenny - Aren't we splitting hairs?

Tinna – Concerned that if we remove the endnote then there will be no indication that a change occurred?

Marianne – pointed out that the warranties have been returned to the original.

Nancy – feels the point of removing the footnote is to dispel the idea that any of Bill's wording has been changed.

Gary – Should mention that the original wording has been restored.

Sense of the body taken:

Does Nagsc want to support a recommendation that this proposal be given to our area delegate for consideration as a future agenda item?
