# Standing Chair Reports

# Cooperation with Professional Community, Cheryl E

Here are the activities that CPC (NAGSC CPC and NNIG PI/CPC) have been involved with since the last report in June 2016.University of Nevada Medical School, Reno: Joyce Y. (NNIG CPC chair and NAGSC CPC co-chair) and Cheryl, along with other CPC committee members meet with a doctor and 4-5 third year medical students. We provide the students with some appropriate pamphlets and central office meeting schedules and a short presentation on CPC. The students get an assignment from the doctor to attend a 12 step meeting and then they report back on their experience in about 6 weeks. We also attend the report backs. We meet with a new rotation of students every 6 weeks. This continues throughout the year. Since the last report the beginning of June, we met on June 6<sup>th</sup>, July 8th, and July 29th.Washoe County School District (WCSD), Reno: We are working with some counselors at the Washoe County School District to create a presentation on alcoholism and AA geared for high school students during a health class. Joyce, Tom, and Cheryl met on June 10<sup>th</sup>, did a mock presentation on June 27<sup>th</sup>, July 1<sup>st</sup>, and July 25<sup>th</sup>. Next

time we meet we will hold a mock presentation for committee members. We will review feedback before going back to the school district to do a mock presentation with the counselors, Victim Impact Program: Joyce, Joanne, and Cheryl went to a Victim Impact Panel on June 14th at the Douglas County Courthouse in Stateline, NV. In Douglas County, folks that get a DUI must attend a Victim Impact Panel as part of their requirements. There were four folks on the panel. There are four folks on the panel, one of them in recovery from our committee. The next Victim Impact Panel will be August 18th at 3:00pm at the East Fork Justice Court in Minden, NV. Orientation to AA Sessions: Joyce and several other members have been working on an overview of the Orientation to AA Sessions for the past couple years. The purpose of these sessions is to help folks new to AA and court ordered folks to understand AA meetings and the language of AA and how and why we do what we do. There will be 6 sessions. These are NOT AA meetings. These sessions are a service to help folks learn about AA. There will be facilitators of these sessions. They will need to be "trained" to facilitate to provide consistency. These orientation sessions will be maintained by CPC/PI to ensure the sessions will continue and that the message will be consistent. The committee is currently doing mock presentations to prepare to begin presenting these sessions at Bristlecone Treatment Center starting in Oct. Volunteers Of America Restart Mental Health Division: Joyce and Cheryl met with case managers at Restart on July 26<sup>th</sup>. We went to gather information about what their needs were so we could determine if AA would and could fill their needs and if so, what committee would do this. Restart is an 8am to 5pm facility for clients that are chronically homeless and have mental health issues and need assistance. The facility is locked to the public. One must be a client to get in. They would like to have AA info for their rack in the sitting area and for case managers to give out. The pamphlets they would like are: AA schedules; Info on AA; Is AA For Me?; A Newcomer Asks...; AA and Medications; Serving Alcoholics with Special Needs; Problems Other Than Alcohol, Sponsorship; and old AA Grapevines. We agreed to provide 12 of each of these to start. Joyce picked up the literature Aug. 2<sup>nd</sup> and delivered it to Restart. Joyce and Cheryl will work with the H&I committee members to see if this service falls under their responsibility rather than PI/CPC. We also discussed with them the possibility for H&I to bring an AA meeting into the "open" resource center on the Volunteers Of America side. District Meetings: We are attending Northern Area district meetings to give a 10 minute overview on CPC/PI. We be going to District 12 (Fallon) business meeting on August 13th. CPC Committee Meetings: We had a committee meeting on June 12<sup>th</sup> and July 10<sup>th</sup> at the First Congregational Church (Sunnyside) in the annex building in Reno from 2-3:30. We had 6 and 8 folks in attendance. Our next committee meeting will be August 28th.

## **Public Information, Lyle C**

I took this from the Public Information Workbook under the section on "Forming a P.I. Committee. Once you decide to form a P.I. committee, it is a good idea to identify exactly what your needs are and set goals and how many people you have available to get the job done. In some instances, the first task for a committee is to inform the A.A. members in your area about the need to communicate with the public. Sometimes you need to correct misconceptions about whether A.A.s should be going out to non-A.A.s. A few P.I. committees have reported resistance from members who fear they will be doing "promotion" by letting professionals and the public know about A.A. Have the members read and become familiar with the P.I. Workbook so that they have a clear understanding of ways the A.A. message is carried to the public, and of the Traditions and A.A. experience in this area." I have been calling district PI chairs to find out what we can do to support their public information efforts. I know that districts 6, 8 and 20 have PI committees. If your district or group needs help in forming a PI committee or your PI committee would like to share your experience strength and hope, please contact me. Also, I am available to come to your districts. Unfortunately I have been very busy with family obligations, but still

would love to come to your districts. The NAGSC Public Information Committee is available to come to your districts.

Lyle added: On the way to this meeting I was contacted by the hotline number and was able to speak with a mother about her concerns with her "wayward son". I have been a wayward son myself and appreciated being able to speak with her about AA and to be able to carry the message through the hotline.

# Corrections/Bridging the Gap, Mike L

Hello everyone my name is Mike L again I am an alcoholic serving now putting on my NAGSC Corrections Facilities chair hat. The committee's activity has been quiet these summer months but I do have some important information to share. The biggest news I received from the General Service office is the new corrections video called "A New Freedom". The 30 minute available for viewing from aa.org in both English and Spanish .http://www.aa.org/pages/en\_US/a-new-freedom. This new video is a powerful and emotional compilation of a diverse group of incarcerated AA members giving their stories in a "....general way what it was like, what happen, what it is like now,". It highlights the real need for meetings in the correctional facilities. At the end the video is there information on how to contact AA about the AA correspondence service and pre-release information to make contact with the AA community upon release. I myself am very grateful to have been corresponding with an AA member who incarcerated on the Nevada Lockwood facility. The member is very eager to get the AA message and he shares it with his fellow inmates. If would like me to come to your district or group and are in interested and about hearing about how the message can be brought to the correctional facilities through the AA correction correspondence service or AA meetings please contact me. One update on the ongoing effort to get meetings at the Washoe County Parr Blvd facility is looking to have meetings on Wednesday Night and is looking for volunteers, Michelle M the NNIG corrections chair can be contacted through central office.

## **Special Needs/Remote Communities, Roberta B**

Due to health considerations, I have not been as active as I would like. That being said, I visited District 2 and the After Shifters group in June. I will be attending the District 20 business meeting in October. Today I set a date with District 4 and opened negotiations with District 8. In the meantime, I will be contacting the remaining Districts to schedule a visit before the end of this rotation. I will be rotating out in December so if anyone is interested in this committee for the next rotation and would like to join me at any meetings in the coming months, let me know. It is not too early to investigate your service commitment for the next rotation.

## **Treatment Facilities, Gary S**

Well, my commitment as your treatment chair is quickly coming to an end, I would like to thank you all for the opportunity to serve as treatment chair for the last two years. I would like to extend a special thank you to all of you who have stepped up to make the BTG aspect of my duties a great success. But as my commitment nears an end and my counterpart in NNIG who was very active and made my transition into this position very smooth is also rotating out. I couldn't help but wonder where things as far as treatment and especially the BTG aspect of my duties would head, but as we have all had to accept that we can't worry about things that are really out of control, and we turn things over, I have come to realize that God has things well in hands. The NNIG elections have been held and the new NNIG treatment chair seems to be very motivated and ready to hit the ground running and is working with the outgoing chair, Joel B, to keep things running without a hiccup. My biggest concern was what would happen to the area of BTG, as when I began my commitment things appeared to be almost stagnant and non-existent. But I believe my concerns have been answered, whereas the position of NNIG BTG chair has been empty for the last two years but it has at long last been filled. ## **Intergroup Liaison, Michael ML**

Diane B, treasurer reported that we are in a deficit situation of \$4844.06 from our year to date goal. It appears that event revenues are down including speaker meeting attendance. We had elections in June and all positions have been filled including new members of the steering committee. The central office is running smoothly. Last month there were 11 twelve step calls, 63 business calls, 102 volunteer hours, 12 retail calls, and 33 AA event calls. A total of 180 calls into the central office last in June.

It has been my pleasure to serve you as Area 42 Alternate Archivist, thus NAGSC Archivist, for the past almost four years. My term is about to end. During my time in this position our Northern Nevada Archives has grown substantially in size. We don't have a storage facility, so, unfortunately, it has been and currently resides in my garage. With the help of many of you, we've been able to take archives displays to several dozen group meetings, district meetings and functions including one camp-out and several outdoor Founder's Day events. I have also been able to make presentations to various groups. As I indicated, this is a four-year term. Archivist and Alternate Archivist rotate between the north and the south, therefore at the September Area 42 Elections Assembly an Archivist will be chosen from the north. He or she will also serve as archivist for NAGSC. I hope somebody here will make himself or herself available. As for any Area office position, all duly elected DCMs, DCMCs, and area officers, past or present who have served a full term are eligible. The duties, as outlined in our Area Guidelines, are to catalog and maintain all archival material and to

I have also been working on our next Assembly, there is a lot to get ready. It will be an election assembly and as such we do that business before we do any other business. We will have some presentations and fellowship on Friday evening and some other special things planned. I have to say I thought that having Bob W at our last assembly was a very good way to get the message out as to what goes on all around the world and what AA is doing with our contributions. I do want to say I see that some of our districts and committees have been very active in doing the primary purpose of AA. I personally love taking meetings to jails and doing other things to carry our message of hope to other folks, I also love being there when someone whom I have not meet yet shows up at a meeting so I can be a greeter again. One more thing that I think about is our purpose in General Service. This body is put together to do communication between AA as a whole and the fellowship and also to do things that single groups and small areas can't do, such as publishing uniform literature and public information resources, publishing our international magazine, the Grapevine but also helping to bring light to dark areas and helping to start groups among other things. With new blood comes new ideas and new ways of doing the thing we have been doing for a while now, 'Carrying the message of Hope to the still suffering Alcoholic.' Once again, I would love to visit any of our district events and love getting around our Area. Call or write me any time, I like to talk to you and am looking forward to seeing you all in September at our Assembly.

### **Old Business**

Carol gave a report concerning some confusion surrounding a section of the guidelines change 2<sup>nd</sup> reading at the Spring Assembly.

- 1. Area 42 Guidelines recognized Area Chairs before 2014 revision
- 2.0 Area Committee
  - 2.3 C, The duties of the Committee Chairs shall be as defined by their respective Committee guidelines and /or the NAGSC or the SAGSC guidelines.
- **2. Area 42 Guidelines removed section 2.3 C. in 2014,** therefore no Committee chair recognition.
- 3. Proposal to add Committee Chairs and Liaisons to 2.1 Membership C. was voted down on April 3, 2016.
- 4. There was confusion during discussion on this item, it was discussed

and voted on twice and failed both times.

- 5. Some members were disturbed over the results and confusion over the proposal. A committee of members feeling their positions are not valued by the assembly body was formed, and they have taken a group conscience to redress this personal grievance. This shall be addressed at the September assembly.
- 6. All the members on the 5 area rosters have been considered voting area committee members for several years, and are therefore recognized in all discussions which take place during the two annual committee meetings.
- **7. Carol B opinion.** Area 42 Guidelines should reflect the respect, approval and support of the area assembly, by including these trusted servants. Isn't this the "Meat & Potatoes of AA"? The 21 General Service Trustees serve on 13 committees, which cover these various aspects of service (along with items covering conference responsibilities). When the GSC convenes each spring, 135 conference members divide themselves into these committees. Among their duties is to do the business of editing and updating the documentation of our various committee's Workbooks and Kits, carrying the worldwide message of Alcohol Anonymous.

### Lyle also gave a report on this subject:

I believe Wayne H best described how this all started: "This started as a way to address a "confused" vote at the assembly." Wayne polled the GSRs at one of his district meetings and they didn't feel fully informed. It was not a fully informed group conscience at the assembly that we are now trying to rectify. There have been multiple meetings in both the north and south to address what has been perceived as an exclusion of the standing committee chairs from the area committee. The feelings ranged from confusion, frustration, anger and hurt. At the June DCM/Chairs pre NAGSC meeting a group of members proposed a non-quideline change to add standing committee chairs to the area committee. I took a sense of the body as to whether we should present the non-guideline proposal or have an open discussion after the elections. The general consensus was to have a discussion only at the assembly, but wait to present a quideline change proposal. There were no opposing votes, however there were a number of abstentions due to confusion. Some did not feel the discussion was complete. Unfortunately, we ran out of time. Our Area Chair, Phil, said that standing committee chairs will be included in the blue room. However, we did not discuss that this will be his last assembly as area chair and if we place principles before personalities the next area chair may not include the standing committee chairs in the blue room, specifically as we are not in the area guidelines. I recalled something that happened to me during a different panel with different personalities. In 2012 I was asked to get off of an Area conference call because as Corrections Chair for NAGSC I was not part of the Area Committee. Then in the spring of 2015 our Area Guidelines were officially changed to exclude standing committee chairs from the composition of the area committee. In the spring of 2016 Carol attempted to restore standing committee chairs to the area committee. But the change was voted down. Referring back to the concepts, it was suggested to read Concept IV, which is the right of participation. Concept Four reads in part: "The "Right of Participation" is therefore a corrective of ultimate authority because it mitigates its harshness or misuse. It also encourages us who serve A.A. to accept the necessary disciplines that our several tasks require. We can do this when we are sure that we belong,

when the fact of our "participation" assures us that we are truly the "trusted servants" described in A.A.'s Tradition Two."
