Delegate's Report

Delegate (Rhonda F): I can't thank you enough for bestowing upon me this great honor. I have never felt so connected to AA as when I was representing all of you at the GSC. I'm here to tell you all that each and everyone of you is qualified to be our next Delegate.

I arrived in New York, hungry, lonely and tired, when I picked up my luggage and saw that it had been broken and I had to call an Uber because there were no cabs I quickly escalated to Angry. Two hours later I arrived at the hotel grabbed a sandwich and went to my room, positive that you had picked the wrong person for the job. The next morning, I woke up, got showered and met the pacific region to take the Circler Line Tour. We walked through New York City and I fell in love, the architecture was amazing, and the people were wonderful. The walk and don't walk signs do not mean anything in New York.

After the tour we returned to the Hotel then headed to the conference area where there was a meet n greet. I walked around the meet n Greet collecting buttons and bookmarks from the other delegates. I felt like the deer in the headlights. They suggest you mingle and don't cling to the people you know but I found myself searching for familiar faces and shying away from the ones I didn't know. I felt awkward and alone. We then sat down at round tables and listened to the Remote communities meeting and the

1728 presentations. When I got back to my room to dress for dinner, I was exhausted, spiritually mentally and physically. Still convinced that I was not the person for the job.

Then it happened, we sat down to dinner and Vera from Oregon 58 said, "Every meeting, every picnic, every potluck, every sponsee, sponsor, cup of coffee, roundup, assembly, conference, every phone call and every newcomer qualifies me to be here today". I cried. I knew that it was not me at that table, it was AA as a whole. I knew that you had brought me up one commitment at a time.

The next day we met as an entire group and it was like I was wearing a new pair of glasses; I could see my purpose and the old Rhonda (who talks to everyone) came out. I handed out my Area Buttons and introduced myself to everyone. Then they called Roll. I sat there waiting for my name to be called and was filled with so much emotion. 135 members were present or here. The panel 69 Delegates by region took the stage and presented their two-minute talks about their Area. Over the course of the week I sat next to Maine, Rhode Island, Indiana, Utah, California and Canada.

Monday and Tuesday, we met with our committees to discuss the Agenda items. We deliberated for 6 hours over the Grapevine agenda items and called for more background and the statement of purpose regarding the Grey pages. It was in that room that I really got to see Concept 3 in full swing, the right of decision. I heard so much more information and different opinions from 7 other areas. My mind raced back and forth. Then finally the Delegate from 44 New Jersey Jeff said its in the Grapevine Charter, we have given the Editor the Editorial Freedom to publish what they think is best for AA. We then Called the New Editor in and asked him if he felt he had the freedom to choose, he said he did not. Since it has gone to the conference so many times, he feels he must follow the conscious of the conference. We decided not to recommend any items to the conference. We cited Editorial Freedom on the Grey Pages.

Lunches and dinners were served everyday and desserts were everywhere! After the committees met, we all me back in the Conference area to hear more Delegates talk about their areas. We were not allowed to discuss agenda items with anyone except our own committees.

Wednesday morning, we took a trip on the Subway to GSO. I walked in and saw the Serenity Prayer written in 70 languages and brail. I was so overwhelmed with Gratitude I started to cry, then I couldn't stop. I kept thinking pull it together Rhonda, but the tears kept rolling. I sat down in a corner by the coffee pot and the man sitting next to me asked if I was ok. I said yes, just grateful. He asked where I was from and I said 42, he said oh, I was Phil's Buddy last year, I said you know Phil? Then just like that I stopped. I felt at home, I felt connected in a way I have never felt. We toured the office and I got lost in Archives. My confession is I got so lost in the Archives I never made it to the Grapevine Department.

Wednesday afternoon we started hearing the report backs and recommendations. I will get to those in a minute. Thursday and Friday, we listened to the committees share what they recommended, and we voted on the recommendations. 7 Floor actions were brought to the floor during these 4 days. They were recorded and to be heard after the regular recommendations were all presented.

Saturday Morning, we had brunch and the Trustees that were rotating out gave their farewell speeches. David M Class A Trustee and Finance Guy (He writes the Around the picnic table reports) Talked about his journey with AA and how he gave his time and energy to AA because it saved his wife's life, he cried, she cried, I cried...

One last note before I review the agenda items. I forgot to take my service Manuel with me.

Questions/Discussion

Julie will be uploading the committee reports from GSO to the google drive.

Rhonda is happy to send any report if you would like it, just call her.

Joyce asks Rhonda to briefly tell us about the fors and against the big book

- We're getting a new website at GSO and they're moving everything from that fmv to an erp, they are changing the whole system
- Literature has 55 items on it every year, they would have to drop all of that and work on the big book, didn't seem logical
- Some people said we shouldn't even do a 5th edition, they talked about plain language, a digital only 5th edition
- They didn't feel the process should start this year
- Next year will be good because they will have all those new systems in place
- We ask GSO to do a lot of work for us and the workload is too much

Question asked – how do we reintroduce that? Rhonda says to submit it. Joyce says she heard it has to skip a year, we can't bring it up again till the following year.

Rhonda didn't think the workload was a good excuse, she voted yes, she thought they should hire more people. "I have too much work on my plate is a good reason not to do something."

Question asked and answered. Review contribution for \$5000 (when you die) was increased to \$10,000

Phil asks question, Blue card – any talk of taking it out of the pamphlet? No, but there was a lot of talk about being consistent.

Joyce asks Rhonda to describe how the committees work at GSO. Some committees make suggestions but they aren't the same as recommendations. There's no voting on suggestions. Recommendations get voted on.

Suggestions won't be in the next report since they didn't recommend they should be.

Discussion around technology ensues.

Question asked – what were the hot issues this year? Rhonda answers - The hot issues in the fellowship are the workload of GSO and that we are falling behind in technology and we aren't meeting people where they are.

How many of you work with a newcomer on a tablet? No one raises their hand. The big book isn't going anywhere.

The staff didn't say they need more people, she just heard a lot of workload talk.

Question - Does the staff grow with the growing aa population? No. we used to have a lot more staff (125) and when the economy crashed they got rid of 40 people. (this decision doesn't have to go through the body) Phil mentions when we hire staff we have to fund retirements. Less than 40% of the groups are sending money to GSO so they are being prudent with their hiring.

There are more meetings than there are groups.

Alt Delegate (Julie C): My name is Julie and I have the privilege of serving as the Alternate Delegate for Nevada Area 42. I am going to be a broken record for a little while until most of us become familiar with our new implementation of area conference committees. Last year we introduced the idea of creating 13 area conference committees that mirror the General Service Conference Committees. Everyone is welcome to join a committee. It is not a huge time commitment and we have already seen an increase in awareness within our area about what is happening at the conference. Pat B, who serves both as our NAGSC Corrections Chair and Co-chair of the Area Conference Committee on Corrections, created an introductory document as an overview of what we are trying to do for his area conference committee. He has graciously shared this document with all the committees. We have updated all the area conference committees with the new volunteers who signed up so far this year. Funding priorities, per our guidelines, state that we first fund our elected officers, then our standing chairs, then assist our DCMs and GSRs with travel expenses. If we want to fully fund our committee chairs, as I believe we should, and assist DCMs and GSRs, we will need to increase our contributions. Our conference committees are much more organized and active then in the past. Their knowledge of specific areas of General Service is invaluable to Nagsc and to your groups. Please, go back to your groups and let them know what services Nagsc can provide, especially through our committee work. Our committees are willing and ready to come to your Districts and events with presentations on Public Information, Corrections/Bridging the Gap, Treatment Facilities, Accessibilities and Remote Communities, Cooperation with the Professional Community and La Vina/Grapevine. If members want to continue having these services available, we need to fund these services.

The other funding priority to consider is our ability to assist GSRs to these events. We encourage groups to understand their important role as participants in general service. The AA general service structure is representative. It relies on active involvement in discussions between our GSRs at our Nagsc meetings, Area Assemblies, PRAASA, and in 2020 at a GS Forum in Las Vegas.

I would like to see more discussion and workshops to help groups with ideas on how to fund their GSRs to these events. I would be happy to work on this with anyone interested in putting together ideas for just such a workshop or presentation.

Remember, spirituality can be found in our baskets and funding our trusted servants to general service events is an important group expense, not a luxury.

Treatment/Bridging the Gap (Ed S): A Panel Presentation on service work at treatment facilities in Carson City is set for June 23, 1:30 - 3:00 p.m., Carson City Alano Club. Presentations will cover Orientation to A.A., Bridging the Gap, and A.A. meetings inside for patients. Carson Tahoe Behavioral Health Services staff will present as well. An event flyer was distributed thanks to NAGSC and District 6 Secretaries and NNIG Central Office. A Coordinator is needed for Orientation to A.A. at Bristlecone Family Resources treatment facility in Reno. A flyer was circulated by NAGSC Secretary and NNIG Central Office. Also, two presenters are needed for one hour Orientation presentations on Thursdays at 7 p.m. Orientation to A.A. at Bristlecone may have to be suspended soon. If you will, please announce the open positions at Reno/Sparks meetings. Contacts for more information are NAGSC Treatment/BTG Chair (Ed S.) and NNIG Alternate Treatment Chair (Terry N.). Bridging the Gap presentations are ongoing in Carson City at Behavioral Health Services, in Fallon at New Frontier, and in Reno at Bristlecone, Cross Roads, Renown Outpatient, and West Hills. A.A.s serving as temporary contact coordinators are available to match after-treatment newcomers with temporary contacts in the mentioned communities. District 20 (Lassen County / Susanville) and District 10a (Elko/Carlin/Battle Mountain) DCMs and long timers

coordinate temporary contacts, and in smaller towns, the NAGSCs Treatment/BTG chair works with DCMs to match temporary contacts with newcomers from treatment. NNIG and NAGSC chairs maintain rosters of presenters, speakers and temporary contacts. Vitality Unlimited in Carson City is interested in having BTG presentation started soon, once A.A. meetings are set up. The opportunity to serve as a BTG speaker, presenter, and temporary contact is announced at meetings and in coordination with DCMs at as opportunities or as requests for temporary contacts arrive. Inside A.A. meetings are held at some treatment facilities in northern Nevada communities, but not in others. NNIG H&I Treatment chair has a data base of treatment facilities with and without inside meetings and it is getting updated. NNIG H&I coordinates with treatment facilities in Reno/Sparks. Outside Reno/Sparks, A.A. meetings at treatment facilities is coordinated between local A.A. members or groups and the facility staff. South Lake Tahoe area has a H&I Committee that coordinates inside meetings at jails and a hospital. Central Office fulfills literature requests from treatment facilities for patients, funded through Pink Can contributions. My experience so far suggests that A.A. members engage in local treatment facilities, hospitals, and intensive outpatient services anonymously. Meetings and workshops on Twelve Traditions are important. The NNIG H&I Committee holds a monthly meeting, which Terry N. and I participate in. We get to learn and to share our collective experience in supporting existing and cooperating in new recovery meetings, Bridging the Gap program, Orientation to AA presentations, and distribution of literature into treatment facilities throughout Northern Nevada - particularly at the moment, in Lassen County, CA and Elko; in Fallon at New Frontier, in Carson City, Reno and Sparks. We are glad to have received requests recently to set up recovery meetings and Bridging the Gap at another treatment facility in Carson City. Terry N. has taken on the duties of Alternate Treatment Chair for NNIG H&I. Carson Tahoe Behavioral Health Services in Carson City hosts weekly Orientation to AA presentations, twice monthly Bridging the Gap presentations with temporary contact requests, and daily AA recovery meetings for clients and outside AA members. To spread awareness and build mutual support for these 12th step service opportunities, a workshop is scheduled for Sunday, June 23,1:30 to 3:00 at the Carson City Alano Club. On March 23, I got to meet the BTG coordinator at New Frontier treatment facility in Fallon, Tracy B., and participate in the BTG presentation. Getting to know one another in action is fun and heartening. Getting to see how 12th step work gets done here and there is fascinating, even delightful. The reliance and confidence we have in AA's spirit of service continues to amaze me. Letting go of outcomes is a blessing. I am glad to be sober, enjoying this day, and grateful for the opportunity to serve with you all. I am grateful for the opportunity to serve A.A. and alcoholics. It is wonderful to be part of making presentations and meetings in treatment and correction facilities.

Intergroup Liaison (Pat S): My job is to serve as a conduit for information between NAGSC and NNIG (Northern Nevada Intergroup).

NNIG meets the first Tuesday night each month at the Alano Club in Sparks.

Corrections (Pat B): Our most urgent opportunity is with the Northern Nevada Transitional Housing facility in Reno. This facility has asked us to bring a meeting into their facility on Sundays from 10 - 11AM. Our goal is to establish a team of 10 or 12 volunteers who are willing to accept a once per month commitment for this facility. Attending a training seminar conducted by the Nevada Department of Corrections is a requirement for being cleared to enter all State of Nevada facilities. The next training seminar is scheduled for Thursday, August 15th from 8AM - Noon in Carson City. We currently have three A.A. members who have completed the training and we are seeking additional volunteers to complete our team and make it possible to start the weekly meeting at Northern Nevada Transitional Housing.

The State of Nevada Wells Conservation Camp is urgently awaiting our effort to assemble a few volunteers to take a meeting into this facility. We are seeking a few volunteers from the greater Elko area to fulfill this opportunity. Training from the State is required prior to being cleared to enter this facility.

In District 20, Susanville, we are seeking volunteers to take meetings into the High Desert State Prison and the California Correctional Facility at Susanville. A previously staffed meeting at High State Desert Prison has gone dark due to insufficient A.A. volunteers to fulfill a weekly commitment there.

Washoe County Detention Center, commonly known as Parr Blvd., - We have had a dozen A.A. members complete the application and training process for this facility. We are now awaiting word from the Washoe County Department of Corrections on final clearance for our volunteers to enter the facility. We have had a limited number of volunteers taking meetings into both the men's and women's sections of this facility and we are anxious to supplement their efforts is staffing meetings at this facility.

The Corrections Correspondence Service, CCS, coordinated through our General Service Office in New York is always looking for volunteers for this extremely valuable service, particularly men volunteers. The only requirement for this service is the willingness to correspond with an inmate who has requested this service and share our Recovery experience, strength, and hope by writing a letter per month on average.

Your NAGSC Corrections Committee is always looking for volunteers to serve as Pre-Release Contacts for incarcerated A.A. members who will be paroled into various cities throughout the NAGSC geography.

Pre-Release Contacts meet the inmate upon their parole, take them to an A.A. meeting, and help them start the process of becoming comfortable in A.A. outside the prison walls.
