My name is Bryce and I'm an alcoholic. I'm currently serving as your DCM Coordinator for the Southern Area.

I want to touch on a couple of things this afternoon. First, earlier today we had a meeting with some of our southern area DCM's. The purpose of the meeting was to discuss some topics that are pertinent to the area.

We talked about the importance of leadership. I gave a quick presentation of the 9th Concept and talked briefly about our 9th tradition. It all boils down to leadership and responsibility. And as DCM's we are a "committee" that has a responsibility to not only lead by example, but to serve our area as needed.

Another thing we discussed was our annual chili cook off. We began talking about the organization of it for next spring. As I am writing this report prior to the actual meeting I can only describe what we discussed in a general way.

I would like to share about a virtual meeting that I attended for the first time on the last Sunday in June. It is a virtual meeting that focuses on the traditions and Concepts. It starts at 5:00pm PST on the 2nd Friday and the last Sunday of each month. The meeting is sponsored by past and active delegates/area officers of Area 15, Southern Florida. The Zoom code is 455 496 8467, pw Outreach (case sensitive). I found this meeting to be highly informative and I would recommend it to anyone who wants to get more informed about general service. The formats are: 2nd Friday is general discussion about service and the last Sunday is a Tradition/Concept speaker mtg.

So, one of the ideas that I have is to have a monthly speaker meeting at the new Central Office location sponsored by the Southern Area DCM's. We could have 2 speakers; one 10 minute the other 30 minutes or so and then have a question and answer session. Use the GSR's and the other area officers to fill those slots. The topic would always be something related to service so we could get ideas on how to better discharge our duties. How can we best make our service structure more effective and efficient? How do our Traditions and our Concepts affect the way we do things in AA? Where do we start? Maybe the second Saturday of the month or any Saturday or Sunday that would not conflict with the regularly scheduled meetings that we already have would work.

AREA OFFICER REPORTS:

DELEGATE: RHONDA

I have been approached about whether we can start meeting or not and I wanted to share some of the things that the GSO and other Delegates are sharing. I have links and can help you find the information for your group to make the right decision, but each meeting is allowed to make their own decision. <u>AA.org</u> has info there too. We do not have rules in AA, but we just want to do what is right for our community. Mis you guys so much. Hope we can be together in November.

ALTERNATE DELEGATE: JULIE

My name is Julie and I am an alcoholic and currently serving as our Panel 69 Alternate Delegate. Welcome to all of you who are new to general service. I want to thank Jake for asking me to talk today about general service. It is my intention to draw a thru line from the group to the general service conference.

So, what is general service, you may ask. One definition from the pamphlet, Circles of Love is:

"A.A. is made up of interconnected circles of people within the Fellowship, who work together to carry A.A.'s message of hope. But in order for A.A. to run itself without bosses or rules, in accordance with our Twelve Traditions, we need a system of communication for finding out how A.A. as a whole feels about its world affairs, and how it wants to operate.

For A.A. to run its own affairs, each A.A. group needs to make its voice heard on overall A.A. policies. This starts with a group's general service representative (G.S.R.), who represents the voice of the group conscience and has the job of linking his or her group with A.A. as a whole."

As Bill W wrote in Concept I:

"The A.A. groups today hold ultimate responsibility and final authority for our world services - those special elements of over-all service activity which make it possible for our Society to function as a whole. The groups assumed that responsibility at the St. Louis International Convention of 1955. There, on behalf of Dr. Bob, the trustees, and A.A.'s old time leaders, I made the transfer of world service responsibility to our entire Fellowship."

But what does that mean for your group? Each group has both the responsibility and the authority for our world services. What does it mean to have a G.S.R.? When I was a new G.S.R. I heard a lot of opinions about what my new position entailed. Because of all the different opinions, I have learned to go to the literature, especially, when in doubt. As explained in the G.S.R. pamphlet: You transmit ideas and opinions, as well as facts; through you, the group conscience becomes a part of "the collective conscience of our whole Fellowship," as expressed in the general service conference. You may ask, do I really know what an informed group conscience is?

From the Group pamphlet: What Is an Informed A.A. Group Conscience?

"The group conscience is the collective conscience of the group membership and thus represents substantial unanimity on an issue before definitive action is taken. This is achieved by the group members through the sharing of full information, individual points of view, and the practice of A.A. principles. To be fully informed requires a willingness to listen to minority opinions with an open mind.

On sensitive issues, the group works slowly — discouraging formal motions until a clear sense of its collective view emerges. Placing principles before personalities, the membership is wary of dominant opinions. Its voice is heard when a well-informed group arrives at a decision. The result rests on more than a "yes" or "no" count — precisely because it is the spiritual expression of the group conscience. The term "informed group conscience" implies that pertinent information has been studied and all views have been heard before the group votes."

Hopefully you have seen the general service structure upside-down triangle. Your groups are at the top because the groups are the ultimate authority and decision makers in Alcoholics Anonymous. The district is the next level of communication where the group's voice is carried by each group's G.S.R. at the district meeting. The area (including the southern and northern committees) is the next level of communication where the G.S.R. also carries the voice of the group to the area assembly meetings. The general service conference is the annual meeting where the area delegate carries the voice of all the groups within an area. The general service conference is made up of the 93 area delegates, 21 trustees and general service office staff. These approximately 135 people represent the collective group conscience of Alcoholics Anonymous.

Your district may have standing committees, such has Public Information or Corrections. Standing committees are where much of the work is done to reach out the hand of A.A. Area 42 has standing committees where we coordinate with districts and groups to provide the services for each committee to the local community.

Additionally, the members of each standing committee should be familiar with the current issues that will be discussed at the general service conference, especially as they relate to their specific committee.

Here's an example of how general service can help reach the still suffering alcoholic. Last year our Delegate, Rhonda, received the complete list of agenda topics and asked each area conference committee to recommend topics for our area to hear about. Our Treatment and Accessibilities Area Conference Committee reviewed all items pertaining to their committee and their number one choice to be presented was Item B: *Consider adding a story from an A.A. member who is deaf to the pamphlet "Access to A.A.: Members Share on Overcoming Barriers."* It was decided to be presented at the Southern roundtables in February. The G.S.R.s that were at the roundtables hopefully brought the information back to their groups.

So, what happens when a group discusses an agenda topic? It could be that the G.S.R. presents to the group what they heard at the presentation – the presentation plus feedback heard at the roundtables. Maybe the G.S.R. provides a copy of the written summary provided by the area conference committees, and perhaps a current version of the pamphlet. Then the members of the group have a thoughtful discussion. The one thing I am sure happened for all groups in Southern Nevada that discussed this agenda topic, is that they became more informed about the need to make A.A. accessible to the hard-of-hearing. Perhaps there were a few members who struggle with their hearing in the group, the group may have decided to bring in an ASL interpreter or at least be familiar with the closest ASL meeting. Or some members may become more aware and now speak louder and clearer for the person who is hard-of-hearing.

So, what happened with this agenda topic. First, the members of SAGSC supported adding a new story, then it was supported at the area assembly and passed at the general service conference. Now, there is a new version of the pamphlet containing Ashley's story. In Ashley's story, she talked about how her hearing, non-signing sponsor wouldn't let her give up and through informed group consciences, there are now ASL meetings daily in her community. The deaf community has grown in A.A because of the additional ASL meetings,. Her story goes on to talk about how important it is for the deaf to fully participate in A.A., including general service.

So how does your group contribute to the health and wellbeing of A.A.? As a G.S.R., are you bringing the agenda topics back for your group's voice? Do you have a well-informed group conscience? Have you followed through with what happened at the general service conference? If not, we are here to help.

I would like to close with a reading from the <u>A.A. Service Manual</u>, page S20 (By Bernard B. Smith, non-alcoholic, Chairman of the General Service Board and Conference 1951-1956).: Why do we need a Conference?

"We may not need a general service conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.

We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its service.

We need it to ensure that changes within A.A. come only as a response to the needs and wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

Hello all, I am Laura and I am an alcoholic. As CPC Chair I will be giving the report of the CPC/PI Committees. We, like everyone have been significantly impacted by the Covid-19 pandemic. All public events continue to be cancelled or have become virtual. As you may be aware, prior to Covid-19 we typically participate in 5-10 events per month. In addition our interaction with the professional community events have also been postponed or have become virtual events. We have continued to participate with our many community partners providers via Zoom meetings, and are ready and able to be upfront safely if/when public events begin.

We have joined a North America AA CPC group, which meets quarterly via Zoom. With that participation we have learned all CPC/PI committees are fully supported financially by their Areas for all committee functions and needs. We recently participated in a meeting and have learned new ideas for out-reach to professional communities and tools for tracking contacts. NEW BUSINESS:

HISTORY

In past the funding for committee **general service** work was shared by SAGSC and Intergroup. The funds have been for some time managed by Intergroup. And at one time there was a surplus that secondary to a large contribution made to SAGSC, some of which was distributed to committees and central, office. However about 3-4 years ago funds began to run short for the committees to purchase literature for public information events, and CPC events, so the committee adopted the H&I group contribution process and began collecting contributions via a Green Can. The committees essentially became self-funded. And for a while managed fine. In the last year 2019 the average contributions funds from groups and meeting averaged about \$165/mo (based on Intergroup financials) These contributions afforded the committees to do it work – which is the definition of **General Service.** It provided funds to purchase literature, printed meeting schedules, and supplies necessary for tables at Public, and Professional events. As many of you are aware the committees participated in 6-12 events per month. In the last few years we have highlighted the focus on the homeless and veterans. In addition, CPC events provided us with an opportunity to educate medical professionals, clergy, educators, human resource counselors, and/or behavioral health counselors on what AA is and how to help those in need. We self-funded our committee chairs travel to Area 42 assemblies and PRAASA events. Intergroup (Central office) managed the contributed funds, collecting the contributions from groups and meetings.

As you all must be aware- mid March 2020, the world as we know it changed. In April our remaining committee funds(approx. \$2300) was transferred to SAGSC. The committees **General Service** work also changed dramatically. The public and professional events were cancelled, and we had to find a new way get the word out. As you heard in our report we continue to be involved in reaching those in need. We are working on press releases, PSAs and outreach to venues. We are also reaching out to the professional communities with presentation offerings via zoom. However our ability to remain self- funded has also been significantly impacted. In our research with the North America AA CPC group and GSO, it was revealed that all CPC/PI business in other areas is fully supported by the Area and districts. No one we spoke with is self- funding their work through contributions collected at meetings. They are fully integrated into the structure of the area. Our question is " *Is it possible to return to that model in our area?*"

VI FUNDING

F. All SAGSC officers, and standing Committee Chairs shall submit an annual budget, or estimate of their committee expenses.

The intent of the guidelines implies that all standing committees **general service** work will be supported financially by SAGSC. Now, obviously if funds are not available for distribution then all committee budgets need to be adjusted. Last year we did submit a budget to the finance committee for travel expense only, and there was great confusion as to whether we were eligible for those expenses to be reimbursed by SAGSC ,as we were seen as technically a self- funded committee and not a standing committee. However funding was approved if we did not have funds available.

It is our committee's request to find out how the body of the SAGSC feels about fully supporting the **general service work** of our vital committees going forward. Briefly our expenses on a monthly basis in 2019 was approximately \$145/mo for literature and supplies. In addition our averaged out travel for committee chairs to Area 42 assemblies and PRAASA about \$140/mo totaling an annual expense of approximately \$3420. However we project our literature expense will be significantly less this year and likely future years, as we have been forced to embrace the digital/virtual age. We are not asking for a commitment for any funds today, but we would like to poll the body of SAGSC on funding the full committee's **general service work** in the future. Thank you for your consideration. Questions?
