- Will have members representing both the North and the South, which will allow us to meet and serve with members from both ends of the state.
- Will recommend to the delegate one or more topics from their committee to be presented (however, a committee may decide not to recommend any topics).
- Will provide the presenter(s) for the topic(s) chosen by the delegate to be presented at either the roundtables or the assembly.
- Q. Who can be on one of the Area Conference Committees?
- A. Participation is completely voluntary. Any member can volunteer.
- Q. Are the Area Conference Committees the same committees that go out and perform service throughout the fellowship?
- A. No, service committees are generally organized within the NAGSC and SAGSC service structures and are separate from the Area Conference Committees.

 Example: Participation on the Area Conference Committee on Public Information does not mean a member does PI service. If public information service is attractive, a member joins the NAGSC or SAGSC PI Committee.
- Q. Can a member be on both an Area Conference Committee and a NAGSC or SAGSC service committee?
- A. Absolutely, but not required. However, it would be extremely beneficial.
- Q. What will my participation include?
- A. Participation will include a few conference calls and communication through email throughout the year. We will also get to see each other at our Area Assemblies in Tonopah, as well as at our NAGSC or SAGSC meetings. There will be other opportunities for those interested in doing more.

I want to especially thank all who served as Area Conference Committee Chairs. You are our pioneers. You took a risk. We appreciate the time and effort you all put into learning a new process and leading those on your committees. Your feedback is invaluable and hopefully we will be able to incorporate your suggestions for next our panel. Thank you to all our past trusted servants who mentored the Area Conference Committees. We benefited from your wisdom and experience. And finally, a big shout out to all those who interpreted at our meetings and translated all the documents. This was the first panel where all the documents (or nearly all) were available to our Spanish speaking members. PI (PUBLIC INFORMATION):

Hi, I'm John and I'm an alcoholic. By the looks of things, I'm your new SAGSC PI committee chairperson. I'm looking forward to this opportunity to serve Alcoholics Anonymous in Las Vegas.

The job of the Public Information Committee is to give the public at large, Alcoholic and non-Alcoholic, a view of what Alcoholics Anonymous is. Contrary to what many people in Alcoholics Anonymous would like to believe, AA is not a secret society. Individually we are anonymous at the level of press, radio, and film, but as an organization we are very open about our program and how it works.

Has anyone on here heard of the term "Substance Abuse?" 20 years ago there was no such thing as substance abuse, we only had "people who have problems with drugs and alcohol." Alcoholics Anonymous did not create these terms; the 3rd parties we surrendered our 12th step work to created them. These 3rd parties (and by 3rd parties I mean treatment centers and non-profits centered around substance abuse) have created Professionals who specialize in Addiction. And these non-profits and Addiction Specialists are no longer using the term "people who have problems with drugs and alcohol," they're using the term "Substance Abuse."

Lets use our imagination for a second and think of a lady alone in her house. Shes in her 40s. She still has a job and a car, but she has burned every bridge, her finances are in shambles, her family wants nothing to do with her anymore, and she drinks a box of wine or more a day. Does she think she has a "Substance Abuse" problem? She's heard the term before- in the 2000s during news stories about Methamphetamines and in the 2010s thanks to the heroin epidemic. To her, Substance Abusers are drug addicts and she doesn't have a drug problem; she might maybe think she has an alcohol problem, though, but she's definitely not a junkie.

95% of the drunks in this room today got to AA by going trough someone or someplace first. The old ways of the 12th step call are now just stories most of us hear from oldtimers.

Since we have given all of our 12-step work to the third parties, they have been the ones that are doing the outreach for us, even though we don't think of it that way. Lots of us are more than happy to go speak at treatment centers and sober living houses and do other H&I work, and that is a version of the 12th step.

There's another version of the 12th step - the original one - and that is 'Carry The Message <u>To</u> The Alcoholic Who Still Suffers.' Now that the term 'Problems with Drugs and Alcohol' has been replaced with 'Substance Abuse,' our people, the Drunks, aren't hearing their name anymore.

Now, you might be thinking to yourself "how do we get these treatment centers and nonprofits to also focus on alcoholics?" That is something we are going to work on. Or, we can do some good old-fashioned twelve-step work and get the word out that there is a program for the alcoholic and it's here in Las Vegas and its free and we are here to help you now.

A movement is starting in AA all across the United States where similar PI committees are recognizing this same breakdown in public communication. There was a time when all media outlets, doctors, nurses, judges, and the common person knew exactly what AA was. That has been disintegrating for years. We have a couple decades worth of lagging public awareness that we need to make up for and its becoming increasingly important to get started on it now.

The SAGSC PI committee is jumping on this new wave of enthusiastic public outreach that was once so pervasive in Alcoholics Anonymous. With the advent of AA on Zoom, we have been able to workshop and discuss with other PI committees different methods on effectively educating Public on what AA is and who it's for.

The biggest issue we will need to tackle is out digital footprint, which we will talk about at our next SAGSC meeting (maybe). As for now, we are going to use some old fashioned Analogue to begin the outreach process.

A small, yet effective, information drive we can begin immediately is to place single pamphlet holders with informational posters at Urgent Care facilities. These pamphlet holders will provide an easy to read message on what AA is and provide a pamphlet for a potential Alcoholic to take with them if they choose to. We are not doing away with the large literature racks that most of us are used to, but for now we are going with a low cost – maximum impact strategy to start us off.

[Show the holder, go over description] On the poster it will state plainly: *Alcoholics Anonymous is a <u>Free</u>* program that has helped millions recover from alcoholism (informing the patients, nurses, doctors, and staff what AA is). *If it feels like you have crossed a threshold and are no longer able to control your drinking, the members of alcoholics anonymous are available to help (informing the patients, nurses, doctors, and staff who AA is for). The pamphlet provided will be: "Is AA for you? 12 questions only you can answer" that people can take with them.*

Obviously, this is just a small step forward. That is why I'm giving a Area Wide call for help. We are going to need upwards of 10 on-foot volunteers as well as a volunteer coordinator to help with literature distribution. 3 or 4 people willing to be a "media liaison team" to work on PSAs, be available for local news stories, do radio and podcast interviews about AA (and work to get us radio and podcast interviews). 3 or 4 people willing to be a Public Presentation team to speak at non-AA functions about what AA is. And even a digital media team that can handle Adobe Illustrator, InDesign, After Effects; as well as web design and audio recording.

These volunteers are going to need to come from your home groups. If you can please get the word out to your groups that would be huge. If any of you need me to come speak to your home group whether in-person or Zoom (I can do it during the 'AA related announcements part of the meeting), don't hesitate to ask. I'll be there.
