AREA OFFICER REPORTS:

DELEGATE: JAKE

My name is Jake - I'm alcoholic. I am very honored and privileged to have been elected to serve as the delegate for Area 42 panel, 73. If you are new to General Service, you may be asking yourself what does a delegate do? Alcoholics Anonymous is different than most every other organization in the world. Our service structure is based upon an upside down triangle where the groups of AA are at the very top. In Alcoholics Anonymous, we want every decision to be made by all of the groups of AA. Once a year, there is a big, weeklong meeting that we call the General Service conference. That is where the decisions of Alcoholics Anonymous are made. Obviously, we cannot have a meeting with every single member of Alcoholics Anonymous attending. So the 93 areas of Alcoholics Anonymous in the United States and Canada all elect one delegate to represent their area at the general service conference. The delegate's responsibility is to carry the group conscience of their area to the General Service conference in New York. That is my job and I take my job very seriously. We will be receiving the topics and the background information for all of the items that will be discussed at the General Service conference on February 15. When we receive the background information, we will use our area conference committees to summarize and discuss every item on the agenda. The area conference committees will then recommend what items they think are the most important to our area. These items will be discussed at our area round tables, as well as our area assembly in Tonopah, Nevada. If you are new here today, you are going to hear 5000 new acronyms, and are going to be overwhelmed with a lot more information than you could ever learn in one day... and that is okay. No one expects you to understand everything that is going on here. Just like everything else in Alcoholics Anonymous we take General Service one day at a time. Also, another important thing to understand is that nothing happens quickly inside AA. I could stand up here and talk for the next 3 hours about general service in Alcoholics Anonymous. Luckily for you I'm not going to do that. What I do want to say is that COVID-19 was a huge punch in the face for Alcoholics Anonymous as a whole. This meeting that we are having today would've been illegal to have two years ago. Now that we are back to being able to have meetings and our committees able to actually do their service work I am very excited to get back to doing all of the amazing work that is done in a general service committee. In this meeting today you are going to hear from our standing committee chairs, and they are going to tell us all about all of the wonderful things they have done, and all the things they have planned in order to carry the message to suffering alcoholics this year. This is why I fell in love with General Service and Alcoholics Anonymous. Every delegate is assigned to one of 13 conference committees of the General Service conference. I have been assigned to the public information committee. That means I will be discussing every item on the agenda in the public information committee with our public information committee before the general service conference happens. In our area, we have area conference committees that will be doing the same thing. So, I hope you will volunteer to participate on one of the Area Conference committees. The general service committee is always very busy at the start of the year with receiving, summarizing, and discussing the agenda items that will be discussed at the General Service conference in New York. I am very glad you are all here today. The last thing I will share is something I heard at the pacific region forum in Salt Lake City last year. When we are discussing these General Service conference agenda items, say what you mean, but do not say it mean. In Alcoholics Anonymous

we are not always going to agree on how we should handle certain topics. That is why it's very important for us to discuss these agenda items while keeping an open mind. Listening to what everybody has to say, especially the people we do not agree with. Then, when we take the vote we let the group conscience decide what we will do. And we trust that the group conscience is always right. During this process, nothing that we ever get done will ever be as important as how we treat each other while we do it. Alcoholics Anonymous has saved my life and general service has become a huge part of my program of recovery. Thank you all very much for saving my life and giving me a life worth living. We will publicize the roundtable through Homeless Alliance, PACT Coalition and other alcoholism-focused organizations in Clark County. Within AA, we will utilize Silver Streak for mass communication and the distribution of a flyer early next month. A light lunch and beverages will be served. We intend not to charge a fee to attend, so we will ask for funding to cover the cost of the lunch and beverages. We will submit a budget estimate with the request for funds, shortly. Given that it is a weekday event, we anticipate reasonably good participation by Professionals and hope that members of AA can find the time as well. It will be an in-person event only and will not be conducted hybrid. CPC also intends to support and participate in an informational event later this year hosted by all three committees (PI, CPC, Accessibility). The intent is to introduce each committee's mission, goals and service opportunities to members of the fellowship of Alcoholics Anonymous. The workings and accomplishments of our three committees continue to be understated and warrant a stronger voice within the fellowship. More information will be forthcoming. Committee members continue to participate in CPC North America that meets quarterly. These meetings offer ideas on what other parts of the country are doing to bring the AA message to other parts of the country. Lastly, we continue to welcome more volunteers. GUIDELINE CHANGE - PROPOSAL FOR LA VIÑA COMMITTEES – SECOND READING – JASON

(Wording change sent under separate cover)

The La Viña Ad Hoc Committee proposes the creation of two (2) La Viña committees complete with Chair positions, one in the North and one in the South. The purpose of this proposal is to bring La Viña into parity with NAGSC and SAGSC Grapevine committees. The La Viña committee chairs' duties would be the same as the Grapevine chairs and will be to represent La Viña at Area, SAGSC and NAGSC events. The La Viña Chairs should be fully funded, voting members of the area committee. The newly formed NAGSC and SAGSC La Viña committees should be included in the Area budget process. As our Area grows and matures it is time to recognize the value, passion and efforts of those who have been carrying the La Viña message and give them parity with the Grapevine committees efforts. The area Ad Hoc committee is tasked with recommending ways to create parity. To achieve this, we are proposing to both NAGSC and SAGSC to create La Viña committees complete with Chair positions and that the Area 42, NAGSC and SAGSC guidelines recognize the chair positions. Finally that the new La Viña Committees and Chairs are financially supported by appropriate budgets.

History: For several years dedicated individuals have been carrying the La Viña message to Area 42 with no support from the Area. They have put together story writing workshops. NEW BUSINESS:

GUIDELINE CHANGE - PROPOSAL FOR SAGSC TECH CHAIR - FIRST READING - ANDREW

Objective: To create the SAGSC Technology Chair position.

Background: During the shutdown from the pandemic starting in 2020, Area 42 replaced in-person meetings with virtual meetings. As Nevada began opening up, the assemblies, SAGSC, and NAGSC meetings changed to a hybrid format (in-person and virtual, combined). At the September 2022 Area Assembly, a Technology committee was formed to assist the trusted servants of Area 42 with any questions or situations that might arise concerning technological equipment owned by and services subscribed to by Area 42. The technological equipment will include, but is not to be limited to, translation equipment, computing devices and accessories, including audio and visual accessories (where possible) necessary to provide virtual access to Area assemblies and meetings. Additionally, the Area Technology Committee will address technological issues that might arise or be brought forward in the future by members of Area 42.

Per the Area 42 Guidelines, the Technology Committee consists of the: Area Technology Chair, Alternate Technology Chair, NAGSC Technology Chair (appointed by NAGSC Chair), and SAGSC Technology Chair (appointed by SAGSC Chair).

Proposed Changes to the SAGSC Guidelines: Additions vs Deletions. The only text being changed is listed below. The remaining Guidelines stay intact.

IV VOTING MEMBERS AND PROCEDURES

B. If residing in or elected from the South, the following, or their alternates, shall be full voting members of SAGSC:

- 3. Newsletter Editor, and Web Servant, and Technology Chair.
- 4. Southern Area Officers:
 - a. Chairperson:

v. Appoints the:

- (3) Technology Chair;
- (4) Ad Hoc Committees as needed, and
- (5) When a SAGSC Standing Committee is unable to fill a Chair position, appoints the appropriate Chair.

5. Appointed Positions:

c. Technology Chair:

- i. Provide technical support in planning and facilitating SAGSC meetings, including use of virtual communication platforms and technical assistance with venue equipment.
- ii. Assist SAGSC officers with technical support on SAGSC or Area-provided computer devices and translation equipment.
- iii. Be responsible for storing and overseeing the transportation of equipment to events.
