On the 11<sup>th</sup> of June we had a booth set up at Founders day located at the Salvation Army here in Las Vegas, NY. There we were able to sign on 3 Special Needs volunteers. We are still visiting a member that is awaiting a liver transplant. Special Needs visits this member once (1) a week and has been for the past 6 months. I had planned on attending the Forum this August but my plans have changed and I'm not going now, if anyone is attending I would love to hear what goes on at this event. ### **Committee Reports:**

**H&I** – Alan – H & I business meeting is held 3rd Tuesday of every month at Central Office at 6:00PM. New members are invited to arrive at 5:30 for a brief orientation meeting. We currently serve over 50 panel meetings on a weekly or biweekly basis. We conduct meetings in facilities where the residents are unable to attend regular AA meetings on the outside. We also supply these people with AA books and literature on a regular basis. As with any service committee, we can always use more volunteers. To be eligible to take meetings into any correctional facility, there is a clearance process and facility orientation that are required, plus a sobriety minimum. For the treatment facilities, there is generally a very minimal sobriety requirement. Here is our 6 month re-cap of donations and expenditures, Total Donations were \$14,711.34, Expenditures were at \$11,477.39, indicating that we used some funds that were already in the bank. If you'd like a more detailed look there are a few detailed spread-sheets here on the front table for you to look at showing how the money was used and there is also a re-cap spread sheet showing exactly what literature was disbursed to each facility over the last 6 months.

Bridging the Gap — Alan — First off I would like to introduce my CO-Chair, Darryl B. We are progressing well with revising our volunteer list and adding new volunteers. I have sign-up forms available here for anyone who wishes to take them. They do include contact information for B-T-G and myself, both e-mail & phone. The overall activity level of requests has shown a slight increase over the last few months, and as H&I volunteers pass this information along we expect it to continue to grow. Still dealing with information from requesters not being accurate enough to m,ake contact after they're released. Encouraging the H&I volunteers to assist with this by quickly proof-reading the request cards when they get them. We currently have several volunteers corresponding with inmates 4+ months in advance of their release in an effort to insure they get connected with AA upon their release. I have a meeting with Tyler D. who is the new Programs Coordinator for CCDC on this coming Wednesday to discuss and review who does what and how regarding AA panels at the County jail. I will have a report on this later at the August H&I and Intergroup meetings. I will be attending the National Bridging-the-Gap Workshop/Conference in Sacramento, CA. In September, and will also be attending the Forum in Woodland Hills, CA in August. H&I will be providing some funding for the B-T-G event only, not the Forum. If anyone would like further info you may contact myself or my co-chair Darryl after this meeting, or at any other time.
