FINANCE REPORT: EDIE

The Finance Committee met on May 14th to discuss how to best use the monies that were not used for PRAASA 2018, but had been allocated and transferred from the savings to the checking account.\

The amount of \$7,500.00 (as approved by the body) was transferred, however only \$4,200.00 was reimbursed to participating unfunded officers, DCMs and GSRs, leaving a balance of \$3,300.00. As a committee, we decided to bring this to the body for suggestions or proposals on how this money should be best spent.

We ask that you think about this and send your proposals to the Finance Committee so that we can present same at the July SAGSC meeting and vote on which proposal or proposals we would like to see adopted. Please send your proposals to me not later than June 20th so that the committee can discuss prior to presenting a summary report to the body at the July 8th meeting. We will take a vote at that time.

Following is a second and final reading of the Guidelines amendment proposal. After the reading, I will ask for a vote on this amendment and whether the body chooses to accept it or not.

PIC (PUBLIC INFORMATION COMMITTEE): HOLLY

Hello, SAGSC!

Life is good at the Cooperation with the Professional Community and Public Information committees. We are working hard to provide literature and hope for a better life in Alcoholics Anonymous.

Since the last SAGSC, we participated in the Project Homeless Connect, the weekly Pop Up Project Homeless Connects, Family Connects, multiple health fairs, and the Giving Project. We regularly attend monthly meetings of the PACT Coalition, the Mayor's Faith Initiative, the Giving Project, and the Nevada Homeless Alliance. We give information about what AA is and what it isn't. Many professionals have misconceptions about AA mandating religion, forbidding prescribed medications, being a cult, etc.

Some special events we attended included a Recovery Resource Information Fair, TINHIH Black Monday, a 3 day Counseling Advances Conference, and a 3 day National Conference on Adolescents and Young Adults. We have been working with UNLV to provide literature and aid in starting an AA meeting on campus. Caroline gave UNLV Counseling Center a literature rack. Holly delivered AA pamphlets to UMC Human Resources/Employee Assistance. They were grateful for literature, as they had just been directing those employees in need to our website. Samuel, a Spanish speaking member of the committee, was live on a radio broadcast on channel AM1420. Holly is working with Beasley Media and facilitating an AA PSA announcement. Caroline and I also attended PRAASA and the Area 42 Assembly, which were both fantastic! We learned a lot!

We continue to concentrate our efforts on the homeless and veteran populations. We did this through attendance at special events and at monthly provider meetings for professionals working in these fields – that's CPC, and through outreach in the general public and our fellowship – that's PI, to educate the general AA public about what we do. We work closely with the Accessibilities Committee, District 21, and Al-Anon.

We attend AA events, such as the Gratitude Ball, Founders' Day, and the Las Vegas Roundup. We love to party and are available for any AA event - District Workshops, picnics, etc. We contribute to the Area 42 Newsletter and our local Intergroup Silver Streak.

Our committee remains strong and dedicated. We held an inter-committee workshop the first week of April to see where we can best be of service to suffering alcoholics. We are currently in the beginning stages of organizing official presentations to deliver to professional groups in the community. We are always looking for new members. DCM's: please ask someone from your District to become the liaison with CPC and PI. We meet on the second Monday of the month at 4:30 at Central Office – just before Intergroup. We serve snacks – really good ones. Please come join us!

INTERGROUP LIAISON: KELLIE

Michael H. gave the Treasurers report to Intergroup on May 14, 2018. The income and expenses for the month ending April 2018 are as follows:

Total Income \$9,860.09; Total Expenses \$9,821.74; Literature income \$3,337.15: Literature Expenses \$2,200.37; Intergroup Bank Balances: Total Central Office Accounts \$23,120.06; Payroll Account \$200.76; Prudent Reserve Account \$10,003.63; Literature Account \$10,199.11; Total Bank Accounts \$43,523.56.

Central Office took 719 information calls, the Hotline received 1,682 information calls. Central Office received 111 twelve-step calls, while the Hotline received 240. The Web Site experienced an average of 273 hits per day, for a monthly total of 8,179 visits.

The first Men's Night Out was a big success, ninety three men registered and a contribution of \$1,300 will be given to Central Office. Founder's Day will be held June 9, 2018, starting at 7:00am at Christ Episcopal Church, 2000 S. Maryland Parkway. Start time is 7:00am. Tickets are \$5.00.

Following is a second and final reading of the Guidelines amendment proposal. After the reading, I will ask for a vote on this amendment and whether the body chooses to accept it or not.

Proposal to Amend the SAGSC Area 42 Guidelines as follows:

The Finance Committee proposes to amend **Section VI Funding** by adding item **G**

G. A Prudent Reserve is established to ensure that, after all obligations are paid, enough funds are held to conduct Southern Area business. We shall strive to maintain a savings account reserve equal to at least 1/3 of the previous year's expenses, to ensure that SAGSC will be able to meet its financial obligations. A 2/3 majority vote of SAGSC officers is necessary to draw upon our prudent reserve.

We request this amendment be effective May 20, 2018, if adopted by the body at the May 2018 meeting.

Note: Edie asked for a vote to accept the proposal as written and carried the vote with no opposition. (passed)
